### **INTRODUCTION TO SANPARKS**

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

The Parks under the management of SANParks are divided into 6 regions:

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

## **BACKGROUND AND PROBLEM STATEMENT**

A coordinated effort to develop strong leaders within the SANParks is critical for its long-term sustainability. Therefore, the SANParks currently has a need for a panel of Executive Coaching service providers with accredited executive coaches who are capable of coaching the SANParks executives, General Managers and senior managers. The service providers will be required to understand the organisational context at both micro and macro levels and ensure that matching of coaches with the executives is properly done.

It is against the above background that SANParks seeks to appoint a panel of capable service providers who will be able to assist in providing executive coaching services for a period of three (3) years on an “as and when required” basis. The successful service providers will need to understand the current and emerging leadership skills requirements of the organisation and offer agile and cost-effective executive coaching that is adaptable to the dynamic business environment in which the SANParks operates.

## **BUSINESS UNIT RESPONSIBLE FOR THE BID**

The Human Capital Management Department will be responsible for the project as project manager and project sponsor.

## **CONTEXT OF THIS PROCUREMENT**

Proposals are hereby invited for the provision of Executive Coaching Services to SANParks for a period of 3 years.

SANParks is looking to make use of the services of a panel of experienced Executive Coaching companies or service providers. The SANParks will not appoint a single company but will work with different service providers who once they have demonstrated the ability to fulfil the functionality criteria and are the most competitive in terms of price and B-BBEE will become preferred suppliers and will be approached as and when required.

Coaches / companies are required to prepare a proposal for a coaching programme for SANParks Executives, General Managers and Senior Managers that would describe the objectives, content and measurable outcomes of the programme contextualizing this with State Owned Enterprises and worldwide best practice in terms of executive-level coaching, learning and development.

## **CONTRACT PERIOD**

The contract for this service is three (03) years.

## **SPECIFICATIONS/SCOPE OF WORK**

SANParks intends to establish a panel of coaches /companies who are pre-qualified and will be rotated upon as and when required by the organization to provide coaching services to SANParks executives and senior management.

In order to be considered for pre-qualification SANParks requires potential coaches /companies to examine the scope and extent of management functions and responsibilities within the organization in relation to departmental mission, strategic goals as well as management competencies.

SANParks intentions with the coaching programme are to ensure that its executives and senior managers are provided with effective coaching services so that individuals:

- Achieve significant personal growth and development.
- Have Increased awareness of their strength and weaknesses and are able to determine their personal attributes.
- Are motivated to perform optimally to the best of their ability.
- Are better equipped to manage change and drive organisational transformation.
- Are provided with practical techniques to deal with pressure and work stress and how to achieve a balance between personal life and professional life.
- Are guided around techniques for mastering the art of listening, blending humility with confidence, building rapport and interpersonal relationships, and other areas that impact on individual and group performance.
- Are assisted with the channel to address their unique development needs and also attaining general insight into learning and growing, decision making, conflict resolution and problem solving.

### **Scope**

The project scope is limited to any of the SANParks' areas of jurisdiction.

## **Key Activities**
