3 X AIR CONDITIONERS:

Description

- ii. One outdoor unit with four indoor unit combination

MICE ROOMS:

Description

1. WINDOWS:

1.1 Close off completely – welding work needed

1.2 Dim – dark film to be put on all windows

2. HEATING, VENTILATING, AND AIR CONDITIONING (HVAC System)

Air conditioners in each of the smaller rooms (see above specifications)

3. LIGHTING

New lighting system with a timer must be installed.

4. WALLS

Paint needed.

5. FLOORS

Must be refurbished.

6. WASHING BASIN

Get a bigger one , 4mX2mX2m

7. CAGES (solid floors)

Individually Ventilated Cages (IVC) are highly recommended. Stands and accessories required

7.1 Rabbits (Breeding):

Minimum floor space – 6400cm²

Minimum cage height – 60 cm

7.2 Guinea pigs (Breeding)

Minimum floor space – 2500cm²

Minimum cage height – 23 cm

7.3 Mice (Breeding)

Minimum floor space – 300cm²

Minimum cage height – 12 cm

8. Wash basin-steel, 4X2X2m

2. **Essential administrative requirements:**

3. The above specified goods/services should be delivered / rendered to the ARCOnderstepoort Veterinary Institute at above-mentioned delivery address.
4. The particulars of the guarantee that will apply to the goods quoted for, with the particular regards to the period and extent of the warranty must be clearly stated. Where services are required, service providers must submit documentation pertaining the relevant experience.
5. Your written quotation must be deposited or emailed depending on the instructions given in the email.
6. All price quotations that have a rand value of R 30,000.00 to below R 50,000,000.00, including VAT, will be evaluated by applying the 80/20 principle as prescribed by the Preferential Procurement Policy Framework Act 5 of 2000 and its Regulations. The lowest acceptable price will score 80 points, the 20 BBBEE points will be allocated as follows:
