## **1. INTRODUCTION**

The Atlantis Special Economic Zone (ASEZ) was designated as such by the Minister of Trade and Industry on the 19 October 2018 and the license to operate the zone was granted to the Western Cape Government (MEC for Finance and Economic Development). In response to this, and in accordance with the license conditions, the Atlantis Special Economic Zone Company (ASEZ Co) was set-up by the Western Cape Government in partnership with the City of Cape Town. This establishment followed due process and the company was registered in March 2020.

The ASEZ is a geographical area of 118 hectares in the industrial area of Atlantis. It is a Greentech SEZ with the objective of attracting Greentech manufacturers. The ASEZ currently consists of a number of investors on privately owned land (about 25ha) as well as three separate portions of vacant and industrial zoned land owned by the City of Cape Town (+93ha). This land is in the process of being acquired from the City of Cape Town.

The Atlantis SEZ has been identified as a strong manufacturing node in Atlantis and the Western Cape, with Greentech a key emerging sector for the Western Cape and for South Africa.

The Atlantis community and industrial area was established by the Apartheid government as a group areas Coloured township and people forcibly removed from suburbs in Cape Town were relocated here (amongst other areas). The government also created attractive incentives for industrial manufacturing in Atlantis. When these incentives and subsidies were removed, it led to a slump in manufacturing in the nineties. Since then, the City of Cape Town, working with National and provincial government, has been actively exploring ways to stimulate new industrial investment in Atlantis. Prior to Atlantis being designated a Special Economic Zone, the city had designated the area as a green manufacturing hub. The ASEZ aims to contribute to green industrial development in Atlantis and the area will no doubt become a key platform for Greentech industrial development in the Western Cape.

## 2. SPECIFICATION

### 2.1. BACKGROUND AND CONTEXT

The ASEZ currently has 2 offices; Century City and Atlantis. Atlantis is based approximately 41kms from Century City. The company has grown and the need has arisen for the ASEZCo to purchase a double cab bakkie for Infrastructure to move around on site. The construction has started at the ASEZCo and will continue as more and more investors land and require top structures. A double cab bakkie is the most practical vehicle to use while working on site.

### 2.2. DELIVERABLES

2.2.1. To Supply, Deliver, a double cab bakkie including all on road costs to the ASEZCo.

2.2.2. Maintenance

2.2.2.1. Apart from the standard service plan included in the purchase of the vehicle, the ASEZ requires a 90 000km or 5 year full maintenance plan.

2.2.3. On road cost

2.2.3.1. All on road costs such as delivery, licensing, registration and number plates must be included.

2.2.4. Personalised License Plate

2.2.4.1. The ASEZ would like to have a personalized license plate as well, which must state ASEZ 3 – WP.

2.3.1. This is a once off supply and deliver purchase.
