RESPONSIBILITIES OF SANPARKS

SANParks shall:

- Give indication of unsatisfactory performance to the attention of the company's management for improvement and expect feedback on how such unsatisfactory performance or bad behaviour will be prevented for future occurrences.
- Review the monthly report and provide feedback.
- Effecting payment within 30 days from date of receipt of original tax invoices.

RESPONSIBILITIES OF THE BIDDER

- The General Conditions of Contract (GCC) as well as Special Conditions of Contract (SCC) forming part of this set of tender documents will be applicable to this tender in addition to the conditions of tender. - The service provider may not assign or subcontract any part of the order without the written consent of the Addo Elephant National Park - SANParks.
- For SANParks week, the service provider will need to supply additional staff for five (5) working days: Monday to Friday – dates will be confirmed
- Addo Elephant National Park will need an extra 1 (one) male and 1 (one) female
- Matyholweni Rest camp will need an extra female to assist during SANParks week as stated above.
- The service provider must provide a letter undertaking to register employees on UIF on commencement of the contract.
- It is the responsibility of the appointed service provider to adhere to the Basic Conditions of Employment Act in terms of working hours and remuneration rates of the appointed workers (cleaners).
- The successful service provider will be expected to supply his/her staff with uniform with name tags.
- Only South African citizen can be employed for this project
- No work is to be left unfinished unless authorized by Hospitality Services Manager.
- The service provider must at all times comply with the conditions of the Occupational Health and Safety (OHS) Act, regulations and standards and must also comply with the Environmental Regulations and standards All goods or services purchased will be subjected to inspection by SANParks management

- In the event that the supplier fails to render the service to acceptable standards, SANParks retains the right to take which ever steps are necessary to alleviate the situation. This may include the involvement of other service providers and the service provider will not have any claim because of the actions taken by SANParks.

ASSIGNMENT AND SUB-CONTRACTING

- The service provider will not assign or subcontract any part of the contract

INDEMNITY
