1. PURPOSE

The purpose of this RFQ is to appoint a service provider for servicing, maintenance and repairs on assorted ultralow temperature freezers in Skukuza and Kimberly laboratories for a period of three years.

BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

2. SCOPE OF WORK

Suppliers may submit a proposal for the servicing and repairs of Ultralow Temperature Freezers listed below.

These freezers are already installed on site in Skukuza and Kimberly

The scope of work includes the following:

- Routine inspection and servicing of each unit on a bi-annual basis.
- Stripping, fault-finding and repairs of failed / damaged units as and when required.
- In some cases, this may require emergency call-out to attend to the affected unit, while in other cases this can be addressed during the scheduled routine service site visit. The list of units is as follows:

Additional items:

- In some cases, ULT Freezer units may require off-site repair. The transport arrangements will be handled by SANParks.
- All service / call-out costs to be included in the quote. None of the following will be provided by SANParks: Transport to work site (Skukuza, Kruger National Park or Kimberly Offices); accommodation for technical staff on site; park entry fees etc. Information regarding fees can be accessed at www.sanparks.org
- All listed freezers are cleaned and decontaminated by laboratory staff, on a regular basis, as per SANParks' laboratory SOPs. However, technicians working on site must have extensive understanding of bio-safety protocols and working with potentially infectious substances / potentially zoonotic pathogens, and must be provided with suitable PPE when working on site.
- The approved service provider shall under no circumstances interrupt the operations of the laboratory as a result of his/her activities.
- Full adherence to the Occupational Health and Safety Act, Act 85 of 1993 and other applicable Acts (especially the Animal Diseases Act, Act 35 of 1984) will be applicable during the course of the contract.

- The contract will not be limited to the above-mentioned machinery / instruments as SANParks may expand/replace equipment as required.
- Items damaged or lost due to the service providers negligence will be replaced at the service provider's costs.
- The appointed service provider will invoice SANParks upon completion of each job as per the quotation.
- All issues regarding the repairs/services required are to be communicated with the relevant laboratory manager.
- Only the service providers who company with mandatory requirements will be appointed, and in an event where more than one supplier complied with the mandatory requirements, the suppliers will be asked to quote at the time when a service is required, and a purchase order will be issued to the supplier with the lowest quote price or scored the highest.
- In the cases of emergency call-out to effect repairs, the suppliers will be selected based on the shortest lead time for the call out.

3. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)

The verification during this phase is to assess the bid responses for purposes of verifying compliance with RFQ requirements, whereby a bidder may be disqualified if they do not fully comply which requirements as stipulated below:

- Submission of fully completed SBD1 (Invitation to Bid),
- Submission of a quotation on the company letterhead,
- Submission of fully completed SBD 4 (Bidder's disclosure),
- Submission of fully completed SBD 6.1 (accompanied by the original or certified B-BBEE Status Level Verification Certificate or B-BBEE Sworn Affidavit). (DTIC/CIPC)

4. CENTRAL SUPPLIER DATABASE – MANDATORY COMPLIANCE

Bidders are required to be registered on the Central Supplier Database (CSD) of National Treasury prior to submitting their bid (open tenders). Failure to being registered on the CSD and failure to submit the requested proof of registration on CSD information will lead to disqualification. Payment will be made in accordance with the PFMA (within 30 days of receipt of invoice) after delivery of service rendered or goods delivered.

11. FINAL AWARD

SANParks recommends the bidder who has quoted on all the items as required in terms of the RFQ for the contract award subject to the bidder having supplied the relevant administrative documentation and complied in all aspects with the terms and conditions and requirements of the RFQ. Final award will be confirmed by issuing a PO.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

80/20

Where

Ps = Points scored for price of tender under consideration

Pt = Price of tender under consideration

Pmin = Price of lowest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be

supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

(a) an invitation for tender for income-generating contracts, that either the 80/20 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

(b) any other invitation for tender, that either the 80/20 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7. If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the

The recipient shall within one (1) month of receipt of a written request from SANParks to do so, return to SANParks all material embodiments, whether in documentary or electronic form, of the confidential information including but not limited to:

- (a) All written disclosures received from SANParks;
- (b) All written transcripts of confidential information disclosed verbally by the SANParks; and
- (c) All material embodiments of the contract intellectual property.

The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract.
