DETAILED SPECIFICATIONS

iThemba LABS Cape Town is looking for a company to install two (2) Catalyst 9500 48-port 25/100G, C9500-48Y4C-A switches. The contractor must be a verified Cisco partner and provide six (6) months after sales support. The integration should be demonstrated through a reference document, complete with example reports generated. Currently, iThemba LABS Cape Town campus backbone switches are two Cisco WS-6506-E switches connected as a Virtual Switching System (VSS) for redundancy.

Scope

The scope of this project includes Installation, Integration, Implementation and Testing of the Cisco switches. The contractor will be responsible for removing existing equipment, installing new equipment, making all necessary interconnections, and then verifying that the network is fully functional (Configure VLANs, QoS, routing, security policies, and other items). Ensure all support and maintenance software is configured and activated.

Contractor

The contractor must have sufficient network expertise and certifications for installations. Contractor must be a certified Cisco partner. Silver or Gold Cisco Partner, preferably Gold. Contractor must be

able to provide documentation upon request. Contractor must provide six (6) months after service support.

Documents

The contractor will provide detailed instructions for network design, site survey templates, configuration templates, installation procedures, documentation procedures. Once completed, the contractor should provide an updated network design document listing all a summary of all assigned ports, along with media type, vlan, redundancy, etc.

Training

Training should be provided to a designated IT staff member during the installation.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to Bids and contracts, Bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of Section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation


