- 2. Financial/pricing information must be presented in a **separate** attachment from the Technical / Functional Response information.
- 3. The onus is on the Bidder to further ensure that all mandatory and required documents are included in the electronic submission.
- 4. All electronic submissions should be prominently marked with the full details of the tender in the email subject line.
- 5. Bidders are advised to email electronic submissions at least thirty minutes before the bid closing time to cater for any possible delay in transmission or receipt of the bid. The onus is on bidder to ensure that the bid is submitted on time via email

Any misrepresentation in terms of the above constitutes a criminal offence as set out in the B-BBEE act as amended.

# **DETAILED TECHNICAL SPECIFICATION**

#### 1. COMPANY OVERVIEW

South African Broadcasting Corporation (SABC) is a Public Entity founded in August 1936 and listed in terms of Schedule 2 of the Public Finance Management Act, Act No. 1 of 1999, as a public broadcaster in South Africa, and provides 19 radio stations as well as five television broadcasts to the general public.

#### 2. BACKGROUND

The SABC was declared as a National Key Points (NKP) sites in 2006 under National Key Point Act, Act 102 of 1980. The South African Broadcasting Corporation SOC Limited (SABC) in terms of the Control of Access to Public Premises and Vehicle Act 53 of 1985 and National Key Points Act, No 102 of 1980, as amended, is required to obtain the services of trained NKP security personnel from the bidder to perform twenty-four (24) hour physical security services for the SABC Tshwane offices. The required services will be rendered 24hrs, 7 days per week in SABC Tshwane Offices.

### 3. SCOPE OF WORK FOR PHYSICAL SECURITY SERVICES REQUIRED

As from the effective date of the agreement with the service provider, the service provider shall provide the SABC with required services and expertise as set out in the agreement.

The Services of trained NKP security service provider are required by the SABC to perform duties at the SABC Tshwane offices. The services will also be required for TV Outside Broadcasting as and when required.

The security services shall be provided on the premises as follows:

- Access and Egress control
- Guarding and Patrolling of the premises
- Provide searches as and when required
- Escorting specific persons as required by the SABC from time to time
- Protection of assets, personnel, and the premises
- Control room operations:
  - Monitoring of CCTV Cameras
  - Control room administration duties
  - Handling emergencies in the building
  - Conduct risk and threat assessments around the premises
- Loss control- The control of equipment leaving and entering the premises
- Ad-hoc services outside this agreement will be delivered by the same Service Provider.

 Conduct Covid-19 screening and ensure staff, visitors and contractors adhere to all Covid-19 protocols and guidelines.

The specific duties of security service provider in respect of the premises shall be as described in the SABC's Standard Operating Procedures (SOP's). The SOP setting out the specific duties of the security service provider shall be complied with by the service provider at least a week before the Services commence. The said SOP- may be amended from time to time with the agreement by both parties.

A list of names of Security Officers to be vetted with South African Police Services (SAPS) together with their ID proof should be submitted to SABC Chief Security Officer. Only security officers with positive clearance from SAPS will be deployed at an NKP site.

#### 4. REGULATORY REQUIREMENTS

Bidders are to provide physical security services in line with the following legislations;

- 4.1 National Key Points Act 102 of 1980;
- 4.2 The Control of Access to Public Premises and Vehicle Act, 1985, Section 2, 3 and 4 The application of the Criminal Procedure Act, Act 51 of 1977, Section 20, 23(b) (as amended in the Criminal Procedure Amendment Act, 33 of 1986) Section 24, 29 and 42 (as amended in the Amendment of the Criminal Law Amendment Act, 59 of 1983) as well as Section 46, 49, 50 and 51
- 4.3 Section 13 of the Constitution;
- 4.4 The Firearms Control Act 60 of 2000, section 10, 34, 90 and 106.
- 4.5 Private Security Industry Regulation Act 56 of 2001;
- 4.6 Protection of Information Act 84 of 1982;
- 4.7 Trespass Act 6 of 1959;
- 4.8 Occupational Health and Safety Act 85 of 1993; and
- 4.9 Protection of assets.

#### 5. PERSONNEL REQUIREMENTS

The security service require compliment as follow:

- 5.1 Security compliment of eight (08) NKP trained officers recommended for this site.
- 5.2 Provide five (05) NKP staff for Day shift consisting of one (01) x Grade B and four (04) x grade C.
- 5.3 Provide Three (03) NKP staff for Night shift consisting of one (01) x Grade B and two (02) x Grade C.
- 5.4 The Eight (08) NKP staff, which excludes the relief personnel, hence sufficient compliment of eight (08) NKP trained officers recommended for this site.
- 5.5 The service provider must provide relievers on-an-as needed.
- 5.6 All security staff personnel shall be trained and knowledgeable about SABC procedures, protocol and Standard Operating Procedures (S.O.P). In addition, the graded staff will be responsible for the following:

- 5.6.1 Grade B security personnel who will operate as shift supervisors.
- 5.6.2 Grade C security personnel as per the NKP Act and patrol inside and outside the premises, including the main security control centers, entry and exit

#### 6. PERSONNEL REQUIREMENTS FOR EMERGENCIES

The appointed service provider will be required to provide security personnel for emergencies like demonstrations and riots on an as and when required basis on the same terms.

#### 7. EXPECTED DELIVERABLES

Provide a security management function at the premises which will include access, parameter control at premises and escorting of personnel and/or members of the public as and when required, and general crime prevention measures as instructed from time to time. This service will include the management of all security systems installed by the SABC, as well as the execution of the SABC's security policies and procedures.

#### 8. CHARGES AND SETTLEMENT OF ACCOUNTS

- 8.1 The fees payable by the SABC to the service provider for the security services rendered in terms of this agreement shall not be less than but in accordance with the statutory wages prescribed by the relevant Act.
- 8.2 The prices should be based on the latest PSIRA published rates.
- 8.3 The service provider shall, on or before the end of each calendar month submit to the SABC an invoice, to be certified by both the service provider and the SABC as correct, specifying the services rendered during that current month and detailing the amount due and payable to the service provider. Value added tax shall be shown separately on each invoice for all vat-able items.
- 8.4 Payment for the security services shall be made by the SABC to the service provider within thirty (30) days after the receipt of valid invoice.
- 8.5 Should there be any error in the invoiced amount, it shall be corrected on the following monthly invoice submitted by the service provider.
- 8.6 The service provider shall on or before the end of a calendar month submit a statement to the SABC in respect of services rendered to the SABC in that current month in terms of this agreement.
- 8.7 The SABC will be credited with the amount equal to the services not received during the month of the statement.
- 8.8 At least two (2) calendar months prior to statutory rate increase, the parties shall meet in an effort to agree upon the price in respect of the provision of security services by the service provider for the subsequent 12 months.

#### 9. ACCESS TO PREMISES

- 9.1 Subject to the SABC's security measures, the SABC shall grant the service provider and its employee's access at all reasonable times to the premises so that they may carry out their duties in terms of the contract.
- 9.2 The service provider shall ensure that its employees are fully aware of the SABCs' security measures and regulations and that they shall subject themselves to such rules and regulations, including searches.
- 9.3 The SABC shall provide the service provider with all the necessary keys and access facilities, free of charge, so that the relevant workers may execute their duties in those areas of the building where they have to carry out their function in terms of the contract.

#### 10. GENERAL PATROLS AND FUNCTIONS OF THE SERVICE PROVIDER

The Service Provider must execute the following:

- 10.1 Ensure security officers on foot conduct patrols as per control monitoring equipment on site. Security shall conduct patrols as per the SABC Standard Operation Procedures. These patrols shall be required every day from Monday to Friday between 18:00 and 06:00, and over weekends and public holidays.
- 10.2 Control and supervise all personnel on duty.
- 10.3 Ensure that personnel are deployed at required sites on time and in correct attire or uniform.
- 10.4 Report any emergencies and possible illegal activities that could arise to the SABC Control room with immediate effect.
- 10.5 Provide particular attention to all boundaries and possible approach and/or escape routes which may be used by undesirable persons.
- 10.6 Ensure security personnel are in possession of their identity certificate or permit and necessary equipment at all time in order to perform their duties as required.
- 10.7 Ensure that all security personnel used in these patrols are trained in the proper use of hand held two-way radio sets.
- 10.8 Ensure that all officers at all times are capable to convey salient details of incidents or reporting such incidents.
- 10.9 Propose recommendations to the SABC with the possible improvements or preventative measures relating to security issues relevant to a site.
- 10.10 Ensure a supervisor is on duty and available at all times.
- 10.11 Ensure that an up to date personnel attendance register is maintained.

#### 11. GENERAL CONTROL ROOM DUTIES

# Bidder shall ensure that:

11.1 Security officers issue and receive pre-approved SABC vehicles after hours, weekends and Public Holidays as per Standard Operating Procedures.

- 11.2 Security officers shall manage telephone exchange outside office hours.
- 11.3 Security officers shall monitor all alarms including fire alarms etc.
- 11.4 Security officers shall monitor digital camera system.
- 11.5 Security officers shall perform all other duties as per Standard Operating Procedures of SABC.

#### 12. GENERAL ACCESS DUTIES

- 12.1 Security officers shall manage front door and rear door access points as per Standard Operating Procedures.
- 12.2 Security officers shall monitor and control all gates and access points of the building as per Standard Operating Procedures.

#### 13. ADDITIONAL REQUIREMENTS

- 13.1 12.1 The service provider must provide his own occurrence books and any other registers and stationary required to perform their duty which will subsequently be SABC property.
- 13.2 Contingency plan will be guided by the SABC and will be executed by the service provider during emergencies.
- 13.3 Additional Security Officers may be required on an ad-hoc basis. A fix rate per hour must be quoted for (Casual guarding).
- 13.4 The service provider will provide management structure for the site.
- 13.5 Rates quoted for equipment shall be calculated on twenty four (24) hour shifts, except for equipment utilized in patrols.
- 13.6 Rates quoted for security personnel shall be calculated on twelve (12) hour shifts.
- 13.7 A minimum quoted in one (1) of baton, set of handcuffs, 9 mm Pistols, Active two way Radio, Active Base radio/station is required in the site. (Refer Annexure C).
- 13.8 Charge-out tariffs shall be reviewed annually and agreed increases shall become effective from 1 September each year.
- 13.9 It is a specific requirement for this site that the switchboard and reception will be manned by the service provider after hours on week days (17H00 PM-08H00 AM, weekends and public holidays.

#### 14. ROVING PATROLS

- 14.1 To increase the effectiveness of security personnel, the service provider may be requested to provide roving patrols. These patrols shall be required to randomly patrol the area, supervise all posted security personnel, carry out irregular inspections of security personnel and to provide quick assistance to security personnel when incidents occur.
- 14.2 This service shall be carried out in such a manner to ensure the effectiveness in maintaining alertness of security personnel and prevention of theft.
- 14.3 When the service of additional security personnel are urgently required, the service provider shall provide the additional services at the same rates quoted for, within a time agreed

upon between the SABC and the service provider but not later than twenty four (24) hours after the request has been received.

- 14.4 The additional services shall be provided for a period as agreed upon by both parties.
- 14.5 The service provider shall monitor operational CCTV camera images.
- 14.6 The service provider shall ensure Control room administration and communicate with internal departmental functionaries and contractors with regards to SABC rules / regulations.
- 14.7 The Service Provider will be expected to enter into a Service Level Agreement with SABC over and above contractual agreement. All personnel to be deployed to site are expected to sign non-disclosure agreements

# 15. SPECIAL CONDITIONS TO SECURITY PERSONNEL

- 15.1 The following is mandatory to all security personnel:
- 15.2 Security personnel must be dressed in full company uniform when on duty at all times.
- 15.3 Security personnel to visible wear ID card whilst on duty. The ID card must contain member name, surname, PSIRA number and a photo of the employee.
- 15.4 All personnel must have a police clearance and not have criminal records.

# 16. THE FOLLOWING KPI'S WILL BE USED TO EVALUATE THE PERFORMANCE OF THE SERVICE PROVIDER:

- 16.1 Monthly report submitted before 5 days subsequent to the end of each month. Guards reporting on duty arrive on or before the specified time.
- 16.2 All staff correctly graded and in accepted uniform as per SOP.
- 16.3 Staff shifts to change within 30 minutes (sick leave and relievers planned).
- 16.4 Security personnel to be in possession of correct equipment on-site, replacement of equipment within 48 hours turnaround time.
- 16.5 Training as per SOP and on the job training.
- 16.6 Incidents reporting turnaround time (report within 2 hrs of the incident taking place, preliminary report within 24hrs, final report at completion of investigation with 14 days).
- 16.7 Overall Management and Supervision (attendance of weekly and monthly meetings, availability of after-hours supervisors and offsite management, documented minutes of meetings sent to SABC within 7 days, return of phone calls within 30 minutes & emails within 1 hour).
- 16.8 Proof of refresher training courses undertaken on a monthly and quarterly basis.
- 16.9 All registers and forms must be available for inspection at all times.

# 17. CONTRACT PERIOD

17.1 Eight (08) months.

#### 18. COSTING

The quotation must reflect a detailed cost breakdown, and any indirect costs associated with the rendering of this service (as per current PSIRA rates).

#### 19. RFQ Response Information

#### **Effective Date of Bid**

Vendors should state in writing in its quotation to the SABC that all furnished information, including price, will remain valid and applicable for 90 days from the date the vendor quotation is received by the SABC.

### 20. EVALUATION CRITERIA

#### 20.1 **BBBEE and Price**

The RFQ responses will be evaluated on the 80/20 point system

#### 20.2 Technical Evaluation

- The RFQ submission will be technically evaluated out of a maximum of 40;
- A threshold of 32 points out of 40 has been set.
- Bidder who obtains less than 32 points that will not be considered for the next phase of evaluation.

# 20.3 Site Inspections

- The bidder sites will be inspected and evaluated out of a maximum of 90 points.
- A threshold of 75 points out of 90 has been set.
- Bidder who obtains less than 75 points will not be considered for the next phase of evaluation.

## 20.4 **Objective Criteria**

- The SABC further reserve the right not to award this RFQ to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.
- Bidders who are blacklisted or have committed other acts of fraud and misrepresentation of facts e.g. tax compliance, BBBEE, company financials, etc. will be eliminated from the bid process.

#### **Functionality Threshold for Site Inspection**

Bidders who obtain less than threshold of **75 points** will be declared non-responsive and will be eliminated from further evaluation.

#### 21. ADJUDICATION USING A POINT SYSTEM

- 21.1 The bidder obtaining the highest number of total points will be awarded the contract
- 21.2 Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- 21.3 In the event that two or more bids have scored equal points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 21.4 However, when functionality is part of the evaluation process and two or more bids have scored equal points for B-BBEE, the successful bid must be the one scoring the highest score for functionality
- 21.5 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

#### 22. POINTS AWARDED FOR PRICE

## THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

- 22.1 Bidders who qualify as EME's in terms of the B-BBEE Act must submit a certificate issued by a verification Agency accredited by SANAS for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates or DTI Affidavit.
- 22.2 Bidders other than EMEs must submit their original and valid B-BBEE status levels verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a verification agency accredited by SANAS.
- 22.3 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate
- 22.4 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 22.5 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 22.6 A tenderer will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intend sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended Sub-contractor is an EME that has the capacity and the ability to execute the sub-contract.
- 22.7 A tenderer awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capacity and the ability to execute the sub-contract.

#### 23. COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a RFQ, between the closing date and the date of the award of the business.

All enquiries relating to this RFQ should be emailed two days before the closing date.

#### 24. CONDITIONS TO BE OBSERVED WHEN TENDERING

- 24.1 The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.
- 24.2 No tender shall be deemed to have been accepted unless and until a formal contract / letter of intent is prepared and executed.
- 24.3 The Corporation reserves the right to:
  - 24.3.1 Not evaluate and award tenders that do not comply strictly with this tender document.
  - 24.3.2 Make a selection solely on the information received in the tenders and
  - 24.3.3 Enter into negotiations with any one or more of preferred Tenderer(s) based on the criteria specified in the evaluation of this tender.
  - 24.3.4 Contact any Tenderer during the evaluation process, in order to clarify any information, without informing any other Tenderers. During the evaluation process, no change in the content of the tender shall be sought, offered or permitted.
  - 24.3.5 Award a contract to one or more Tenderer(s).
  - 24.3.6 Accept any tender in part or full at its own discretion.
  - 24.3.7 Cancel this RFQ or any part thereof at any time.
  - 24.3.8 Should Tenderer(s) be selected for further negotiations; they will be chosen on the basis of the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs.
- 24.4 SABC shall not liable for any loss or injuries or damages or death of the bidder representative while travelling for SABC auction business

## 25. COST OF BIDDING

The Tenderer shall bear all costs and expenses associated with preparation and submission of its tender or RFQ, and the Corporation shall under no circumstances be responsible or liable for any such costs, regardless of, without limitation, the conduct or outcome of the bidding, evaluation, and selection process.

## **ANNEXURE A**

## CONSORTIUMS, JOINT VENTURES AND SUB-CONTRACTING REGULATIONS

### 1 CONSORTIUMS AND JOINT VENTURES

- 1.1 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 1.2 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.

# 2 SUB-CONTRACTING

- 2.1 A tenderer will not be awarded points for B-BBEE status if it is indicated in the tender documents that such a tenderer intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points the tenderer qualifies for, unless the intended sub-contractor is an exempted micro enterprise that has the capacity and ability to execute the sub-contract.
- 2.2 A tenderer awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the tenderer concerned, unless the contract is sub-contracted to an exempted micro enterprise that has the capability and ability to execute the subcontract.
