3. OUTLINE

These Terms of Reference outline the minimum Scope of Work for which the Electrical Contractor (Electrical Cont) is responsible. It defines key activities and what the Electrical contractor is responsible for delivering i.e. the required outcomes as a result of the electrical activities.

4. BACKGROUND

Winnie Madikizela Mandela Local Municipality falls within the jurisdiction of Alfred Nzo District of the Eastern Cape Province.

The municipality has a valid NERSA approved distribution license to the residents of Bizana. Due to the rapid growth and development within the jurisdiction, Winnie Madikizela Mandela municipality therefore seeks to have service providers that will be on a fixed/callout contract whenever there is a need. The appointed Electrical contractors will be required to provide a Crane Truck and labour to carry out every electrical work that they have been called out for. The turnaround or response time for every call out will be stipulated by the client in every callout.

5. SCOPE OF WORK

Winnie Madikizela Mandela Local Municipality, Electrical Unit, invites bids for the provision of Crane Truck Hiring services for electrical repair works on both MV and LV network within the Winnie Madikizela Mandela municipality operational area. This will include the replacement of MV apparatus such as transformers, MV poles, conductors and all electrical connections related to the above.

All MV switching testing and earthing operations will be conducted by Winnie Madikizela Mandela municipality technicians and the appointed contractor must make sure that all necessary precautions as mentioned above have been followed before any resumption of works.

MINIMUM REQUIREMENTS

- . Proof of ownership of a crane truck
Or
- . An agreement to lease (the owner must attach proof of ownership)
- . Crane operator certificate (attach proof)

NB. Bidders should take note of the above technical (quality) evaluation criteria.

- [a] All the necessary documentation must be submitted for the Evaluation Panel to make an informed evaluation. Evaluation of the Technical (Quality) Requirements will be based on the information provided by the bidder.
 - [i] **Experience** - The experience annexure must be completed. Only Crane operators with experience on working on electrical apparatus and networks will be considered. Please attach CV of Crane operator detailing the required experience.
 - [ii] **Expertise** – The qualifications (Crane Operating certificate) of the company/team to undertake the work must be provided for evaluation purposes. Please attach Crane operating Certificate
- [b] Bids that do not meet a minimum 50 % in total for the criteria listed above will not be considered further.
- [c] A minimum total score of 50% out of 40 points must be obtained in order for the bid to proceed to the Financial Evaluation i.e. 80 points.

CONDITIONS OF APPOINTMENT

Compliance with and performance in terms of the Terms of Reference is a specific condition of the appointment of Crane Truck Hiring Services. The Municipality will provide all relevant information available for the purpose of successfully completing the project.

The appointed service provider will be paid according to rates supplied for the particular work done on a callout.

6. SCOPE OF WORK FOR CRANE TRUCK HIRING SERVICE

The scope of work will be as per the instruction given to the contractor during callout based on the activities that will be tabled as itemized with execution rates.

- a. Supervision on installation of equipment and compliance to OHS Act requirements.
- b. Providing the municipality with a detailed report of all work done.

PROJECT SETUP

- a. The project will be a two-year fixed contract based on a call out by the client.
- b. The response time to any callout must not be more than 5 hours from the time of call.
- c. The kilometers that will be paid for by the client are limited to 100km to and from the work site.

The Electrical Contractor is responsible for his/her staff's safety and that of the community around where the work is being carried out during all callout. .

 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
