Tenderer must base its estimated rigid inclusion lengths on the 1785-C0-030-C-DWG-0001-01-T-0A to 1785-C0-030-C-DWG-0001-03-T-0A and 1785-C0-030-C-DWG-0002-01-T-0A and 1785-C0-030-C-DWG-0002-02-T-0A and the borehole data.

1785-C0-020-C-DWG-0002-01-T-0C and 1785-C0-020-C-DWG-0003-01-T-0A show the level of the top of the sandbank as 0.0m CDP \pm 1.0m. Tenderer to base estimate on 0.0m.
