### **Specifications for 3 X 32 000 Btu/hr non- inverter air conditioners:**

Wall Split 32000 Btu/hr Non Inverter Air Conditioner  
Eco-friendly R410A Gas  
Cooling and Heating  
Refrigerant Leak Detection Protection Function.  
Installation must be included in the quote (2 X standard installation back to back and 1 X ground floor/first floor installation requiring 8 m tubing). The installation will involve removal of the current dysfunctional units and replacement with the new units.  
Minimum of 12 Month Warranty on all parts and 5 years on the compressor

## 2. Compulsory requirements:

- 2.1. Valid current Tax Clearance Certificate and the pin code issued by the South African Revenue Services (SARS).
- 2.2. Only bidders registered on the Central Supplier Database (CSD) will be considered. Bidders shall include the CSD registration number with the bid proposal.
- 2.3. Only bidders that submit a valid current certified copy of the BBBEE certificate, original BBBEE certificate or the sworn affidavit, will be considered for scoring on the 20 points as per the 80/20 principle. Bidders are therefore required to submit the certified copy of the BBBEE certificate, original BBBEE certificate or the sworn affidavit.
- 2.4. Completed and signed Standard Bidding Documents (SBD) forms included in the bid document.
3. The above specified goods/services should be delivered / rendered to the ARC-Onderstepoort Veterinary Institute at above-mentioned delivery address.
4. The particulars of the guarantee that will apply to the goods quoted for, with the particular regards to the period and extent of the warranty must be clearly stated. Where services are required, service providers must submit documentation pertaining the relevant experience.
5. Your written quotation must be deposited or emailed depending on the instructions given in the email.
6. All price quotations that have a rand value of R 30,000.00 to below R 50,000,000.00, including VAT, will be evaluated by applying the 80/20 principle as prescribed by the Preferential Procurement Policy Framework Act 5 of 2000 and its Regulations. The lowest acceptable price will score 80 points, the 20 BBBEE points will be allocated as follows:

7.6 Quotes should be submitted on an official letterhead and duly signed.

7.7 Goods and services should be supplied / rendered upon receipt of a purchase order from the ARC.

7.9 The ARC supply chain management code of conduct is applicable.

7.10 Standard Bidding Documents (SBD) forms must be signed and returned together with the quotation if the price is above R 10,000.00. Failure to comply will result to disqualification of your quotation.
