The contract comprises of the following:

- Demolition of existing surfacebed
- Construction of new combi court surface bed, surfacing and markings
- Provision of goalposts
- Erection of combi-court fencing

It is estimated that tenderers should have a CIDB contractor grading designation of **2 CE** or higher.

A compulsory clarification meeting with representatives of the Employer will take place at the council chambers at Port Nolloth Library on **Tuesday, 17 February 2026 at 11H00**. The closing time for receipt of tenders is **Friday, 13 March 2026 at 12H00**. Bid documents must be deposited in the bid box situated at the municipal offices, 169 Main Road, Port Nolloth. Late bid submissions will be not considered. Bids will be evaluated in accordance with the applicable Preferential Point Scoring System as set out in the Councils Supply Chain Management Policy. The following forms: **MBD1, MBD 4, MBD 6.1, MBD 6.2, MBD 8, and MBD 9** must be completed and submitted with the bid. The Municipality reserves the right not to award the tender to the only or the lowest Tenderer. Tenders may only be submitted on the tender documentation that has been issued.

**The following tender conditions will be applicable:**

- a) Faxed, e-mailed or late Proposals will not be accepted.
- b) The tender will be evaluated on 80/20 system Where 80 points for price and a maximum of 20 points for specific goals. To claim for specific goals prospective bidders MUST submit proof of the required documents. Specific goals will be evaluated based on the upliftment of communities through, but not limited to, housing, transport, schools infrastructure donations, charity organisations letter of intent (2% of contract value). Letter of intent to be attached. 10 Points awarded. The promotion of enterprises located in a specific province for work to be done or services to be rendered in that province, specifically referring to the Northern Cape will be awarded 10 Points.
- c) No tender offer will be considered from the following tenderers: Persons who were convicted for fraud or corruption during the past five years. Who wilfully neglected, reneged on or failed to comply with a government contract during the past five years
- d) Tenderers must submit a valid Tax Clearance Certificate or SARS PIN.
- e) Tenderers must be registered on the CENTRAL SUPPLIER DATABASE. Log onto [www.csd.gov.za](http://www.csd.gov.za) for registration or accredited as a Contractor or a contractor according to the Central Contractor Database (CSD).
