NEW 66/11KV SUBSTATION IN CLANWILLIAM AND NEW 66KV FEEDER BAY IN GRAAFWATER SUBSTATION

Cederberg Municipality invites tenders for contract no: CED 20/2022-2023 for a new 66/11kV 10MVA substation in Clanwilliam, and a new 66kV feeder bay in the existing Graafwater Substation. Both projects will be executed under an Eskom Self-Build agreement and handed over to Eskom once completed. It is compulsory that the Tenderer must provide proof that he is an approved Eskom Contractor.

The project is planned to be executed over the 2022/23, 2023/24 and 2024/25 financial years.

Only tenderers who satisfy the eligibility criteria stated in the Tender Conditions and Tender Data (Clause C.2.1) are eligible to submit tenders. It is estimated that tenderers should have a CIDB contractor grading designation of **7EP** or higher.

Only locally produced or locally manufactured transformers class 1 (80%), transformers class 0 (90%), steel structures and hardware (100%), steel products and components (100%), industrial lead acid batteries (50%), electrical- telecom cables (90%), cement (CEM1) (100%) and plastic pipes (PVC) (100%) with stipulated minimum thresholds for local production and content will be considered.

All bids received shall be evaluated in terms of the Cederberg Municipality's Supply Chain Management Policy, read with the Preferential Procurement Regulations of 2017. It is estimated that the 80/20 preference points system will be applicable. Tenders will be evaluated in terms of price and preference.

The successful tenderer must also be registered on the Centralized Supplier Database (CSD). Tenderers can register on www.csd.gov.za.
