The City of Mbombela is inviting bids from experienced service providers for provision of catering services for the City of Mbombela.

It is compulsory that service providers download a copy of the bid document that will ONLY be available as from 31 July 2026 on the City's website: www.mbombela.gov.za on the tenders and notices' folder and National e-Tender Portal: www.etenders.gov.za, free of charge.

Duly completed bid documents and supporting documents which are, COPY OF TAX COMPLIANCE STATUS, CERTIFIED COPY OF B-BBEE CERTIFICATE OR SWORN AFFIDAVIT FOR B-BBEE, CURRENT MUNICIPAL RATES AND TAXES STATEMENTS FROM RELEVANT LOCAL AUTHORITY OR PROOF OF RES FROM A TRIBAL AUTHORITY OR LEASE AGREEMENT ACCOMPANIED BY THE LESSOR'S UP-TO-DATE RATES AND TAXES STATEMENTS FOR BOTH THE BUSINESS AND ACTIVE DIRECTORS INCLUDING JV/CONSORTIUM MEMBERS, CSD REGISTRATION FULL REPORT (Summary Report will not be considered) and a copy of the COMPANY REGISTRATION CERTIFICATE, together with the bid document must be sealed in an envelope clearly marked: **"BID NUMBER, FULL PROJECT DESCRIPTION AND CLOSING DATE"** with the name of the bidder shall be placed in the bid box at MBOMBELA CIVIC CENTRE at 1 NEL STREET, MBOMBELA, before 11:00 on the closing date.

Bids received by telegram, fax or e-mail will not be considered. Late bids shall not be accepted or considered.

A compulsory site briefing will be held on 4 August 2026 at 11:00 in the Mbombela Stadium Shed, 1 Bafana Road, Mataffin, Mbombela, 1200.

Bidders are advised not to commit fraudulent activities or forge documents. All abusers of the SCM system, including forging or faking of returnable documents, may be reported to SAPS and restricted from doing business with any Public Institutions for a period NOT exceeding 10 years which is in line with section 28 and 29 of the Prevention and Combating of Corrupt Activities Act 12 of 2004.

A preferential point system shall apply whereby this contract will be allocated to a bidder in accordance with the Preferential Procurement Policy Framework Act, No 5 of 2000 and as defined in the conditions of bid in the bid document, read in conjunction with the Preferential Procurement Regulations, 2022, where 80 points will be allocated in respect of price and 20 points in respect of targeted goals.

SPECIAL CONDITIONS OF THE BID

1. SUBMISSION OF TENDERS

The tender must be completed on the attached tender form, which shall not be detached from this document. The completed submission must be fully priced, extended, and totalled, completed in all respects, and duly signed. It shall be sealed in an envelope and submitted in accordance with the instructions provided in the Invitation to Tender.

Proof of posting will not be accepted as proof of delivery to the designated tender receipt location.

Tenders will be opened in public immediately after the advertised closing date and time.

All information submitted by prospective bidders will be used solely for tender evaluation purposes and will be handled in accordance with the Protection of Personal Information Act (POPIA).

2. TENDER DEPOSIT

Tender documents may be downloaded free of charge from the following platforms: the City of Mbombela website at www.mbombela.gov.za under the Tenders and Notices section, as well as the National e-Tender Portal at www.etenders.gov.za

3. ADJUDICATION OF TENDER

The City of Mbombela reserves the right, at its sole discretion, not to accept the lowest-priced bid or any bid received and may cancel or withdraw this tender at any stage of the procurement process should it be deemed necessary or in the best interests of the Municipality. The Municipality shall not be liable for any costs incurred by bidders arising from such cancellation or withdrawal.

This bid shall be evaluated and adjudicated in accordance with the provisions of the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000), the Preferential Procurement Regulations, 2022, the Municipal Finance Management Act, 2003 (Act No. 56 of 2003), the City of Mbombela's Supply Chain Management Policy, Preferential Procurement Policy, and all applicable legislation governing public procurement. Evaluation shall be conducted using the 80/20 preference point system, whereby 80 points will be allocated for price and 20 points for specific goals.

Bidders shall not alter, amend, modify, or add to any part of the bid document except where such amendments are expressly permitted or issued in writing by the City of Mbombela. The bid document shall be completed in non-erasable black ink. Any corrections or amendments must be initialled and dated by the duly authorised signatory. The use of correction fluid, masking fluid, pencil, erasable ink, or any unauthorised alterations is prohibited and may render the bid non-responsive.

All bid documents shall be fully completed and signed by a person duly authorised to bind the bidder. Where the bidder is a juristic person and the bid is signed by a person other than the sole director, sole member, or sole proprietor, the bidder shall submit proof of the signatory's authority to bind the entity, in accordance with the requirements of the bid document. This may include, where applicable, a directors' or members' resolution, power of attorney, or other written authority. Failure to submit the required proof of authority shall render the bid non-responsive.

All bid documents shall be fully completed and signed by a person duly authorised to bind the bidder. Where applicable, proof of authority of the signatory shall be submitted in accordance with the requirements of the bid document. Failure to comply with this requirement may result in the bid being declared non-responsive. This requirement shall not apply to sole proprietors or entities with a single director or member.

A bid shall be rejected where any municipal rates and taxes or municipal service charges owed by the bidder (including its business entity or directors) to any municipality or municipal entity are in arrears for more than three (3) months. Failure to submit valid and up-to-date proof of municipal rates and taxes will also render the bid non-responsive.

The City of Mbombela reserves the right to verify all information submitted by bidders. Should any information, document, declaration, or certificate be found to be false, misleading, inaccurate, or fraudulent, the Municipality may reject the bid, cancel any resulting contract, recover any damages suffered, and institute any legal or administrative action deemed appropriate.

Bids shall be rejected where the bidder or any of its directors, members, trustees, or partners appears on the National Treasury Register for Tender Defaulters established in terms of the Prevention and Combating of Corrupt Activities Act, 2004 (Act No. 12 of 2004), or is listed on the National Treasury Database of Restricted Suppliers, or is otherwise prohibited by law from conducting business with any organ of state.

Bids may also be rejected where the bidder has committed fraud, corruption, fronting, collusion, or any other improper conduct, or has abused the Supply Chain Management System of the City of Mbombela or any other organ of state, in accordance with applicable legislation and the Municipality's Supply Chain Management Policy.

The MBD 1 form shall be regarded as the Form of Offer and must be fully completed and duly signed by the authorised signatory; failure to do so will render the bid non-responsive.

4. COMPLETION OF TENDER DOCUMENTS

Tenders shall only be considered if this tender document is fully and correctly completed, with all required information inserted in black ink and duly signed.

4.1. Compulsory documentation to be submitted

The following compulsory documents must be attached to ensure that the bid is considered:

- A valid Tax Compliance Status (TCS) Pin.
- Proof of company registration.
- Certified copies of the Business Director(s)' identity documents.
- A full Central Supplier Database (CSD) registration report not older than 30 days from the closing date. Summary reports will not be accepted.
- At least one certified copy of an appoint letter / certified copy of a purchase order with a certified reference letter for decoration services (200 people >) for company experience.

4.2. Municipal rates and taxes requirements (Bidding Entity)

- The bidder must submit a valid and current municipal rates and taxes statement for the business premises issued by the relevant local authority.
- Where the business operates in an area under the jurisdiction of a recognised traditional authority, the bidder may submit proof of residence issued by the relevant tribal authority.
- Where the business premises are leased, the bidder must submit a valid lease agreement together with the lessor's current municipal rates and taxes statement for the leased premises.
- The physical business address reflected on the Central Supplier Database (CSD) must correspond with the address reflected on the company's registration documents.
- The Municipality reserves the right to verify the municipal rates and taxes information against the details reflected on the CSD and the company's registration documents.
- It remains the responsibility of the bidder to ensure that the company's municipal rates and taxes account is fully paid and not in arrears.

4.3. Director(s) Municipal Compliance

- The bidder must submit valid and current municipal rates and taxes statements for each active director, including directors of consortium or joint venture partners, for the residential addresses reflected on the company's CIPC registration documents.
- Where a director resides in an area under the jurisdiction of a recognised traditional authority, proof of residence issued by the relevant tribal authority may be submitted.
- Where a director occupies leased residential premises, the bidder must submit a valid lease agreement together with the lessor's current municipal rates and taxes statement for the leased property.
- The residential address reflected on the municipal rates and taxes statement, proof of residence, or lease agreement must correspond with the residential address of the respective director as recorded on the company's CIPC registration documents.
- The Municipality reserves the right to verify the municipal rates and taxes compliance of each director using the director's identity number and the residential address reflected on the CIPC registration documents.
- It remains the responsibility of the bidder to ensure that the municipal rates and taxes obligations of all active directors, consortium or joint venture partners, and, where applicable, the lessor, are fully settled and not in arrears.

4.4. General note

- For all key personnel whose CV is submitted, certified copies of qualifications and certified copies of identity documents must be submitted with the bid (if applicable).
- Certified copies must not be older than three (3) months to be considered valid.
- Copies of certified copies will not be accepted; only certified copies of original documents shall be recognised.
- Failure to comply with the above requirements will result in immediate disqualification.

5. TAXES AND DUTIES PAYABLE

Bidders shall include in their tender prices all applicable taxes, duties, and levies. No claims for additional payment in respect thereof will be entertained.

All prices and rates quoted shall be inclusive of Value-Added Tax (VAT). VAT shall be reflected as a separate lump sum in the tender summary, and the total amount inclusive of VAT shall be carried forward to the Form of Tender.

6. WITHDRAWAL OF TENDER

In the event that the successful bidder fails to perform the services in accordance with the terms of this tender, the City shall be entitled to terminate the contract summarily. In such circumstances, the bidder shall be liable for any additional costs incurred by the Municipality as a result of re-advertising the tender or awarding the contract to a less favourable bidder.

7. NOTICE OF BIDDERS

Should any amendments, additions, or alterations to the tender documents be deemed necessary prior to the closing date for the submission of tenders, such amendments shall be communicated to bidders through Notices to Bidders, which shall form an integral part of the tender documents.

Where applicable, bidders shall complete, sign, and date the Notices to Bidders and submit them together with their tender submissions.

8. PERIOD OF VALIDITY OF TENDERS

The tender shall remain valid for a period of thirty (30) days from the closing date for the submission of tenders, as specified in the Tender Form.

9. BID PRICE

All prices quoted shall be inclusive of the delivery of the required services as specified in the bid specifications, Value-Added Tax (VAT) where applicable, and all disbursements and associated costs.

All prices must be quoted in South African Rand (ZAR) and shall be deemed firm and fixed for the duration of the contract, unless otherwise stated in the bid documents.

10. CESSION OF ASSIGNMENT

Neither the Council nor the successful bidder shall cede, assign, transfer, or otherwise dispose of any rights, obligations, benefits, interests, or any part of the contract to a third party without the prior written consent of the Council.

Any cession or assignment shall only be permitted where it is made in favour of a duly registered financial institution and subject to the prior written approval of the Council.

11. DELIVERABLES

The successful bidder shall be responsible for the provision, supply, installation, maintenance, and removal of all decoration elements required for the City of Mbombela Employees' Empowerment Event, in accordance with the specifications, approved concept, programme schedule, and any instructions issued by the City of Mbombela or its appointed Project Manager.

The decoration services shall include, but not be limited to, the following:

Provision of a complete decoration setup in accordance with the approved theme, colour scheme, layout, and event requirements as specified by the City.

Supply and installation of all required décor items, including, but not limited to, table decorations, centrepieces, stage décor, entrance décor, backdrops, floral arrangements, fabric draping, lighting décor, themed elements, and any other decorative features required for the event.

Professional setup and arrangement of all decoration items at the designated venue prior to the commencement of the event.

Ensuring that all décor installations are aesthetically pleasing, safe, stable, and suitable for the venue and nature of the event.

Ensuring that all decoration materials, equipment, tools, and resources required to execute the service are provided by the successful bidder and are of an acceptable quality and standard.

Maintaining the décor presentation and replacing or rectifying any damaged, defective, or unsuitable decoration items during the event period, where applicable.

Removal of all decoration items, equipment, and materials after completion of the event, leaving the venue in a clean and orderly condition.

The event is scheduled to take place on 18, 19, 20 and 21 August 2026 at the Mbombela Stadium Shed. Detailed logistical arrangements, including access times, setup schedules, venue requirements, and coordination arrangements, shall be confirmed with the successful bidder upon appointment.

The successful bidder shall ensure that all decoration services, materials, equipment, personnel, and resources are delivered and fully operational at the designated venue within the agreed setup timeframe. Strict adherence to the approved decoration plan, specifications, quality requirements, and event programme shall be mandatory.

The successful bidder shall be required to coordinate closely with the City's appointed Project Manager and comply with all reasonable instructions relating to the execution, positioning, alteration, or removal of décor elements. No changes to the approved decoration concept, specifications, or layout shall be made without prior written approval from the Project Manager.

Failure by the successful bidder to provide the required decoration services in accordance with the approved specifications, agreed timelines, quality standards, and instructions of the Project Manager shall constitute a breach of contract and may result in the City exercising any contractual remedies available, including withholding payment, requiring corrective action, claiming damages, or terminating the contract where appropriate.

The City shall not be liable for any costs incurred by the successful bidder as a result of failure to comply with the contractual requirements.

Late delivery, incomplete setup, poor workmanship, or delayed arrival of personnel, décor items, or equipment shall not be permitted unless prior written approval has been obtained from the Project Manager due to exceptional circumstances.
