This bid will be evaluated in terms of the Functionality criteria as set forth in the bid document and the 80/20 preferential points system shall apply. This Bid will be adjudicated in accordance with the Preferential Procurement Policy Framework Act (Act no 5 of 2000) and as defined in the Conditions of the Bid in the document, read in conjunction with the Supply Chain Management Policy of the KAGISANO-MOLOPO LOCAL MUNICIPALITY, the Municipal Finance Management Act (Act no 56 of 2003) and the MFMA Supply Chain Management Regulations.
