1. INTRODUCTION

The City of Tshwane (here after referred to as the CoT) is seeking service providers to submit bids for the supply, delivery and off-loading of safety nets (upper nets) underlined by debris netting (shade cloth) for steel bulk waste containers to the Municipality's Waste Management Depots, as and when required, over a period of 12 (twelve) months.

2. BACKGROUND

The city provides a service for the collection and transporting of business and domestic waste from premises at an applicable tariff, through the use of steel bulk waste containers. Bulk waste containers are placed at the client's premises and serviced as per the client's request. The steel bulk waste containers need to be covered with safety nets so that waste does not spill on the ground or on other vehicles, and cause damage whilst being transported to disposal sites.

The city requires safety nets to address the need for safe transportation of waste to the city's disposal sites. The city therefore intends to procure safety nets to meet this need.

3. DESCRIPTION OF SERVICES

The safety net (upper nets) prevents waste from falling off the bins whilst the debris net (shade cloth) prevents the small objects from falling off. The nets protect workers, pedestrians and motorists.

Therefore, the city plans to procure safety nets, which must be delivered and off-loaded as would be advised by the project manager.

The Municipality does not guarantee to purchase the quantities indicated or any quantity. The Municipality reserves the right to increase or decrease the approximate quantities.

4. DELIVERABLES

The nets have been split into two categories, category A and category B. The safety net material and design shall be as per the provision below, and as per the figures provided.

Category A: Safety nets for 4 m³, 6 m³, 11 m³ and 12 m³ steel bulk waste containers (skip bins).

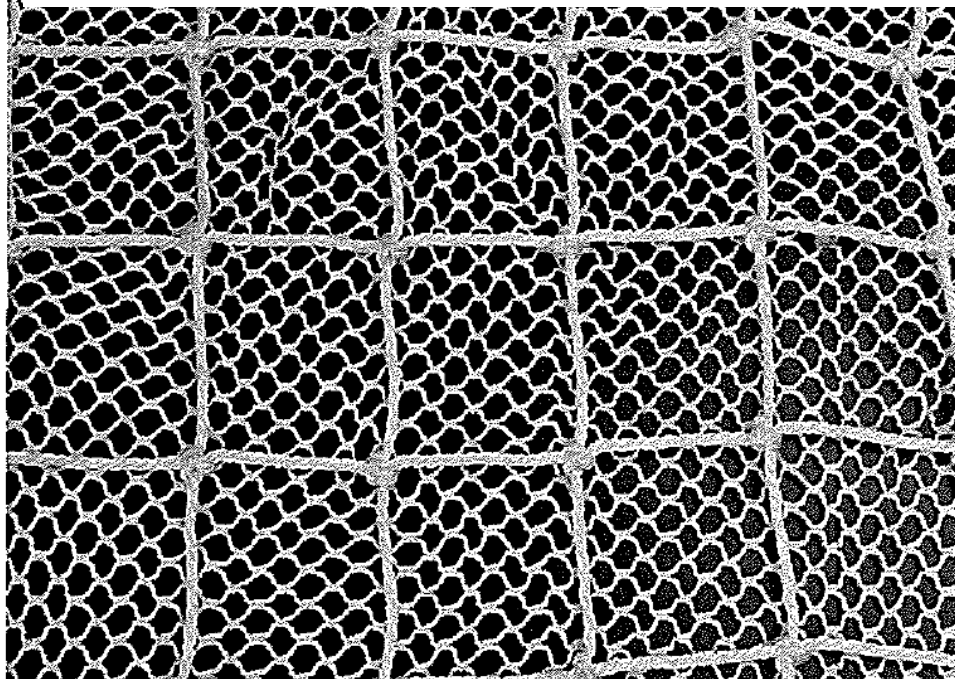


Figure 2: Mesh size

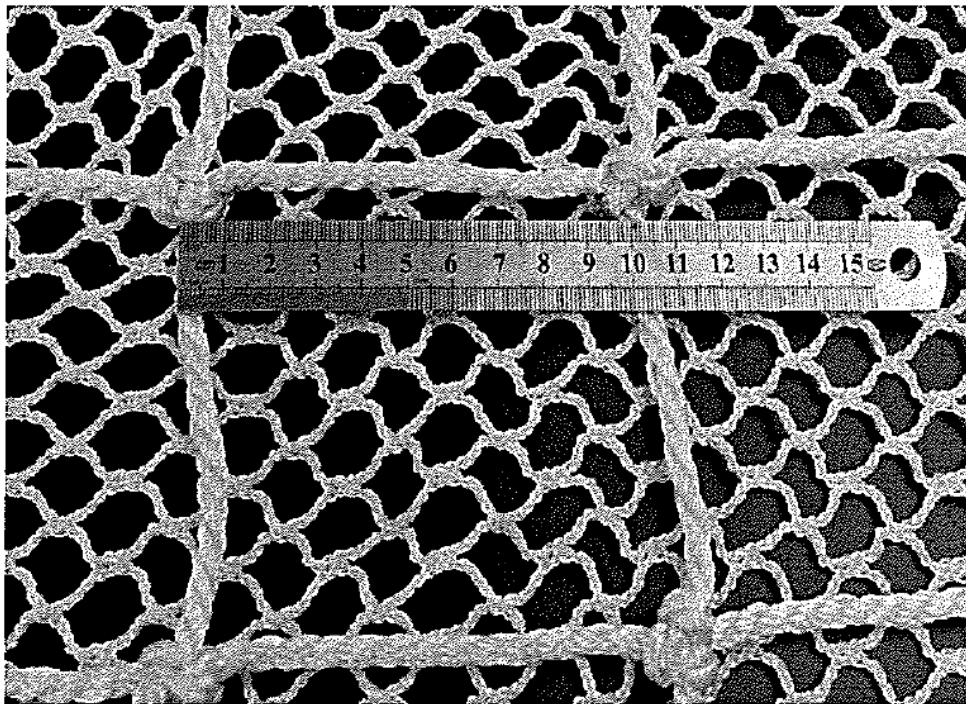
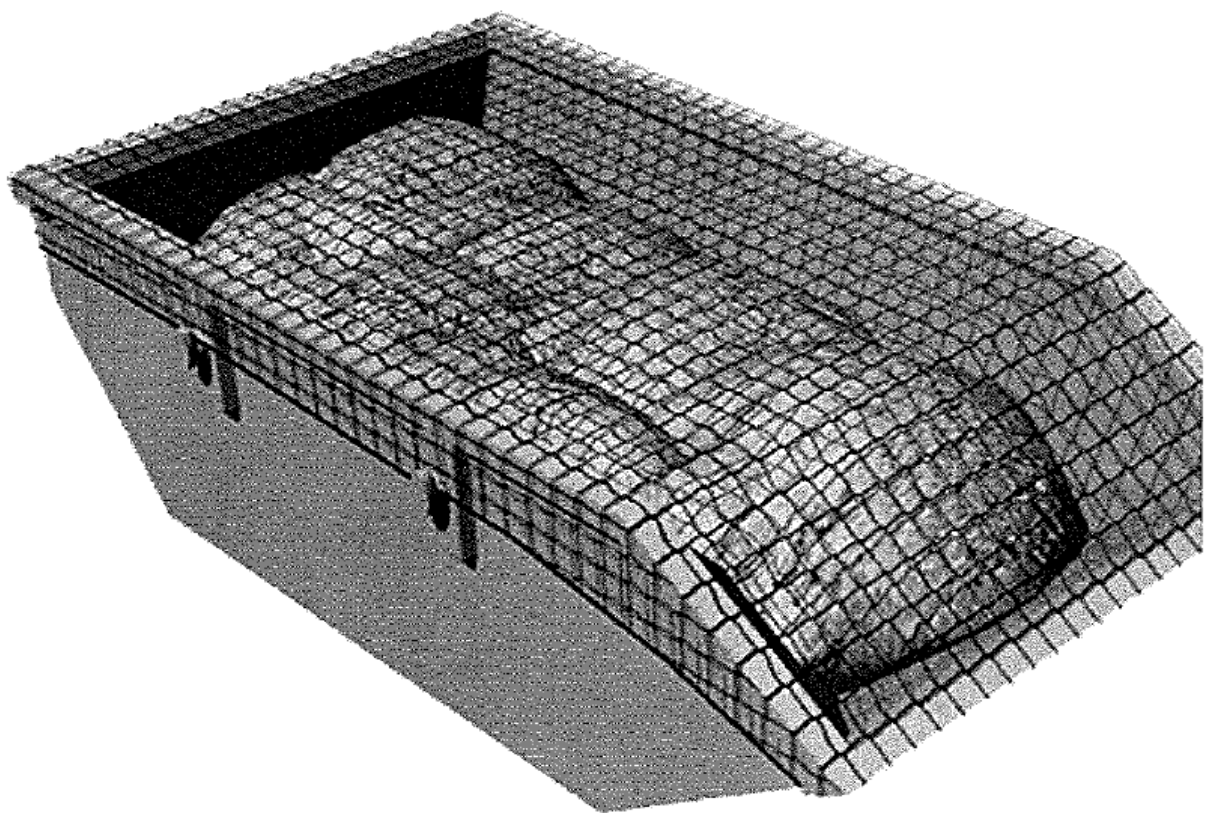


Figure 3: Bulk waste container covered with safety net



MINIMUM REQUIREMENTS FOR INTERESTED BIDDERS AND SPECIAL CONDITIONS OF THE TENDER

All tender conditions and/or instructions set out below must be strictly adhered to, failing which this bid submission may be declared non-responsive.

Quality and guarantees

If at any time on delivery the Waste Management Division is dissatisfied with the workmanship, the service provider must immediately remedy any defect to the satisfaction of the Waste Management Division.

The guarantee period for quality and workmanship shall be twelve (12) months. A guarantee period below twelve (12) months will result in the tender being disqualified. The bidders shall submit full details of their guarantee commitments, indicating in all respects the extent thereof, failing to do so, the bidder will not be considered.

5. MANAGEMENT AND REPORTING

The service provider will report to the representative of the city who will be the project manager.

6. AREA TO BE SERVICED

The service provider shall be responsible for supply, delivery and off-loading of safety nets (upper nets) underlined by debris netting (shade cloth) for steel bulk waste containers, at the Waste Management Depot, 1 Von Wielligh Street, Pretoria West. It should be noted that the service provider will be held liable for incidents during the transportation process.

7. DETAILS OF OFFER AND REQUIRED SAMPLE

- 7.1** The safety nets supplied should be SABS compliant. The service provider will be required to comply with all standard specification and must, if ordered to do so, furnish the Waste Management Division with certificates indicating that the material does comply.
- 7.2** The City reserves the right to request a sample of the nets, which must be delivered to the Waste Management Depot, 1 Von Wielligh Street, Pretoria West at the bidder's own cost when requested to do so by the Waste Management Division after closing of the bid. The samples would then be evaluated against the applicable standards and specification. In a case where the City decides to submit a sample for SABS testing, costs of such shall be borne by the bidder.
- 7.3** The specifications do not amend or replace the General Conditions of Contract and Special Conditions of Contract in any way, but complement

them by providing more specific details and requirements, and should therefore be read in conjunction with both documents above.

8. MATERIAL

Should it appear to the Project Manager that the service provider is not executing the contract in accordance with its true intent and meaning, or that he/she is refusing or delaying to carry out the contract, or that he/she is not carrying out the contract at a rate of progress to ensure delivery by the delivery date (14 days after receipt of purchase order), or that the time has expired within which delivery should have taken place, or in the event of any other failure or default by the service provider, then the Project Manager may give notice in writing to the service provider to make good on the failure or default. Failure to correct could lead to cancellation of an order.

9. RECORDS

The service provider shall keep record of all safety nets supplied according to date, time and serial number, and according to the issued order. The service provider shall also supply the city with these record as and when required, during the contract period.

10. PERFORMANCE CLAUSE

Performance clause will be based on section 21 of the general conditions of contracts.

11. VALIDITY PERIOD

The validity period for the quotation after closure is 90 days.

12. CONDITION

- The safety nets supplied should be SABS compliant.

13. EVALUATION CRITERIA

The bidders will be evaluated in three stages. The evaluation will be done as follows;

- Stage 1: Administrative compliance
- Stage 2: Mandatory requirements
- Stage 3: Preferential Point System.

Stage 1: Administrative Responsiveness Evaluation

14. MARKET ANALYSIS

The city of Tshwane reserves the right to conduct market analysis. Should the city exercise this option, where a tenderer offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the tenderer if they will be able to deliver on the price, if a tenderer confirm that they cannot, the tenderer will be disqualified on the basis of being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract, including performance warnings and listing on the database of restricted suppliers.

The city further reserves the right to negotiate a market related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the tenderer scoring the second highest points, if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the quotation.

15. SERVICE LEVEL AGREEMENTS

The successful bidders must enter into a Service Level Agreement with the Municipality upon appointment for this quotation.

9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
