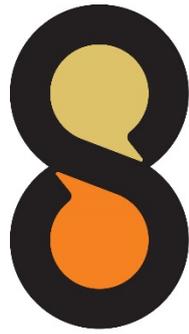

## 1. SCOPE OF WORK

The appointed services provider is expected to provide SALGA with the following:

### 1. Augmentation of Cost-of-Supply Studies

Enable the automation of cost and profitability processes in the determination of tariffs for electricity and water – based on approved rules, guidelines, and formulae.

### 2. Data Aggregation and Pipelining

Build a functionality that ensures for the manual and automated sourcing of required data points for the conducting of the Cost-of-Supply studies (incl. internal municipal data and external micro and macro-economic data). This will encompass the formalisation of those data pipelines in conjunction with SALGA. This will also ensure data cleansing and harmonisation.

### 3. Scenario Modelling Capabilities

Facilitate for the generation of multiple scenarios in ensuring municipalities can simulate various conditions and circumstances (i.e. If-scenarios and goal-seeking exercises)

### 4. Document Management

Support uploading and downloading of all relevant documents (e.g., death certificates, certificates of competence, ownership certificates), ensuring secure storage and easy retrieval. These must be traceable and accessible at any point in time.

### 5. User Access and Security

Embed user authentication in order to ensure data is protected from unauthorised access.

### 6. AI Capabilities within the platform

Have Artificial Intelligence embedded within the architecture of the solution (in line with the SALGA Digital's framework component of Future-Focused Architecture).

### 7. Reporting

Generate standard and custom reports, dashboards that would summate outputs produced from both final models/tariffs as well as scenarios products – thereby visualising the path towards the final tariffs for both traceability and explainability.

## 2. BIDDER REQUIREMENTS

### 2.1 Specifications and requirements

- The bidders will be expected to demonstrate technical ability and capability to develop and maintain a customisable, data-dependent Cost and Profitability modelling solutions – that are cloud-based and web-based – using platforms within Microsoft Azure, SAS, AWS, and/or GCP.
- Furthermore, the bidders will be expected to demonstrate their ability to incorporate Artificial Intelligence agents into their solution (be it through incorporating one or more of the agentic AI engines from Microsoft, SAS, AWS or GCP).
- Bidders must demonstrate having made use of, and implemented projects, using Microsoft suite as well as SAS-based solutions. Evidence can be provided through screens and/or signed reference letters.

- The technical lead(s) from the bidder must have at least 10 years in developing data analytic and modelling solutions in at least three distinct industries (including financial services and the public sector). This can be supported through resumes/CVs.

1.1 The following preference point systems are applicable to invitations to tender:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

(b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
