1. Contextual Background

Elias Motsoaledi Local Municipality (EMLM) is a rural local based in the South-eastern Limpopo Province of the Republic of South Africa. The Local is habitant to the population estimated at 215010 (Stats SA, Community Survey 2011).

The communities within the local are governed in terms in the traditional leadership with 5 traditional authorities and 31 wards. The ward committees, ward community development workers (CDWs) and the local municipal councillors for part of the municipal governance and communication structures through public participation.

EMLM use events as a platform to interact with its communities as part of social cohesion and nation building. The events are used as platform to enhance and grow EMLM brand as a marketing tool.

2. Objective

To appoint a minimum of 01 (One) and maximum of 03 (Three) service providers to coordinate and stage high quality events management as part of the local's commitment to providing easy access to information, build relationships with communities and stakeholders, enhance social cohesion and nation building.

3. Purpose of the Terms of Reference

This Terms of Reference (TOR) provides the basis for the contracted service provider to undertake an agreed assignment to task i.e. Events Management for EMLM Executive support.

They also provide the yardstick against which the success of an assignment or terms will be measured. This will serve as the legally binding terms for contractual arrangements against which contractors, consultants and other EMLM Community members must operate.

The purpose of the TOR is to:

- Provide the rationale for the tasks that will be undertaken by Professional Service Provider for events management.
- Detail the tasks to be performed and the time frame for their completion.
- Indicate the types and categories of events to be staged.
- Set out the quality management and professional requirements of the service provider or EMLM.

4. Scope of work

The EMLM requires a quotation from professional events management service providers to stage events on behalf of the municipality.

Events management contract will entail actively working with professional service provider for the staging of all events on as-and-when basis as required by the EMLM.

The contract will be for quality events management services, i.e. which includes Mass and VIP catering service only, (from 200 people and above).
