**NB.:** Cockroach gel application (gel pump) kitchen, Termites, Wood worms or borer insects, Wasp and Bee Control, Fleas, Insect in storage areas, Silver /Fish moth, moth larvae, Bedbug treatment (per bed), Bats removal, build and install bat houses

Quotations will be requested, and a purchase order will be issued before rendering this service.

The service provider shall respond within 24 hours of being notified of an ad-hoc request, and the ad-hoc request must be resolved within 48 hours of being notified. Follow-ups on pest control services rendered shall be conducted at no cost to Ezemvelo KZN Wildlife. Ezemvelo KZN Wildlife reserves the right to decline any quotation price that is not market related and invite quotations outside the contract.
