## DETAILED TECHNICAL SPECIFICATION

### **1. COMPANY OVERVIEW**

South African Broadcasting Corporation (SABC) is a Public Entity founded in August 1936 and listed in terms of Schedule 2 of the Public Finance Management Act, Act No. 1 of 1999, as a public broadcaster in South Africa, and provides 19 radio stations as well as five television broadcasts to the general public.

### **2. BACKGROUND**

The SABC's goal is to eliminate work-related accidents and illnesses, by benchmarking Occupational Health and Safety to best practice standards, reducing risks of injury or occupational health related diseases to all employees and by ensuring their wellbeing.

The Free State has Four obsolete X-Ray machines that are stored at Bloemfontein storerooms; these machines are consuming space and that has affected the goal of reducing occupational health and safety risks in the workplace. The department do not have plans for future use, since the machines are obsolete.

The Three X-Ray machines are removed from SAHPRA (South African Health Product Regulatory Authority), and the Fourth X-Ray machine application has been submitted, and it will be removed within 30 days.

### **3. REQUIREMENTS**

**The Successful bidders will be responsible for the above-mentioned scope of works but not limited to:**

- a) Provide collection and transportation service of assets at SABC.
- b) **The service provider is required to give SABC an offer on the assets.**
- c) The appointed service provider must ensure safe removal of all radiation-emitting components
- d) The appointed service provider must ensure proper documentation of decommissioning and disposal.
- e) The appointed service provider must provide the SABC with a Certificate of Safe Disposal.
- f) The appointed service provider will work with SABC staff to compile a register of assets removed from the in order for SABC to remove the assets from the asset register.
- g) Business may be awarded to the service provider that will give a competitive offer to SABC.
- h) **Transaction should be at no cost to SABC.**
- i) Preference will be given to the service provider that will take the whole lot.
