ADDENDUM 1

BID 8/2/2/400 (2024-2027) THE PROVISION OF DOMESTIC AND INDUSTRIAL WASTEWATER QUALITY MANAGEMENT AND GREEN DROP ADVISORY SERVICE TO MIDVAAL LOCAL MUNICIPALITY FROM 1 JULY 2024 TO 30 JUNE 2027.

Bidders are to take note on changes made on the Bill of Quantities (BOQ) and adopt the amended BOQ when doing their pricing.

The following amendments have been affecting:

1. The previous BOQ had item 8 which read: Biomonitoring as per WWTP license condition as and when required. This item has been removed from the BOQ and will not be costed for as the Water Use Licenses of the purification plants are silent on the parameters that needs to be analysed for Biomonitoring. The below BOQ will have to be adopted.
2. For the purpose of costing for item 10: Borehole sampling will be done on a quarterly basis for the following parameters:
 - Fluoride (mg/l)
 - Farcac coliforms count (per100ml)
 - Nitrate/Nitrite (mg/l)
 - Phosphate (mg/l)
 - pH
 - TDS (mg/l)
