1. BACKGROUND

The South African Council for Natural Scientific Professions (SACNASP) is a registration and regulatory body for natural science professionals. SACNASP was established in 1982 through the Natural Scientists Act (No. 55 of 1982), which has subsequently evolved into the directives of the Natural Scientific Professions Act (No. 27 of 2003) (NSP Act). To date, it has 26 fields of practice, represented by 47 accredited voluntary associations (VAs). The Council represents over 16 000 registered natural scientists.

Formal quotations will be evaluated and adjudicated in terms of the 80/20 Preference Point System for Price and B-BBEE prescribed by the Preferential Procurement Policy Framework Act 2017 Regulations.
