1. Background

The SABS is a statutory body established in term of Standards Act, 1945 (Act No. 24 of 1945) and continues to operate in terms of the Standards Act, 2008 (Act No. 8 of 2008) as the national standardization institution in South Africa, mandated to:

- develop, promote and maintain South African National Standards;
- promote quality in connection with commodities; and
- render conformity assessment services and matters connected therewith.

PURPOSE OF THE TRAINING

The request for quotation aims to ensure that the SABS SCM Practitioners and Bid Committee members acquire the necessary understanding, competency and knowledge to execute SCM regulatory requirements when managing

2. Request for Quotation (RFQ)

This RFQ serves as an invitation to submit a quotation **to facilitate the bid committee training to supply chain officials and bid committee members** subject to the SABS Standard Terms and Conditions, of which a copy is available on www.sabs.co.za, accessible through the link: https://www.sabs.co.za/Procurement/proc_toc.asp

The Bidder is requested to supply its quotation, in writing, by the date specified. Should the Bidder require any clarification, the clarification should be submitted by e-mail to the Procurement Specialist identified in this document.

By submitting a quotation in response to this RFQ or participating in this RFQ process, the Bidder accepts that it is subject to and bound by all the terms and conditions contained in this RFQ document.

3. Confidentiality

This document may not be used for any purpose by the Bidder other than for developing their response to it, and all reasonable efforts must be taken by the Bidder to ensure confidentiality of any information provided. This document and any other information of a confidential nature provided to the Bidder during the course of RFQ process are and will be covered by the non-disclosure agreement to be signed between the SABS and the Bidder.

4. No Contract

Bidders shall note that this RFQ does not commit the SABS to any course of action resulting from the receipt of quotations and the SABS may, at its discretion reject any submission which does not conform to instructions and specifications which are contained herein or select a Bidder based upon its own unique set of criteria. The SABS also reserves the right not to select a bidder.

Nothing in this document shall be construed as a contract between the SABS and the Bidder, and no communication, whether verbal or written, by the SABS personnel or agents during the course of this process shall create such a contract in respect of the requirements specified in this RFQ.

5. No Obligation to Proceed

The SABS reserves the right to discontinue the RFQ evaluation process at any time and will not be responsible for any losses incurred by the Bidder as a result of discontinuance of the RFQ process

6. Validity of Proposals

The Bidder's quotation shall remain valid for a period of one hundred and twenty (120) days from the closing date. The SABS may at any time prior to the expiry of the bid validity period, extend the above validity period by sixty (60) days by written notice to the Bidders. In that event, the SABS will not require any consent from the Bidders, and bidders will not be required or permitted to amend any of their quotations.

The SABS retains the right, but is under no obligation, to request Bidders to extend the validity periods of their quotations, prior to expiry thereof, if it has already invoked the extension referred to above and it is in the SABS' interest to further extend the bid validity period. Such request shall be in writing. The Bidder is not obliged to extend the validity period. Also, bidders will not be required or permitted to amend any of their quotations.

7. Scope of Work

7.1 Objectives

SABS EXCO is implementing naming convention changes to give effect to Procurement governance structures. The SABS historically had a Cross Functional Sourcing Team (CFST) and the Tender Committee, now the change to be implemented introduces the Bid Specification Committee (BSC), Bid Evaluation Committee (BEC), and Bid Adjudication Committee (BAC). To effectively transition to these committees, it is critical that training is conducted.

The purpose of the request is to invite suitably qualified, experienced and accredited training providers to offer training to SABS officials who will serve on bid specification, evaluation and adjudication committees as well as Supply Chain Management Officials who are responsible for support functions of the Bid Committee system.

The training programme should be aligned to the basic values and principles governing the supply chain management functions as contained in the Constitution of the Republic of South Africa 1996, PFMA, PPPFA 2022 and other legislation governing Supply Chain Management in the Public Sector.

7.2 Scope of Services

- Duties, responsibilities, and mandate of bid committee members.
- Training to include current and relevant case studies to be able to demonstrate practical application on to legislation, governance and compliance approach and methodology.

7.3 Expected Outcomes and Deliverables

The expected outcomes and deliverables must be read in conjunction with the scope of services.

- Discuss the elements of supply chain management model that apply to bid committees.

- To fully understand functions of the Bid Committee members.
- Understand the regulatory framework that governs SCM within public service to demonstrate an understanding of how each legislation and/or prescript regulates the decision making of bid committess.
- Apply knowledge of the applicable regulatory framework for compliance.
- Apply knowledge of the functions of the bid committees i.e. specification, evaluation and adjudication.
- Discuss the importance of ethical conduct at all stages of the bid committee process.
- Legal and non-legal compliance.
- Understanding of a Schedule 3B public entity environment.

7.5 Requirements

- The service provider must provide the programme implementation plan detailing the specific modules/activities, specific outcomes/deliverables, training/learning methodology, required resources and specific timelines.
- The service provider must indicate the learning delivery model (hybrid solution-virtual and face-to-face learning)
- The successful bidder will be expected to design training material that will be provided to SABS staff to refer to at a later stage.
- The successful bidder will be required to send the presentation to the SABS Human Capital technical team for comment and review prior to conducting the training.
- Certificate of Competence is required after the training to all successful learners.
- The service provider must provide a project close-out report detailing further recommendations on anchoring the required skills.

Only Bidders who meet the 75% minimum threshold will be evaluated further on 80/20 preference points system of 2022. (Pricing and Specific Goal)

11. Quotation

- Transportation cost (If applicable)
- Disbursement
- Fixed price, Where foreign currencies are involved, bidders should make provision for forward cover.

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
