Introduction

1. The KwaZulu-Natal Department of Transport is faced with challenges in delivering services in terms of its mandate. The challenges are poised by a plethora of anomalies, ranging from the adverse audit findings from the Auditor-General, lack of ability to meet planned strategic objectives, lack of human resource capacity to deliver services to its customers and disproportionate allocation of work amongst employees, just to mention a few.
2. As a result of the above mentioned challenges, the Department undertook a strategic review in terms of the four broad faces which are; the review of the strategic plan, the development of a service delivery model, the development of business processes, and lastly, the review of its organization and establishment structure.
3. The organisational structure was consulted with the Office of the Premier on 08 June 2018 and the Minister of Public Service and Administration (MPSA) on 29 August 2018.

Background

4. The KwaZulu-Natal Department of Transport constitutional mandates are outlined below:
 - In terms of Schedule 4, Part A of the Constitution read with other legislation, the Department is concurrently responsible for the following functional areas of legislative competence:
 - Public transport;
 - Vehicle licensing;
 - Road traffic regulation.
 - In terms of Schedule 5, Part A of the Constitution read with other legislation, the Department is solely responsible for provincial roads and traffic.
5. The Department provides the following key services:
 - Construction of new gravel and tar road
 - Maintenance of existing roads
 - Provision of Public Transport
 - Provision of Official Fleet
 - Issuing of public transport licences or permits
 - Issuing of driving licence

- Registration of DLTC's, Registering Authorities (RA's), Manufacturers, Vehicle Testing Stations (VTS)
 - Registration and licensing of vehicles
 - Issuing of abnormal loads permits
 - Registration of title holders
 - Provision of provincial vehicles
 - Road safety education and awareness
 - Policy and planning
 - Training and development
 - Law enforcement and control
 - Traffic fine administration
 - Enforcement on operating licences
 - Job creation, and
 - Economic development
6. When the then MEC T.W Mchunu took over as the political head in 2009, he subjected the Department to a restructuring process. This was just after the former MEC had approved the organisational structure in 2008. The Ministerial Task Team (MTT) was established to ensure the development of the organisational structure in two phases. The first phase involved the development of the macro organisational structure (level 13 and above) which was approved in 2012.
7. The second phase involved the development of the micro structure (from salary level 12 and below) for alignment with the top (macro) structure. All components (i.e. managers and supervisors) were also consulted during this phase. This phase never required consultation with the Minister of Public Service and Administration (MPSA) since the first three tiers (macro structure) were already consulted.
8. In September 2015, Department of Public Service and Administration (DPSA) circulated a reviewed Organisational Design directive for implementation by Departments embarking on the restructuring process. This directive targeted any adjustment on the structure from the division level (i.e. from salary level 9 upwards). This meant that all the structures that are reviewed from a division level should be consulted with the MPSA.

9. The consultation of the proposed organisational structure with the Office of the Premier (OTP) took place in January 2018. The OTP made comments, of which were responded to, on 25 May 2018. The Consultation with the DPSA took place on 29 August 2018. On 17 October 2018, the DPSA informally responded through email to the Department with matters needing urgent attention and consideration on the proposed organisational structure.
10. During the consultation process, with the DPSA some of the comments were in favour of the Department and others not. The comments were presented to various stakeholders of the Department. However, there were no agreements on the issues which were not favouring the Departments. (A copy of comments will be made available to the successful service provider). The Department met the DPSA on 06 February 2019 to discuss comments. Since no consensus was reached at the meeting with the DPSA and most comments were on Program 1 (Corporate Services), the DPSA e-mailed a “counter offer” organisational structure for Program 1.
11. A feedback of the meeting with the DPSA was provided to the MTT on 28 February 2019. The MTT resolved that the DPSA should come to the Province to engage with the Department on the comments made. The DPSA responded by requesting the Department to put in abeyance consultation of the organizational structure pending the 6th Administration. Again, in October 2019, the Department requested a meeting with the DPSA. The DPSA responded through a formal letter signed by the Minister reiterating the comments which were made to the Department in a form of an e-mail. The letter further indicated that the Department is advised to address areas of concern and re-submit an amended organisational structure for concurrence.
12. Since March 2020 the Director-General of the province have tried without success to intervene with a view to ensuring the approval of the structure. It has taken almost 9 years for organisational restructuring in the Department.
13. In March 2021 when the new MEC was appointed, she mentioned that if road transport is to play a meaningful role as a catalyst for development and an economic enabler, it should integrate all forms of transport as road network involves land use, rail, aviation, and maritime. She also mentioned that the government has recently introduced the District Development Model (DDM) which seeks to inter alia, fast-track service delivery and integrate development and the delivery of services to citizens. The MEC clearly stated her vision on how the service delivery model and the organizational structure of the Department should respond to the call to implement the DDM.

Department of Transport in General

14. In terms of the organizational arrangement, the Department has a Head Office, Regions, Costs Centres and Area Offices.

15. The following key services are centralized at Head Office:

- Construction of new gravel and tar road
- Issuing of public transport licences or permits
- Issuing of abnormal loads permits
- Provision of provincial vehicles
- Policy and planning, and
- Enforcement on operating licences

16. The following services are decentralised to regions:

- Maintenance of existing roads
- Provision of Public Transport
- Provision of Official Fleet
- Issuing of driving licence
- Registration of DLTC's, Registering Authorities (RA's), Manufacturers, Vehicle Testing Stations (VTS)
- Registration and licensing of vehicles
- Registration of title holders
- Road safety education and awareness
- Training and development
- Law enforcement and control
- Traffic fine administration and
- Job creation.

17. The Department has three (3) recognised unions which are; Nehawu, PSA, and Poprcru. The above-mentioned unions are consulted during restructuring. Each union is represented by its Provincial Manager.

Purpose

18. The purpose of the project is to review/amend and finalize the draft organizational structure, taking into consideration the new political mandates of the 6th Administration, the new strategic focus of the Department, and comments by the MPSA.

Methodology

19. Applicants are requested to submit a detailed 6 months project plan on how they will undertake this project. The project plan must highlight deliverables, timelines, costs and how various aspects of the **project scope** will be delivered. See below.

Project Scope

20. The scope of the project is as follows:

- Alignment of the organisational structure with the new strategic focus (i.e. vision, mission, new legislative and political mandates etc.). Alignment of the organisational structure with a reviewed Service Delivery Model (SDM) and the District Development Model (DDM)
- Consideration of the MPSA comments on the organisational structure and attend to various requests received from directorates after the proposed organisational structure was consulted with the MPSA. Most requests have already been formalised.
- Develop an organisation and establishment report (i.e. business case) or amend the existing one.
- Ensure that the organisational structure is aligned to the current budget and the Medium Terms Expenditure Framework (MTEF)
- Develop an Implementation Plan.
- Consult the organisational structure with the Premier, and the MPSA in terms of the Public Service Regulations.

Project Duration

21. The project duration is 6 months from the date of appointment of a service provider.

Experience Requirements

22. The experience required is as follows:

- 22.1 The service provider must have successfully completed similar projects in the public sector institutions. At least one member should have experience in stakeholder engagement as they will be required to consult with *inter alia*, organised labour. It is critical to have the details of the projects in terms of the description and the project value, and the client organisation's reference letters.

Expertise Requirements

23. The competency and expertise are as follows:

- 23.1 There should be a minimum of 2 team members from the service provider for this project. At least one member of the team must have a 3 years diploma/degree (NQF 6) in Organisation and Work-study or Production/Operations Management or Industrial and Organisational Psychology or Organisational Development or Human Resource Management or Law or Public Administration. One member should have a 4 years degree (NQF 7) in Organisation and Work-study or Production/Operations Management or Industrial and Organisational Psychology or Organisational Development or Human Resource Management or Law or Public Administration.
- 23.2 The service provider must be able to use Visio software for graphics and indicate in which projects he/she used the software previously to develop the organisational structure.

Administrative Requirements

24. Only proposals that comply with all administrative requirements will be considered acceptable for further evaluation. Incomplete and late Proposals will not be considered. The following documents must be submitted:

- Detailed project plan
- Copies of Qualifications
- Details of similar projects, and letters of appointments
- Detailed Curriculum Vitae of each member, and
- References for similar projects
- Fully completed standard bidding / quotation documents.

Functional Evaluation

25. Only proposals that comply with paragraph 24 above will be considered during the functional evaluation phase.

26. Minimum Requirement: The minimum threshold for functionality is **60 percent** (60%) based on the average of scores awarded by the evaluation panel members. All proposals will be scored as follows against the functional criteria indicated below.
