- 1.1. **Client:** a customer or someone who receives services, in this case the client will be CENTLEC.
- 1.2. **Contractor:** a person or company that performs work on a contract basis. The term may refer to: General contractor, individual or organization.
- 1.3. **Contract:** a legal document that states and explains a formal agreement between two different people/parties.
- 1.4. **High-Mast:** a tall pole with lighting attached to the top pointing towards the ground, usually used at sites requiring lighting over a large area.





6. SCOPE OF WORK / SPECIFICATION

6.1. BACKGROUND

CENTLEC (SOC) Ltd, located in Margaung Metropolitan, is responsible for the provision of sufficient public lighting.

6.2. OBJECTIVES

The overall objective is to appoint a service provider for the effective manufacture, supply, delivery, erection, testing, commissioning of 40m RYLO type high mast lights and 20m solar mast lights, complete with luminaires and associated solar equipment. Maintenance of existing medium and high mast flood lights to CENTLEC for a period of thirty-six (36) months.

6.3. SCOPE OF WORK

- 6.3.1. The scope of work for the successful bidder will be to manufacture, supply, deliver, erect, test, commissioning, and maintenance of medium masts, 20m solar masts and 40m RYLO type high mast lights complete with luminaires and associated solar equipment within the CENTLEC area of supply. The successful bidder will be required to provide services as and when needed.
- 6.3.2. The successful bidder will obtain a registered professional at their own cost, to administer the DCP tests. The DCP test results must be handed to the CENTLEC project manager as soon as possible. The successful bidder through the manufacturer shall ensure that soil bearing pressure is adequate to avoid failure of the foundation and the mast and shall take all necessary precautions required. Full responsibility for adequate support of the HIGH MASTS will lie with the Manufacturer and successful bidder.
- 6.3.3. The successful bidder undertakes to abide by the stipulations of the relevant legislation on the execution of his duties. The successful bidder undertakes to abide by the Occupational Health & Safety Act 85: 1993 on the execution of his duties, as well as the Construction Regulations as set out in the Act.
- 6.3.4. The successful bidder will obtain at his own costs, the necessary licences, permits or consents, or any other requirements necessary for the execution of his duties, including the arrangements with Telkom, CENTLEC and Water & Sanitation for the indication of services prior to excavation. CENTLEC shall provide way leaves and as for Telkom, Vodacom, Margaung (Roads and Storm water) and other statutory services, the successful bidder is responsible for acquiring way leaves. The appointed successful bidder must take note that before any excavation is done, services must be pointed out on site by the relevant responsible party.

- 6.3.5. Damage to Council or private property / equipment or personal property due to negligence or any other reason, will be for the account of the successful bidder. The successful bidder must be insured for such damages by means of a valid insurance policy.
- 6.3.6. The successful bidder will be remunerated only after an inspection was done and the work is found to be completed according to CENTLEC`s standards.
- 6.3.7. The successful bidder must take note that all electrical networks are to be considered energized. If it is found to be unsafe to work near overhead lines or underground networks, arrangements must be made with the CENTLEC supervisor for isolation of the line (Refer to NRS 060), this isolation request must be done 3 days in advance.
- 6.3.8. Always use warning signs and traffic cones to warn and regulate traffic. Ensure the safety of the whole area and place signs in the most conspicuous areas for motorists, before execution of the work. Road closure must be arranged with the Traffic and Security Sub – Directorate and the necessary permits must be obtained by the successful bidder.
- 6.3.9. Public traffic - The successful bidder shall plan and conduct activities in such a way as to bring about the least possible disruption to the residents and public on the streets where installations are done. General layouts and details for the accommodation of traffic is provided in the South African Road Traffic Signs Manual (SARTSM), Chapter 13, 1994, Road works Signing, which shall be used on this contract.
- 6.3.10. The successful bidder must be registered at the Occupational Health and Safety Commissioner in terms of injuries which might occur at the workplace.
- 6.3.11. The successful bidder may not enter private property without the owner's consent. Where such consent is withheld the Employer / Engineer must immediately be notified.
- 6.3.12. After the excavated area is backfilled all surplus material, soil, etc., shall be removed and the area generally left in a neat and tidy condition.
- 6.3.13. Quality of works: The successful bidder shall undertake to perform all the services hereunder in accordance with the highest standards of professional and ethical competence and integrity. The successful bidder shall be responsible for the provision of materials, tools and equipment, as well as the quality and end result of the workmanships. The cost of remedying any defective works as result of negligence shall be borne by the successful bidder.
- 6.3.14. Compliance with regulations: The successful bidder shall ensure that the works and components thereof comply with Health and Safety Regulations and all other building standards that's applicable.
- 6.3.15. Liability: Nothing in these specifications shall be construed as placing the work

under the specific direction or control of CENTLEC or relieving the successful bidder from his liability as an independent contractor and, as such, the successful bidder shall be solely responsible for the method, manner and means by which the works shall be performed, including, but not limited to supervision and control of their own personnel and scheduling of the work required to insure its proper and timely performance and shall exercise due care to prevent bodily injury and damage to property in the execution of the work. The successful bidder shall restore and make good at their own expense all injuries or damages to any portion of the work before its completion and acceptance.

6.3.16. On completion of the assignment to supply a recommendations report on how to best maintain the facilities for future years.

6.4. TECHNICAL SPECIFICATION

The SANS and NRS specifications form the basic quality guidelines of the installation and serve to set the standards to which individual components as well as the complete installation must adhere to. In all cases the latest available update of the specifications mentioned applies to this contract. All material supplied must be new and undamaged and SANS mark-bearing materials shall have preference. Not all specifications are relevant to this contract, only those applicable shall prevail.

6.4.1. DESCRIPTION OF WORK

6.4.1.1. This specification has reference to 15m medium masts, 20m solar masts and 40m RYLO type high mast lighting poles and lights suitable for the use in lighting for high density housing areas.

6.4.1.2. Installation shall be generally in accordance with the latest Code of practice for the wiring of premises SANS 10142-1:2009.

6.4.1.3. Clearances to overhead lines shall be as detailed in the OHS Act (85 of 1993). During erection adequate precautions shall be taken to avoid accidental contact with overhead lines and any other structures.

6.4.2. COMPLIANCE WITH SPECIFICATIONS

6.4.2.1. Except where otherwise specified, this equipment and its auxiliaries and fittings shall comply with the following specifications and latest amendments.

- i Hot Dip Galvanizing.....SANS ISO 1461:2009
- ii Circuit Breakers – Moulded Case.....SANS 60947-2/3:2016
- iii Structural Steel.....SANS 10162-1:2011/ SANS 50025 / EN 10025:2004
- iv Welding.....SANS 1655:2011
- v Luminaries.....SANS 1279:1980/SANS 475:2006 SANS 60598-2-5

6.4.2.2. Any further requirements laid down by various statutory bodies such as Telkom.

Transnet, etc., shall also be observed when applicable such as:

6.4.2.3. Post Office Act, No.22 of 2011 and the Postmaster General Requirements issued in terms of that Act, and relevant amendments

- i The Electricity Regulation Act No.4 of 2006; and relevant amendments.
- ii The Civil Aviation Act, No 13 of 2009; and relevant amendments.
- iii The Explosives Act, No.15 of 2003; and relevant amendments.
- iv Transnet Safety Regulations.

6.4.2.4. All plant, labour, materials and equipment required to adhere to the various standards, acts and regulations mentioned above, although not necessarily detailed in the specification, shall nevertheless be provided for under this contract and shall be for the approval of the CENTLEC Project Manager.

6.4.3. POSITION OF MASTS

6.4.3.1. The successful bidder will be responsible for ensuring that each mast is installed as indicated by the drawings and site pegs. The successful bidder shall also peg out the position of the mast as if for maintenance purposes to ensure that the best locations are selected, considering topographical conditions, road crossings, telephone crossings, buildings, gates, etc. Where the successful bidder is in any doubt regarding the location shall, after having obtained the approval of the Engineer, employ the services of a registered Surveyor to obtain the correct locations. Re-imbusement for the cost of such services will, subject to granting of approval, be made from the Provisional Sum included for this purpose. Any major deviation considered necessary must be approved by the CENTLEC Project Manager.

6.4.3.2. The successful bidder may not enter private property without the owner's consent. Where such consent is withheld the CENTLEC Project Manager must immediately be notified.

6.4.3.3. Final positions are subject to approval by the CENTLEC Project Manager. Such approval must be gained prior to excavations, else the possible re-positioning of masts may be ordered at the successful bidder's expense.

6.4.4. FOUNDATIONS AND FOUNDATIONS BOLTS

6.4.4.1. A foundation plan, adequately designed with at least a safety factor of 2.5 as per SANS 10225:2012, will be submitted by the successful bidder for approval, prior to placing of order.

6.4.4.2. The foundation shall have a broad, flat, circular or square base from which a square plinth shall rise to approximately 500mm above the surrounding natural ground level.

6.4.4.3. Full details of the reinforcing steel required for the base and the plinth shall be

submitted in duplicate by the successful bidder for recording purposes prior to excavations. The design drawing of the foundation must have the name of the engineer as well as their registration number with ECSA.

- 6.4.4.4. Concrete shall have a minimum strength of 25 MPA with a curing period of 28 days.
- 6.4.4.5. At least two (2) PVC cable entry sleeves, not less than 75mm in diameter, shall be cast opposite of each other into the base from the center of the plinth through the base to a point approximately 750mm below finish ground level, towards the side of the slab, where the trench will be.
- 6.4.4.6. After casting of the foundation, the concrete slab (base) shall be covered with the removed soil and properly compacted in layers of 100mm maximum.
- 6.4.4.7. Excess soil shall in general be evenly spread around the base but may have to be removed, dependent on the site conditions, but the site shall be left neat and tidy.
- 6.4.4.8. The plinth of the foundation must be constructed in such a way, that any water will drain off (screed not permitted).
- 6.4.4.9. All reinforcing steel (base and the plinth) and mast foundation bolts shall have a minimum of 150mm concrete covering from all sides.
- 6.4.4.10. Foundation bolts must be fully hot-dip galvanized.
- 6.4.4.11. The successful bidder through the manufacturer shall ensure that soil bearing pressure is adequate to avoid failure of the foundation and the mast, and the successful bidder shall take all necessary precautions required. Full responsibility for adequate support of the high masts will lie with the Manufacturer and successful bidder.
- 6.4.4.12. Foundation bolts shall be cast in such a way that the top section of the bolts are approximately 185mm above the top of the plinth, unless required otherwise by the manufacturer of the mast.
- 6.4.4.13. Due to theft of nuts from masts, CENTLEC therefore request the manufacturer to design specialized locknuts to secure these nuts from theft. The specialized lock nuts shall be submitted for approval by the CENTLEC Project Manager.

6.4.5. MASTS

- 6.4.5.1. The design of the mast shall be adequate to resist a wind loading produced by a wind speed of at least 144km/h, measured at a height above ten meters from the ground level and acting on the projected area of the complete mast and accessories (SANS 0225:1991). Increase of wind speed with height shall be in accordance with SA Std Building Regulations.

- 6.4.5.2. The steel used for the construction of the masts should preferably be hot dip galvanized to SANS 121:2000 ISO 1461:2002. Alternatively, mast manufactured from SANS 50025 / EN 10025:2004 grade 350WA steel and galvanized will also be considered.
- 6.4.5.3. The mast shall be continuously tapered from the bottom to the top and present good visual appearance.
- 6.4.5.4. A minimum safety factor of 2.5 shall be used in the design of the masts.
- 6.4.5.5. The effective luminary mounting height shall be 15m, 20m and 40m.
- 6.4.5.6. The base plate shall be at least 40mm thick and shall be free from laminations. The welded connection to the mast shall fully develop the strength of the section and in addition supplementary gussets of adequate strength shall be provided between holes.
- 6.4.5.7. An adequate number of bolt holes with approximately 7mm total clearance to bolts, shall be provided.
- 6.4.5.8. A door opening shall be provided near the base of the mast at a convenient working height with adequate dimensions to permit clear access for the equipment mounted therein.
- 6.4.5.9. The sides of the door opening shall be proved with a fully welded reinforced steel frame to restore section modulus and to prevent buckling. The frame shall be curved at the four corners to reduce stress concentration.
- 6.4.5.10. A close fitting vandal resistant steel weatherproof door with a heavy duty lock or locking arrangement shall be provided. (Refer drawing TS-9-1).
- 6.4.5.11. Suitable steel straps for mounting of electrical control panel shall be welded into position.
- 6.4.5.12. Two suitable factory welded stainless steel or brass earth terminals shall be provided inside the mast.
- 6.4.5.13. All welding shall be grinded as necessary to give a smooth and neat appearance and then wire brushed clean prior to galvanizing.
- 6.4.5.14. All galvanizing shall be hot dip and be in accordance to SANS 121:2000 ISO 1461:2002 to give an inside and outside continuous zinc coat of minimum thickness of 450g/m².
- 6.4.5.15. No welding, drilling, punching, grinding, bending or removal of burrs etc shall be permitted after hot dip galvanizing.
- 6.4.5.16. A cable hole of at least 250mm diameter shall be provided centrally in each base plate to coincide with the cable ducts in the foundation.

6.4.6. LUMINAIRES

- 6.4.6.1. Each mast shall be provided with luminary clusters of 6 x Light Emitting Diode (LED) light fittings equivalent to a 400W and 1000 W (Watt) HPS/High Pressure Sodium.
- 6.4.6.2. The luminaires shall be of the floodlight type with a special lens. Housing shall be a solid die cast alloy aluminium (LM6) housing and appropriate lamp support assembly.
- 6.4.6.3. The luminance of each lamp shall not be less than 130,000 lumen (1000W).
- 6.4.6.4. The control gear shall be placed external to the luminaires and housed in a separate high pressure (LM6) die cast aluminium box.
- 6.4.6.5. Access to the control gear and the lamp shall be achieved without the removal of the front glass.
- 6.4.6.6. Control gear and lamp shall be suitable for operation with 240 Volt \pm 10%, 50Hz supply.
- 6.4.6.7. Each luminaire shall be adequately secured by means of adequate stainless steel bolts and nuts or other approved means.
- 6.4.6.8. All floodlight luminaires shall bear the SANS 475:2013. Edition 1.2 mark with a minimum IP rating of IP65.
- 6.4.6.9. Luminary support brackets shall be hot dip galvanized.
- 6.4.6.10. Mast mounting height 15m, 20m and 40m.
- 6.4.6.11. The calculation of the average horizontal illumination and overall uniformities must be by using a grid interval of 10m.
- 6.4.6.12. Maintenance factor 0.8.
- 6.4.6.13. All the luminaires shall be approved by CENTLEC.

6.4.7. LIGHTING LEVELS

- 6.4.7.1. All Bidders must supply a valid lighting calculation on the triangular spacing between masts method.
- 6.4.7.2. At no point between the triangular mast positions, will a value of less than 1lux be allowed on the ground level.
- 6.4.7.3. Indicate on the lighting calculations what your maximum spacing between the mast centers is; attach the actual lighting design complying with all the

requirements in the bid. In general, the high mast lights are planned for 400 m crowfoot distance between the two masts.

6.4.7.4. Isolux diagrams shall be submitted by the successful bidder for approval by CENTLEC Project Manager prior to placement of an order.

6.4.7.5. Masts shall not be considered accepted (taken over) until illumination level readings have been taken by the successful bidder, at night without the moon shining or other lighting interference.

6.4.8. ELECTRICAL CONNECTIONS AND EQUIPMENT

6.4.8.1. Each mast shall be supplied complete with all necessary electrical cables, plugs, and socket couplers, connection boxes, circuit breakers, etc.

6.4.8.2. Connection between mast base and the luminaries shall be made by means of an appropriate and suitable rated Nitril multicore flexible cable (mast light cable).

6.4.8.3. The flexible cable shall terminate in an adequately sized and completely weatherproof terminal box.

6.4.8.4. Electrical wiring between terminal box and individual light connection points shall be neoprene covered suitable UV resistant wire.

6.4.8.5. The main flexible cable shall be securely clamped before it enters the terminal box so that there is no strain on the connections.

6.4.8.6. All electrical circuits within the mast shall be protected by means of suitable moulded case circuit breakers to SANS 156:2007. Edition 3.3 Class 5kA across 3 phase 4 wire system.

6.4.8.7. In addition each mast shall have an appropriate socket outlet, fed from an earth leakage unit, fitted near the base of the mast, for use of portable service unit e.g. winch.

6.4.8.8. All electrical circuit breakers etc. shall be mounted in a suitably enclosed metal clad switchbox mounted inside the base of the mast.

6.4.8.9. All circuit breakers, isolators etc. shall be clearly labelled with engraved plastic labels.

6.4.8.10. All wiring must be marked at both ends with appropriate numbered ferrules.

6.4.8.11. All luminaries connected to a single phase shall be spaced by approximately 180 degrees.

6.4.9. DISTRIBUTION BOARD

6.4.9.1. The following equipment shall be installed in the distribution board located in the

base of masts:

- i All necessary cable glands.
- ii One 60A (5kA) three phase isolator.
- iii Three 25A single phase (5kA) circuit breakers for supply to luminaries.
- iv One 20A three phase (2.5kA) isolator earth leakage unit SANS 10142-1:2003.
- v One 16A three phase plug to enable connection of mobile maintenance equipment.
- vi One three phase 20A contactor, connected to a photo electric switch similar to Royce Thompson RTE/P14 / ripple control relay.
- vii One 20A single phase (2.5kA) isolator earth leakage unit SANS 10142-1:2003.
- viii One 16A single phase three pin plug to enable connection of mobile maintenance equipment.

6.4.9.2. Spare spaces on the distribution box for circuit breakers must be covered.

6.4.9.3. Keep a space for a Ripple Control relay as shown under Section 5 drawing number MAN-N-2. This relay will be supplied by CENTLEC.

6.4.10. MARKING OF MASTS

All masts shall be externally numbered in 20cm high black lettering (the paint shall be UV resistant), on a yellow reflecting background board, with the dimensions Height x Width (30X40) cm in accordance with the numbering allocated on the drawings. These name plates must be installed at a height of 3m above the ground level.

6.4.11. EARTHING

6.4.11.1. Two 12mm diameter earth terminals shall be factory welded in the mast. These terminals shall be made of stainless steel or galvanized.

6.4.11.2. A minimum of 4 x 1200mm long copper earth spikes shall be provided for underneath the base of the foundation before concrete is poured. These spikes must be connected with solid 70mm² bare copper conductor and both ends must terminate on the lightning earth stud in the mast with suitable lugs.

6.4.11.3. Underground joints will be CAD welded.

6.4.11.4. Supply earth connector must be totally separated from lightning earth conductor.

6.4.11.5. A lightning earth mat resistance of ten (10) Ohms or less must be achieved.

Under no circumstances will any mast be accepted if this is not achieved.

6.4.11.6. Full detail of earthing is given on drawing TS-7-9 (CENTLEC standard drawing).

6.4.12. HANDOVER

6.4.12.1. After completion, prior to handover, the complete site must be cleared of all surplus materials and the site reasonably levelled off.

6.4.12.2. Due allowance for the above must be made in the rates quoted for in the Bill of Quantities.

6.4.12.3. Before final acceptance, each mast shall be checked electrically and mechanically for correct operation and performance.

6.4.12.4. Attention is drawn to the maintenance period as detailed in the bid document.

6.4.12.5. A CENTLEC test certificate for high mast lights will be used for the testing of all the masts.

6.4.12.6. The first hand over certificate will only be issued after all the test certificates has been completed, signed and handed over.

6.4.12.7. The final hand over certificate will only be issued after an inspection at the end of the retention period.

6.4.12.8. The Certificate of Compliance (CoC) must be submitted for each mast by the successful bidder to the CENTLEC Project Manager.

6.4.13. EXCAVATION AND COMPACTION

6.4.13.1. Excavation for foundations shall remain open for the shortest period. The successful bidder shall erect and maintain guards, warning notices and lights at open excavations and soil heaps. All foundation excavations must be inspected by the CENTLEC Project Manager before the steel reinforcing is installed.

6.4.13.2. Excavations shall be classified as follows:

- i Un-pickable shall mean granite, quartzitic sandstone, slate and rock of similar or greater hardness, solid shale and boulders in general requiring the use of jack hammers and other mechanical means of excavation.
- ii Pickable shall mean rock and earth that can be loosened and removed by hand-pick and shovel.
- iii After foundation has settled, the foundation shall be backfilled and well compacted. Compactions shall be executed in layers of not more than 100mm to obtain a high

compaction density. DCP tests shall be completed by the successful bidder to prove the quality of the compaction of the soil.

- iv Mast shall not be installed in clayey soil or in swampy conditions without the necessary precautions to stabilize the installation.

6.4.14. SERVICE CONNECTION

A service connection cable (10mm² x 4 core PVC) with a separate earth conductor will be installed by successful bidder up to the foundation. The successful bidder will then, when erecting the masts have to install and connect the service connection cable from CENTLEC's LV network to the distribution board inside the masts according to NRS 016 and SANS 10142. Connection material necessary to connect the cable must be supplied by the successful bidder.

6.4.15. TECHNICAL DRAWINGS

- a. The works drawing(s) will be supplied to the successful bidder
- b. TS-7-9

7. SPECIAL CONDITIONS

- 7.1. The successful bidder will be expected to supply CENTLEC with a complete safety file within two weeks of receiving the appointment letter. The specification of this safety file is attached as Annexure 1.
- 7.2. In the event that the successful bidder(s) appoints sub-contractor, the following shall be expected:
 - a. To ensure that the sub-contractor to be appointed will be supplied with Safety Health Environment and Quality (SHEQ) specification.
 - b. To ensure that the SHEQ documentation is audited regularly for the duration of the contract.
- 7.3. The successful bidder will be expected to enter into a Service Level Agreement with CENTLEC.
- 7.4. CENTLEC reserves the right to appoint more than one bidder.
- 7.5. CENTLEC reserves the right to supply material for the works to the successful bidder.

- 7.6. The successful bidder will be remunerated only after an inspection was done and the work is found satisfactory.
- 7.7. This bid will be executed on an ad-hoc basis.
- 7.8. The successful bidder shall ensure that their employees are properly informed and trained to perform the task. All their employees, who will work on this bid, shall attend and complete, successfully, the CENTLEC SOP course at the CENTLEC Training Centre.
- 7.9. The successful bidder must be insured for such damages by means of a valid public liability insurance policy. This insurance will cover damages to council or private property due to negligence of the successful bidder.
- 7.10. The bidder shall ensure that all tasks are performed in line with applicable legislation, e.g. OHS ACT, Construction Regulations, Labour Act, Electricity Amendment Act, Electricity Supply Regulations, the Mangaung Metro Municipality By-laws relating to electricity supply and the Standard operating procedures of CENTLEC.
- 7.11. The successful bidder shall conduct a risk assessment of the work to be performed and must ensure that spares on this equipment are available in a reasonable time.
- 7.12. The successful bidder shall supply two spare LED fittings per high mast installation and deliver it to CENTLEC project manager during the handover of high masts.
- 7.13. The successful bidder shall compile and present a health and safety plan based on the risk assessment.
- 7.14. The successful bidder will be required to submit a Health and Safety File before commencing with duties. The Health and Safety file will have to meet the CENTLEC standard that forms part of this specification, and it will have to be submitted within two weeks of receiving the appointment letter.
- 7.15. The successful bidder shall inform CENTLEC of any sub-contractor they employed during the duration of the contract and shall ensure that the Health and Safety file is updated accordingly.
- 7.16. CENTLEC will carry out periodic audits at least once a month. The time frames will be agreed upon by the successful bidder and CENTLEC.
- 7.17. The successful bidder must supply power plant to supply themselves with power (400V, 3 phase) were necessary.
- 7.18. The successful bidder must train CENTLEC employees on maintenance of any

new equipment installed (transfer of skills) and submit a training schedule with details in how this training will be done.

- 7.19. The successful bidder will provide all plant, material, transport and labour required for the construction and commissioning of the replaced equipment.
- 7.20. The successful bidder must arrange for three (3) CENTLEC employees to witness all FAT test on new and refurbish equipment. This must include accommodation, catering, flight arrangements and transport.
- 7.21. The successful bidder must give notice to CENTLEC of at least 7 days prior to the FAT test date.
- 7.22. All design documentation shall be submitted with the bid document.

7.23. SITE INFORMATION:

- i Existing Services - The site conditions vary and the successful bidder needs to establish the existing services prior to site establishment. The successful bidder shall supply at their own expense, all water and electricity to the site for carrying out the installation. The successful bidder shall erect and maintain at this own expense suitable and approved temporary fencing to enclose such areas of the works to be carried out and all areas of land occupied by the successful bidder within the Site as may be necessary to implement his obligations under the Contract.
- ii Accommodation on Site - No housing is available. If required, the successful bidder shall provide all accommodation required.
- iii Ablution Facilities - The successful bidder shall provide for the duration of the contract ablution facilities on the site in the form of chemical closets for the use of personnel employed by the works. All ablution facilities provided by the successful bidder shall be efficient, sanitary and non-offensive and all sanitary fees payable to any local authority shall be paid by the successful bidder.

7.24. References - All hardware and related equipment must be upgraded or replaced in accordance to the Manufacturers maintenance requirements.

7.25. The successful bidder must pay all flight and accommodation cost for three (3) employees from CENTLEC to attend all applicable FAT tests.

7.26. All damaged and redundant equipment (related to maintenance/refurbishment) must be delivered to the supply chain stores, scrap yard. The site should be cleared of all rubble and be disposed of appropriately.

7.27. There will be twelve (12) months defects liability period on the workmanship.

7.28. A 10% retention will be withheld for twelve (12) months from the date of 1st commissioning.

7.29. Penalties (10%) will be imposed on the successful bidder, for delays and not keeping to the agreed timelines for specific phases of the project. (As per the program of works submitted).

8. PRICING DATA

- C2.1.1 The quantities set out in the specification provided are approximate and do not necessarily represent the actual amount of QUANTITIES / VOLUME to be supplied. The quantities of supplied and certified for payment will be used for determining payments due and not the quantities given in the Bills of Quantities.
- C2.1.2 The prices and rates to be inserted in the Bills of Quantities (in your bid document) are to be the full inclusive prices described under the several items. Such prices and rates shall cover all costs and expenses that may be required for the delivery of items as described, and shall cover the cost of all general risks, liabilities, and obligations set forth or implied in the documents on which the bid is based, as well as overhead charges and profit.
- C2.1.3 A price or rate is to be entered against each item in the Schedule/Bills of Quantities, whether the quantities are stated or not. An item against which no price is entered will be considered to be covered by the other prices or rates in the Bills of Quantities. A single lump sum will apply should a number of items be grouped together for pricing purposes.

11. GENERAL CONDITIONS OF CONTRACT

1. Definitions

The following terms shall be interpreted as indicated:

- 1.1. "**Closing time**" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2. "**Contract**" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3. "**Contract price**" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4. "**Corrupt practice**" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5. "**Countervailing duties**" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6. "**Country of origin**" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7. "**Day**" means calendar day.
- 1.8. "**Delivery**" means delivery in compliance of the conditions of the contract or order.
- 1.9. "**Delivery ex stock**" means immediate delivery directly from stock actually on hand.
- 1.10. "**Delivery into consignees store or to his site**" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11. "**Dumping**" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12. "**Force majeure**" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13. "**Fraudulent practice**" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14. "**GCC**" means the General Conditions of Contract.
- 1.15. "**Goods**" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16. "**Imported content**" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his unsuccessful bidders) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17. "**Local content**" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.

- 1.18. **“Manufacture”** means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19. **“Order”** means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20. **“Project site,”** where applicable, means the place indicated in bidding documents.
- 1.21. **“Purchaser”** means the organization purchasing the goods.
- 1.22. **“Republic”** means the Republic of South Africa.
- 1.23. **“SCC”** means the Special Conditions of Contract.
- 1.24. **“Services”** means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25. **“Written”** or “in writing” means handwritten in ink or any form of electronic or mechanical writing.

2. Application

- 2.1. These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2. Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3. Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1. Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2. With certain exceptions, invitations to bid are only published in the Government Bid Bulletin. The Government Bid Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za

4. Standards

- 4.1. The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information; inspection.

- 5.1. The supplier shall not, without the purchaser’s prior written consent disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2. The supplier shall not, without the purchaser’s prior written consent, make use of any document or information mentioned in GCC clause
- 5.3. except for purposes of performing the contract.
- 5.4. Any document, other than the contract itself mentioned in GCC clause
- 5.5. shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier’s performance under the contract if so required by the purchaser.
- 5.6. The supplier shall permit the purchaser to inspect the supplier’s records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights

The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

7. Performance security

- 7.1. Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2. The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3. The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
 - 7.3.1. a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - 7.3.2 . a cashier's or certified cheque
- 7.4. The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

8. Inspections, tests and analyses

- 8.1. All pre-bidding testing will be for the account of the bidder.
- 8.2. If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or successful bidder shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3. If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4. If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5. Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6. Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7. Any contract supplies may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.
- 8.8. The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

- 9.1. The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final

destination and the absence of heavy handling facilities at all points in transit.

- 9.2. The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1. Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
- 10.2. Documents to be submitted by the supplier are specified in SCC.

11. Insurance

- 11.1. The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

12. Transportation

- 12.1. Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

13. Incidental services

- 13.1. The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
- 13.1.1 performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - 13.1.2 furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - 13.1.3 furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - 13.1.4 performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
 - 13.1.5 training of the purchaser's personnel, at the supplier's plant and/or onsite, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
 - 13.1.6 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

- 14.1. As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
- 14.1.1 such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and in the event of termination of production of the spare parts:
 - 14.1.2 Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - 14.1.3 following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

- 15.1. The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.2. This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC. The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.3. Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser. If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment

- 16.1. The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
- 16.2. The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.
- 16.3. Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4. Payment will be made in Rand unless otherwise stipulated in SCC.

17. Prices

- 17.1. Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.

18. Contract amendments

- 18.1. No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.

19. Assignment

- 19.1. The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts

- 20.1. The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the supplier's performance

- 21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2. If at any time during performance of the contract, the supplier or its unsuccessful bidder(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration

and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

21.3. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.

21.4. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.

21.5. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause without the application of penalties.

21.5. Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

22.1. Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23

23. Termination for default

23.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

23.1.1 if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2; if the Supplier fails to perform any other obligation(s) under the contract; or if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4. If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

23.5. Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.

23.6. If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

23.6.1 the name and address of the supplier and / or person restricted by the purchaser;

23.6.2 the date of commencement of the restriction

23.6.3 the period of restriction; and

23.6.4 the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7. If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Bid Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

24.1. When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the successful bidder to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the successful bidder in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him

25. Force Majeure

25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

25.1. If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency

The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

27.1. If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

- 27.2. If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3. Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4. Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5. Notwithstanding any reference to mediation and/or court proceedings herein,
- 27.5.1 the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
- 27.5.2 the purchaser shall pay the supplier any monies due the supplier.

28. Limitation of liability

- 28.1. Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;
- 28.1.1 the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
- 28.1.2 the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. Governing language

The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable law

The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.

31. Notices

- 31.1. Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice
- 31.2. The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties

- 32.1. A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2. A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.

- 32.3. No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.

33. National Industrial Participation (NIP) Programme

The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.

34. Prohibition of Restrictive practices

- 34.1. In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a successful bidder(s) was / were involved in collusive bidding (or bid rigging).
- 34.2. If a bidder(s) or successful bidder(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.
- 34.3. If a bidder(s) or successful bidder(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or successful bidder(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or successful bidder(s) concerned.

12.APPENDIX: STANDARD CONDITIONS OF BID

Standard Conditions of Bid

(AS PER GOVERNMENT GAZETTE NO. 29138 OF 18 AUGUST 2006)

(As contained in Annexure F of the Standard for Uniformity in Construction Procurement)

F.1 General

F.1.1 Actions

The employer and each bidder submitting a bid offer shall comply with these conditions of bid. In their dealings with each other, they shall discharge their duties and obligations as set out in F.2 and F.3, timeously and with integrity, and behave equitably, honestly and transparently.

F.1.2 Bid Documents

The documents issued by the employer for the purpose of a bid offer are listed in the bid data.

F.1.3 Interpretation

F.1.3.1 The bid data and additional requirements contained in the bid schedules that are included in the returnable documents are deemed to be part of these conditions of bid.

F.1.3.2 These conditions of bid, the bid data and bid schedules which are only required for bid evaluation purposes, shall not form part of any contract arising from the invitation to bid.

F.1.3.3 For the purposes of these conditions for the calling for expressions of interest, the following definitions apply:

- a) **comparative offer** means the bidder's financial offer after the factors of non-firm prices, all unconditional discounts and any other bided parameters that will affect the value of the financial offer have been taken into consideration
- b) **corrupt practice** means the offering, giving, receiving or soliciting of anything of value to influence the action of the employer or his staff or agents in the bid process; and
- c) **fraudulent practice** means the misrepresentation of the facts in order to influence the bid process or the award of a contract arising from a bid offer to the detriment of the employer, including collusive practices intended to establish prices at artificial levels

- d) **quality (functionality)** means the totality of features and characteristics of a product or service that bear on its ability to satisfy stated or implied needs.

F.1.4 Communication and employer's agent

Each communication between the employer and a bidder shall be to or from the employer's agent only, and in a form that can be read, copied and recorded. Writing shall be in the English language. The employer shall not take any responsibility for non-receipt of communications from or by a bidder. The name and contact details of the employer's agent are stated in the bid data.

F.1.5 The employer's right to accept or reject any bid offer

F.1.5.1 The employer may accept or reject any variation, deviation, bid offer, or alternative bid offer, and may cancel the bid process and reject all bid offers at any time before the formation of a contract. The employer shall not accept or incur any liability to a bidder for such cancellation and rejection, but will give written reasons for such action upon written request to do so.

F.1.5.2 The employer may not subsequent to the cancellation or abandonment of a bid process or the rejection of all responsive bid offers re-issue a bid covering substantially the same scope of work within a period of six (6) months unless only one bid was received and such bid was returned unopened to the bidder.

F.2 Bidder's obligations

F.2.1 Eligibility

Submit a bid offer only if the bidder satisfies with the criteria stated in the bid data and the bidder, or any of his principals, is not under any restriction to do business with employer.

F.2.2 Cost of bidding

Accept that the employer will not compensate the bidder for any costs incurred in the preparation and submission of a bid offer, including the costs of any testing necessary to demonstrate that aspects of the offer satisfy requirements.

F.2.3 Check documents

Check the bid documents on receipt for completeness and notify the employer of any discrepancy or omission.

F.2.4 Confidentiality and copyright of documents

Treat as confidential all matters arising in connection with the bid. Use and copy the documents issued by the employer only for the purpose of preparing and submitting a bid offer in response to the invitation.

F.2.5 Reference documents

Obtain, as necessary for submitting a bid offer, copies of the latest versions of standards, specifications, conditions of contract and other publications, which are not attached but which are incorporated into the bid documents by reference.

F.2.6 Acknowledge addenda

Acknowledge receipt of addenda to the bid documents, which the employer may issue, and if necessary apply for an extension to the closing time stated in the bid data, in order to take the addenda into account.

F.2.7 Clarification meeting

Attend, where required, a clarification meeting at which bidders may familiarize themselves with aspects of the proposed work, services or supply and raise questions. Details of the meeting(s) are stated in the bid data.

F.2.8 Seek clarification

Request clarification of the bid documents, if necessary, by notifying the employer at least five working days before the closing time stated in the bid data.

F.2.9 Insurance

Be aware that the extent of insurance to be provided by the employer (if any) might not be for the full cover required in terms of the conditions of contract identified in the contract data. The bidder is required to seek adequate cover for covering liability that may ensue during the contract term.

F.2.10 Pricing the bid offer

F.2.10.1 Include in the rates, prices, and the bided total of the prices (if any) all duties, taxes (except Value Added Tax (VAT), and other levies payable by the successful bidder, such duties, taxes and levies being those applicable 14 days before the closing time stated in the bid data.

F.2.10.2 Show VAT payable by the employer separately as an addition to the bided total of the prices.

F.2.10.3 Provide rates and prices that are fixed for the duration of the contract and not subject to adjustment except as provided for in the conditions of contract identified in the contract data.

F.2.10.4 State the rates and prices in Rand unless instructed otherwise in the bid data. The conditions of contract identified in the contract data may provide for part payment in other currencies.

F.2.11 Alterations to documents

Not make any alterations or additions to the bid documents, except to comply with instructions issued by the employer, or necessary to correct errors made by the bidder. All signatories to the bid offer shall initial all such alterations. Erasures and the use of masking fluid are prohibited.

F.2.12 Alternative bid offers

F.2.12.1 Submit alternative bid offers only if a main bid offer, strictly in accordance with all the requirements of the bid documents, is also submitted. The alternative bid offer is to be submitted with the main bid offer together with a schedule that compares the requirements of the bid documents with the alternative requirements the bidder proposes.

F.2.12.2 Accept that an alternative bid offer may be based only on the criteria stated in the bid data or criteria otherwise acceptable to the employer.

F.2.13 Submitting a bid offer

F.2.13.1 Submit a bid offer to provide the whole of the works, services or supply identified in the contract data, unless stated otherwise in the bid data.


F.2.13.2 Return all returnable documents to the employer after completing them in their entirety, either electronically (if they were issued in electronic format) or by writing in black ink.

F.2.13.3 Submit the parts of the bid offer communicated on paper as an original plus the number of copies stated in the bid data, with an English translation of any documentation in a language other than English, and the parts communicated electronically in the same format as they were issued by the employer.

F.2.13.4 Sign the original and all copies of the bid offer where required in terms of the bid data. The employer will hold all authorized signatories liable on behalf of the bidder. Signatories for bidders proposing to contract as joint ventures shall state which of the signatories is the lead partner whom the employer shall hold liable for the purpose of the bid offer.

F.2.13.5 Seal the original and each copy of the bid offer as separate packages marking the packages as "ORIGINAL" and "COPY". Each package shall state on the outside the employer's address and identification details stated in the bid data, as well as the bidder's name and contact address.

F.2.13.6 Where a two-envelope system is required in terms of the bid data, place and seal the returnable documents listed in the bid data in an envelope marked "financial proposal" and place the remaining returnable documents in an envelope marked "technical proposal". Each envelope shall state on the outside

the employer's address and identification details stated in the bid data, as well as the bidder's name and contact address.

F.2.13.7 Seal the original bid offer and copy packages together in an outer package that states on the outside only the employer's address and identification details as stated in the bid data.

F.2.13.8 Accept that the employer will not assume any responsibility for the misplacement or premature opening of the bid offer if the outer package is not sealed and marked as stated.

F.2.14 Information and data to be completed in all respects

Accept that bid offers, which do not provide all the data or information requested completely and in the form required, may be regarded by the employer as non-responsive.

F.2.15 Closing time

F.2.15.1 Ensure that the employer receives the bid offer at the address specified in the bid data not later than the closing time stated in the bid data. Proof of posting shall not be accepted as proof of delivery. The employer shall not accept bid offers submitted by telegraph, telex, facsimile or e-mail, unless stated otherwise in the bid data.

F.2.15.2 Accept that, if the employer extends the closing time stated in the bid data for any reason, the requirements of these conditions of bid apply equally to the extended deadline.

F.2.16 Bid offer validity

F.2.16.1 Hold the bid offer(s) valid for acceptance by the employer at any time during the validity period stated in the bid data after the closing time stated in the bid data.

F.2.16.2 If requested by the employer, consider extending the validity period stated in the bid data for an agreed additional period.

F.2.17 Clarification of bid offer after submission

Provide clarification of a bid offer in response to a request to do so from the employer during the evaluation of bid offers. This may include providing a breakdown of rates or prices and correction of arithmetical errors by the adjustment of certain rates or item prices (or both). No change in the competitive position of bidders or substance of bid offer is sought, offered, or permitted.

Note: Sub-clause F.2.17 does not preclude the negotiation of the final terms of the contract with a preferred bidder following a competitive selection process, should the Employer elect to do so.

F.2.18 Provide other material

F.2.18.1 Provide, on request by the employer, any other material that has a bearing on the bid offer, the bidder's commercial position (including notarized joint venture agreements), preferencing arrangements, or samples of materials, considered necessary by the employer for the purpose of a full and fair risk assessment. Should the bidder not provide the material, or a satisfactory reason as to why it cannot be provided, by the time for submission stated in the employer's request, the employer may regard the bid offer as non-responsive.

F.2.18.2 Dispose of samples of materials provided for evaluation by the employer, where required.

F.2.19 Inspections, tests and analysis

Provide access during working hours to premises for inspections, tests and analysis as provided for in the bid data.

F.2.20 Submit securities, bonds, policies, etc. If requested, submit for the employer's acceptance before formation of the contract, all securities, bonds, guarantees, policies and certificates of insurance required in terms of the conditions of contract identified in the contract data.

F.2.21 Check final draft

Check the final draft of the contract provided by the employer within the time available for the employer to issue the contract.

F.2.22 Return of other bid documents

If so instructed by the employer, return all retained bid documents within twenty eight (28) days after the expiry of the validity period stated in the bid data.

F.2.23 Certificates

Include in the bid submission or provide the employer with any certificates as stated in the bid data.

F.3 The employer's undertakings

F.3.1 Respond to clarification

Respond to a request for clarification received up to five working days before to the bid closing time stated in the bid data and notify all bidders who drew procurement documents.

F.3.2 Issue addenda

If necessary, issue addenda that may amend or amplify the bid documents to each bidder during the period from the date that bid documents are available until seven days before the bid closing time stated in the bid data. If, as a result a bidder applies for an extension to the closing time stated in the bid data, the employer may grant such extension and, shall then notify all bidders who drew documents.

F.3.3 Return late bid offers

Return bid offers received after the closing time stated in the bid data, unopened, (unless it is necessary to open a bid submission to obtain a forwarding address), to the bidder concerned.

F.3.5 Opening of bid submissions

F.3.5.1 Unless the two-envelope system is to be followed, open valid bid submissions in the presence of bidders' agents who choose to attend at the time and place stated in the bid data. Bid submissions for which acceptable reasons for withdrawal have been submitted will not be opened.

F.3.5.2 Announce at the meeting held immediately after the opening of bid submissions, at a venue indicated in the bid data, the name of each bidder whose bid offer is opened, the total of his prices, preferences claimed and time for completion, if any, for the main bid offer only.

F.3.5.3 Make available the record outlined in F.3.4.2 to all interested persons upon request.

F.3.6 Two-envelope system

F.3.6.1 Where stated in the bid data that a two-envelope system is to be followed, open only the technical proposal of valid bids in the presence of bidders' agents who choose to attend at the time and place stated in the bid data and announce the name of each bidder whose technical proposal is opened.

F.3.6.2 Evaluate the quality of the technical proposals offered by bidders, then advise bidders who remain in contention for the award of the contract of the time and place when the financial proposals will be opened. Open only the financial proposals of bidders, who score in the quality evaluation more than the minimum number of points for quality stated in the bid data, and announce the score obtained for the technical proposals and the total price and any preferences claimed. Return unopened financial proposals to bidders whose technical proposals failed to achieve the minimum number of points for quality.

F.3.7 Non-disclosure

Not disclose to bidders, or to any other person not officially concerned with such processes, information relating to the evaluation and comparison of bid offers,

the final evaluation price and recommendations for the award of a contract, until after the award of the contract to the successful bidder.

F.3.8 Grounds for rejection and disqualification

Determine whether there has been any effort by a bidder to influence the processing of bid offers and instantly disqualify a bidder (and his bid offer) if it is established that he engaged in corrupt or fraudulent practices.

F.3.9 Test for responsiveness

F.3.9.1 Determine, on opening and before detailed evaluation, whether each bid offer properly received:

- a) complies with the requirements of these Conditions of Bid,
- b) has been properly and fully completed and signed, and
- c) is responsive to the other requirements of the bid documents.

F.3.9.2 A responsive bid is one that conforms to all the terms, conditions, and specifications of the bid documents without material deviation or qualification. A material deviation or qualification is one which, in the Employer's opinion, would:

- a) detrimentally affect the scope, quality, or performance of the works, services or supply identified in the Scope of Work,
- b) change the Employer's or the bidder's risks and responsibilities under the contract, or
- c) affect the competitive position of other bidders presenting responsive bids, if it were to be rectified.

Reject a non-responsive bid offer, and not allow it to be subsequently made responsive by correction or withdrawal of the non-conforming deviation or reservation.

F.3.10 Arithmetical errors

F.3.10.1 Check responsive bid offers for arithmetical errors, correcting them in the following manner:

- a) Where there is a discrepancy between the amounts in figures and in words, the amount in words shall govern.
- b) If the bills of quantities (or schedule of quantities or schedule of rates) apply and there is an error in the line item total resulting from the product of the unit rate and the quantity, the line item total shall govern and the rate shall be corrected. Where there is an obviously gross misplacement of the decimal point in the unit rate, the line item total as quoted shall govern, and the unit rate shall be corrected.
- c) Where there is an error in the total of the prices either as a result of other corrections required by this checking process or in the bidder's addition of prices, the total of the prices shall govern and the bidder will be asked to

revise selected item prices (and their rates if bills of quantities apply) to achieve the bided total of the prices.

F.3.10.2 Consider the rejection of a bid offer if the bidder does not correct or accept the correction of his arithmetical errors in the manner described in F.3.9.1.

F.3.11 Clarification of a bid offer

Obtain clarification from a bidder on any matter that could give rise to ambiguity in a contract arising from the bid offer.

F.3.12 Evaluation of bid offers

F.3.12.1 General

Appoint an evaluation panel of not less than three persons. Reduce each responsive bid offer to a comparative offer and evaluate it using the bid evaluation method that is indicated in the bid data and described below:

Method 1: Financial offer	1)	Rank bid offers from the most favourable to the least favourable comparative offer.
	2)	Recommend highest ranked bidder for the award of the contract, unless there are compelling and justifiable reasons not to do so.
Method 2: Financial offer and preferences	1)	Score bid evaluation points for financial offer.
	2)	Confirm that bidders are eligible for the preferences claimed and if so, score bid evaluation points for referencing.
	3)	Calculate total bid evaluation points.
	4)	Rank bid offers from the highest number of bid evaluation points to the lowest.
	5)	Recommend bidder with the highest number of bid evaluation points for the award of the contract, unless there are compelling and justifiable reasons not to do so.
Method 3: Financial offer and quality	1)	Score quality, rejecting all bid offers that fail to score the minimum number of points for quality stated in the Bid data.
	2)	Score bid evaluation points for financial offer.
	3)	Calculate total bid evaluation points.
Method 3: (Continue)	4)	Rank bid offers from the highest number of bid evaluation points to the lowest.
	5)	Recommend bidder with the highest number of bid evaluation points for the award of the contract, unless there are compelling and justifiable reasons not to do so.
Method 4: Financial offer, quality and preferences	1)	Score quality, rejecting all bid offers that fail to score the minimum number of points for quality stated in the Bid data.
	2)	Score bid evaluation points for financial offer.
	3)	Confirm that bidders are eligible for the preferences claimed, and if so, score bid evaluation points for referencing.
	4)	Calculate total bid evaluation points.
	5)	Rank bid offers from the highest number of bid evaluation points to the lowest.

	6)	Recommend bidder with the highest number of bid evaluation points for the award of the contract, unless there are compelling and justifiable reasons not to do so.
	7)	Score financial offers, preferences and quality, as relevant, to two decimal places

F.3.12.2 Scoring financial offers

Score the financial offers of remaining responsive bid offers using the following formula:

$NFO = W_1 \times A$ where:

N_{FO} = the number of bid evaluation points awarded for the financial offer.

W_1 = the maximum possible number of bid evaluation points awarded for the financial offer as stated in the bid data.

A = a number calculated using either formulas 1 below as stated in the bid data.

Formula	Basis for comparison	Option 1	Option 2

where:

P_m = the comparative offer of the most favourable bid offer.

P = the comparative offer of bid offer under consideration.

F.3.12.3 Scoring quality (functionality)

Score quality in each of the categories in accordance with the bid data and calculate total score for quality.

F.3.13 Insurance provided by the employer

If requested by the proposed successful bidder, submit for the bidder's information the policies and / or certificates of insurance which the conditions of contract identified in the contract data, require the employer to provide.

F.3.14 Acceptance of bid offer

F.3.14.1 Accept bid offer only if the bidder complies with the legal requirements stated in the bid data.

F.3.14.2 Notify the successful bidder of the employer's acceptance of his bid offer by completing and returning one copy of the form of offer and acceptance before the expiry of the validity period stated in the bid data, or agreed additional period. Providing the form of offer and acceptance does not contain any qualifying statements, it will constitute the formation of a contract between the employer and the successful bidder as described in the form of offer and acceptance.

F.3.15 Notice to unsuccessful bidders

After the successful bidder has acknowledged the employer's notice of acceptance, notify other bidders that their bid offers have not been accepted.

F.3.16 Prepare contract documents

If necessary, revise documents that shall form part of the contract and that were issued by the employer as part of the bid documents to take account of: a) addenda issued during the bid period,



- b) inclusion of some of the returnable documents,
- c) other revisions agreed between the employer and the successful bidder, and
- d) the schedule of deviations attached to the form of offer and acceptance, if any.

F.3.17 Issue final contract

Prepare and issue the final draft of contract documents to the successful bidder for acceptance as soon as possible after the date of the employer's signing of the form of offer and acceptance (including the schedule of deviations, if any). Only those documents that the conditions of bid require the bidder to submit, after acceptance by the employer, shall be included.

F.3.18 Complete adjudicator's contract

Unless alternative arrangements have been agreed or otherwise provided for in the contract, arrange for both parties to complete formalities for appointing the selected adjudicator at the same time as the main contract is signed.

F.3.19 Provide copies of the contracts

Provide to the successful bidder the number of copies stated in the bid data of the signed copy of the contract as soon as possible after completion and signing of the form of offer and acceptance.
