### **OUTLINE**

These Terms of Reference outline the minimum Scope of Work for which the Service Provider ( Contractor) is responsible for relocation of High Mast Light. It defines key activities and what the Contractor is responsible for delivering i.e. the required outcomes as a result of High Mast relocation and Installation.

### **BACKGROUND**

Winnie Madikizela Mandela Local Municipality falls within the jurisdiction of Alfred Nzo District of the Eastern Cape Province.

The municipality has a valid NERSA approved distribution license to the residents of Bizana. Municipality installed High Mast light in Matwebu street and Thompson Avenue with the intentions of keeping our streets safe from crime. One of the high mast light encroached someone's yard and the customer has since requested the removal of the High Mast Light. Municipality therefore has a budget to relocate the High Mast light to another position within the same area.

### **SCOPE OF WORK**

- a. Decommissioning and removal of the existing High Mast Light from the plinth
- b. Excavate and demolish existing plinth
- c. Remove rubble and dispose as per municipal refuse disposal policy.
- d. Excavate and build a new concrete plinth at an area identified by client.
- e. Backfill to the required height.
- f. Install the existing High Mast Lights on the newly built concrete plinth.
- g. Commission High Mast Light.
