Tenders must be placed in the Municipal Tender Box before 11h00 on **Friday, 13 February 2026** situated at the Supply Chain Management Offices, 11 Lind Street, Swellendam after which tenders will be opened in public. Tenders may only be submitted on the prescribed tender documents and must include a valid Tax Compliance Status **PIN** as issued by **SARS**.

Late tenders and tenders received by E-Mail or Facsimile will not be considered. Tenders will be evaluated and adjudicated in accordance with the Swellendam Municipality's preferential procurement policy and its Supply Chain Management Policy. The **80/20**-point system will be applicable. The Council does not bind itself to accept the lowest or any bid and reserves the right to accept a tender in full or a part thereof.

Pre-qualification / Eligibility Criteria:

- Bidders are required to attend the compulsory site clarification meeting.
- Bidders must obtain a minimum functionality score of 70%.
- It is estimated that bidders should have a CIDB contractor grading designation of 5GB or higher.
