1.	.1	Bids must be delivered by the stipulated time to the correct address. Late bids will not be accepted for consideration.
1.	.2	All bids must be submitted on the official forms provided—(not to be re-typed) or in the manner prescribed in the bid document. Bid pages are bound to minimise risk of lost pages.
1.	.3	This bid is subject to the Preferential Procurement Policy Framework Act, 2000 and the Preferential Procurement Regulations, 2022, the General Conditions Of Contract (GCC) with its special conditions of contract, and, if applicable, any other legislative requirements.

2. TAX COMPLIANCE REQUIREMENTS

Where circumstances justifies it, the NRF conducts interviews with shortlisted bidders for them to present further information or provide further proof to the evaluation committee. Stage 3 - Price/Preference Evaluation

Basis of fair competition:

The NRF compares each bidder's pricing proposal on an equal and fair comparison basis equitable to all bidders, taking into account all aspects of the bid's pricing requirements including the application of fair pricing tests as set out below in the section "Insufficiency of Funds".

Ranking of the bidders pricing:

The NRF ranks the qualifying bids on price with lowest priced Bid receiving the maximum points (either 80 or 90) and the remainder ranked in relation to the lowest priced bid. The NRF adds the bidders' claimed preference points as verified to the submitted preference claim form (SBD 6.1) to provide the final ranking for the award decision.

Stage 4 - Checking Tax Compliance

Stage 4A – Taxpayers Resident in South Africa

The NRF notifies the recommended bidder in writing where their tax compliance check reflects that they are non-compliant and provides the recommended bidder seven (7) working days to submit written proof from SARS of their tax compliance status or proof that they have made an arrangement with SARS to meet their outstanding tax obligations. Failure to deliver such written evidence of compliance results in the rejection of that recommended bid.

Stage 4B - Non-Resident Foreign Bidders

Where foreign bidders are submitting a bid, they complete all sections of the SBD1 especially the tax questionnaire. The NRF submit the Foreign Bidder's completed SBD1 to the South African Revenue Service to obtain from the South African Revenue Service the Confirmation of Tax Obligations letter. Where South Africa Revenue Services does not issue the letter, Stage 4A applies in clearing the reason for not receiving the letter.

Stage 5 - Award and Contract Signing

The NRF nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

The NRF, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. SCOPE OF WORK INTRODUCTION TO THE NRF

The National Research Foundation Act, Act 23 of 1998, establishes the National Research Foundation ("NRF") as the juristic person that makes this bid invitation and will contract with the awarded bidder. The Public Finance Management Act classifies the organisation as a Schedule 3A Public Entity.

CONTEXT OF THIS PROCUREMENT

The existing paved pathway has loose pavers because of the surrounding plant life, age and weathering. The asphalt surface has degraded to potholes and open patches. Both these walkways have become a tripping hazard to all NRF employees and external stakeholders. The National Research Foundation (NRF) seeks to appoint a service provider to replace the existing paving in front of the West Wing pathway and to replace the existing tar surface in the parking area of the NRF offices indicated in this bid document.

CONTRACT PERIOD

The contract period for this bid contract is for the duration of the underlying bid until completed and signed off.

DESCRIPTION OF GOODS/DETAILED SPECIFICATION

1. DESCRIPTION OF ITEMS REQUIRED

The appointed bidder will be required to replace existing paving in front of the West Wing pathway and to replace the existing tar surface in the parking area. All prospective bidders must visit the NRF to confirm the measurements of the proposed project indicated in this bid document. The appointed bidder is responsible for the disposal of all rubble resulting from the performing of the services as described in this bid document. The appointed bidder must keep all work areas clean.

1.1 Paving in front of the West Wing (±500m²)

- a) Remove the existing paving bricks and edging and cart away.
- b) Supply and Install bevel bond paver with charcoal bevel paver edge. Complete with grouting and final levelling with plate compactor. Including 5% extra pavers to allow for cutting on edges and cutting itself.
- c) Remove the existing fiber glass water feature, complete with cladding, brick and concrete platforms and cart away. x1 each.
- Remove the existing fiber glass water feature, complete with brick and concrete platforms and cart away x1 each.

1.2 Garden kerb installation (±160 m)

- a) Removal and disposal of existing edging around flower beds
- b) Supply and Installation of Garden Kerbs.

1.3. Asphalt Resurface ±150m².

- a) Remove the existing asphalt up to the base course and cart away ±150 m².
- b) Cutting locks on both ends of driveway on area with damaged asphalt.
- Excavation of one layer of existing overlay.
- d) Cover existing concrete kerbing and apply primer coat for new asphalt surface.
- e) Supply and install medium grade asphalt in sync with existing drainage.

1.4. Asphalt ramp installation ±100m² and Edging 40m

- a) Excavation of the area, removal of weeds and levelling.
- b) Supply and installation of Edging for 40meters.
- c) Supply and installation of gravel G5 and cement to reinforce the surface.
- d) Supply and installation of medium grade asphalt 25mm x30mm after compaction.

1.5. Retaining wall installation 9m x 0.5m (4.5m²)

- a) Supply and Installation of a double wall to act as a retaining wall.
- b) Leveling off the ground to reduce the sloping angle.

1.6. Bidder Requirements:

1.6.1. Bidder Previous Experience and References

a) The bidder must submit a list of two projects with contactable references where the bidder has previously successfully completed paving projects and asphalt works or the bidder can submit two signed completion certificates with contact details where the bidder has previously successfully completed paving projects and asphalt works, or the bidder must submit a minimum of two written reference letters which are signed, dated and have company letterhead with the contact details of the referee.

1.6.2. Bidder Technical Skills

- a) The bidder must submit CVs and qualifications of the professional team to be involved in this project. The qualifications must include National certificate N2 (Bricklaying and plastering) or alternatively a national certificate in Mansory construction or any relevant accredited construction related qualification.
- b) The bidder must be registered on the CIDB register of contractors and must be rated in the CIDB register at the following minimum grade: 2GB, 2CE, 2SB or higher.

1.7. Compliance.

- a) The bidder must always comply with the provisions of the Occupational Safety and Health Act, 1993 regarding the safety of equipment and material used. The appointed bidder must provide the correct personal protective equipment (PPE) to all employees performing work as stated in this bid document.
- b) The bidder must comply with the latest Construction Regulations.
- The appointed bidder must ensure that NRF operations are not hindered during the course of the project.

1.8. Quality And Workmanship

a) The longevity of paving is entirely dependent on the quality of the initial installation. The bidder must provide a 3-month workmanship warranty for repairs on all the newly installed paving surfaces as indicated in this bid document.
