1. INTRODUCTION AND PURPOSE

This bid makes provision for the supply, delivery and off-loading of firearm light with attachment, as well as a tactical light bearing holster suitable for a Glock 9mm pistol for the Tshwane Metro Police Department.

BACKGROUND / DESCRIPTION

Theft of electricity cables and the vandalization of electricity substations and wastewater treatment plants has been on the increase in the last five (5) years and the situation has worsened in recent times in the City. This is a national phenomenon and up to this stage it appears as if the hand of the authorities is cut, despite the enabling legislation to address this growing crisis.

To address this growing concern, the City of Tshwane has decisively opted to establish a Cable Theft Unit within the operational mandate of the Tshwane Metropolitan Police Department. Equipment included in this technical specification is specifically aimed at

capacitating operational members with the required resources enabling them to optimally perform their duties during night operations.

2. PROJECT SCOPE

ITEM 1. - PISTOL LIGHT WITH ATTACHMENT, SUITABLE FOR 9MM GLOCK PISTOL

The pistol light with attachment must be compatible with both the Glock 17 and Glock 19 models respectively. The pistol light must be powered by a single CR123A battery to be utilised for tactical and self defence purposes. The pistol light must weigh approximately 74 grams and must feature an ultra-bright 230 Lumen output with a flood beam bright enough for peripheral vision. The pistol light with attachment must have a mechanism to allow for quick detachment as well as the fast and secure locking of the light to a Picatinny Rail. The pistol light with attachment must be designed specifically for law enforcement.

5.4 STAGE 4 – EVALUATION OF SAMPLES

It is imperative to note: The Supply Chain Management Evaluation Committee, WILL ONLY request samples from those prospective bidders that have been identified as shortlisted bidders. These requests for the provision of samples will be extended in a formal e-mail format, by the Supply Chain Management Division, requesting that samples be provided for physical verification.

Each prospective bidder MUST provide one (1) sample,

Each sample provided as part of each prospective bidder's proposal, MUST be in its original packaging, as packaged and distributed by the manufacturer. These samples will be made available free of charge to the City of Tshwane: Metro Police Department.

The Chief of Police will nominate capable personnel from the Tactical Policing Operations to assist the Evaluation Committees with the visual screening of submitted samples and the subsequent evaluation and verification of those samples.

- (e) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003) as amended by Act No 46 of 2013;
- (f) **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- (g) **“consortium or joint venture”** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- (h) **“contract”**Error! Bookmark not defined. means the agreement that results from the acceptance of a bid by an organ of state;
- (i) **“EME”** means an Exempted Micro Enterprise as defines by Codes of Good Practice issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (j) **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- (k) **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- (l) **“non-firm prices”** means all prices other than “firm” prices;
- (m) **“person”** includes a juristic person;
- (n) **“QSE”** means a Qualifying Small Enterprise as defines by Codes of Good Practice issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (o) **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- (p) **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- (q) **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- (r) **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- (s) **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

- 5.2 A bidder who qualifies as an EME in terms of the B-BBEE Act must submit a sworn affidavit confirming Annual Total Revenue and Level of Black Ownership.
- 5.3 A Bidder other than EME or QSE must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.

- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary Institutions and Public Entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
- 5.8 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.

CERTIFICATE OF INDEPENDENT BID DETERMINATION
