1. INTRODUCTION

Eskom is currently looking at the feasibility of locating a 1200MW mid-merit CCGT plant, at sites proximate to the Port of Saldanha. Therefore, Eskom seeks the gas supply, timing for delivery of first gas, shipping/piping/rail/road logistics, and gas pricing information, for supply of LNG to Saldanha to determine the feasibility.

2. SCOPE OF THE RFI

The scope of this RFI is as follows:

- To provide details of your experience handling and supplying LNG in South Africa or internationally.
- To provide details on LNG availability, and the associated supply volumes to match stated plant design basis.
- To provide LNG specification, to cross reference to gas turbine requirements.
- Where applicable, to provide details on whether the necessary permitting is on hand to ship LNG to ports closest to mentioned power stations.
- To get an estimated price in \$/GJ or ZAR/GJ, for the delivery of LNG.

3. SUBMISSION GUIDELINES
