Technical specifications: Refurbishment of Helminthology Laboratories 1 and 2 on the ARC-Onderstepoort Veterinary Research campus.

2. Compulsory requirements

NB: Failure to submit the above-mentioned required information together with the bid document on the closing date will result in the contractor's bid to be rejected.

3. General specifications

- This project is classified as General Building and requires installation of specialised furniture/equipment.
- The service provider must have a CIBD 2 GB rating or higher for General Building.
- The service provider must specialise in and have a proven track record of the installation and refurbishment of laboratories.
- All steelwork to be first treated with a phosphating process and then finished with a baked epoxy powder coating. Colour of frame to be approved by ARC-OVR.
- The 32mm Powder epoxy coated mild steel frame work must be assembled with bolt and nut (NOT welded frames).
- Frame work must be able to carry a load of 250 kg per module.
- Under bench cabinets of powder epoxy coated mild steel; 0.8mm gage sheet metal for body, doors, shelves and drawers.
- Polyurethane handles for installed cabinets.
- Heavy duty stainless steel hinges and runners for installed cabinets.
- Cabinets must be installed under work top with sliding mechanism and bolts.
- 15mm Fundermax phenolic resin tops that are resistant to all chemicals and acids, heat resistant up to 220°C must be used for bench tops and other work tops.
- Colour of 15mm Fundermax phenolic resin work tops and Floorworx vinyl floor to be confirmed by ARC-OVR.

- Remove existing worktop, including basin, from wooden cabinets on western wall. In its place install the following:
 - 2830mm x 600mm 304 Stainless steel top (Franke) with 600mm x 400mm x 300mm pot sink and 200mm splash back
- Install an Arboles cold water tap with removable nozzle for the pot sink.

 - b. Only bidders that claim specific goals will be considered for scoring on the 20 points as per the 80/20 principle.
 - c. Completed and signed Standard Bidding Documents (SBD) forms included in the bid document.
8. The above specified goods/services should be delivered / rendered to the ARCOnderstepoort Veterinary Institute at above-mentioned delivery address.
9. The particulars of the guarantee that will apply to the goods quoted for, with the particular regards to the period and extent of the warranty must be clearly stated. Where services are required, service providers must submit documentation pertaining the relevant experience.
10. Your written quotation must be emailed depending on the instructions given in the email or advert.
11. All price quotations that have a rand value of R 2,000.00 to below R 50,000,000.00, including VAT, will be evaluated by applying the 80/20 principle as prescribed by the Preferential Procurement Policy Framework Act 5 of 2022 and its Regulations.

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
