1. BACKGROUND

Agrement South Africa (ASA) is an entity of the Department of Public Works and Infrastructure responsible to undertake the technical assessment and issuing of fit-for-purpose certificates for non-standardised construction products. These are the official terms of reference (TORs) commissioned by ASA for the appointment of a service provider to perform a B-BBEE verification for ASA.

2. INVITATION FOR PROPOSALS

These terms of reference are intended to provide a scope of work and deliverables to appoint BBBEE verification agency to compile a balance score card, do the required verification in relation to the BBBEE for a period of 36 Months.

Please note the following regarding ASA:

- ASA is a schedule 3A public entity reporting directly to the DPWI.
- Currently have 40 employees.
- This will be the first time we get verified as an entity.

3. SCOPE OF WORK

The appointed service provider will be expected to perform the following services as duties and responsibilities:

Verification of ASA's B-BBEE status'	Project plan on how to implement the verification services of the ASA's BBBEE status
Generation of verification certificate confirming B-BBEE status and recognition	ASA BBBEE certificate

The provision of BBBEE verification services will address the following B-BBEE verification services phases:

3.1.1. Understanding the ASA operating model and context

3.2. Execution

3.2.1 Project plan on how to implement the verification services of the ASA BBBEE status

Implementation of the BBBEE verification service.

3.3. Reporting

3.3.1 Provide a BBBEE certificate confirming ASA's status and recognition level.

3.3.2 Provide a status on gaps identified during the assessment.

3.3.3 Provide a report on the ASA's B-BBEE compliance status

4. TIMING AND DELIVERY

The project will run from appointment of the service provider for a duration of the project. The expected delivery date - will be communicated once the service provider is appointed.

5. SUBMISSION OF PROPOSALS AND QUALIFYING CRITERIA

- Pre-qualification criteria (failure to follow below criterion will result in disqualification)
 - a) Potential service providers must ensure that they are registered on the National Treasury Central Supplier Database (CSD).
 - b) All Supply Chain Management compliant (required) documents have been submitted. These include SBD 4, 6.1, 8 & 9 and General Conditions of Contract.
 - c) Price/quotation (Amount must include all taxes)


