T1.1 Tender Notice and Invitation to Tender

Tenderers are hereby invited for The Upgrading of the Bulk Sewer Pump Station, Gravity Lines and Rising Main in Laingville, Saldanha.

CIDB:

Tenderers must be registered with the CIDB in a CE class of construction works and have a grading designation equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with regulation 25(7A) of the Construction Industry Development Regulations, 2004. It is estimated that tenderers will need a CIDB grading designation of 7CE or higher.

Local Content is applicable to this tender and the bidder must adhere to the requirements as per the MBD 6.2 in the tender document.

Tenderers must be registered on Central Supplier Databases as described in the tender conditions.

Tenderers who are not registered on the Central Supplier Databases are not precluded from submitting tenders, but must however be registered upon being requested to do so in writing and within the period contained in such a request.
