1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) **“price”** means an amount of money tendered for goods or services and includes all applicable taxes less all unconditional discounts.
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes.
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 12 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

2. OVERVIEW

Iziko invites suitably qualified service providers to submit a bid to provide the following services as detailed in the Scope of work at the various Iziko sites.

3. SCOPE OF WORK FOR IZIKO SITES LISTED

- Pruning, trimming of trees and hedges.
- Mowing and trimming of lawns
- Watering of lawns and flower beds
- DE weeding lawns and flower beds
- All flower bed's soil to be regularly turned
- Remove all dead flowers/ plants from plant and flower beds
- Remove all Hedera/Ivy plants and spray with weed killer
- All fallen tree trunks and branches must be removed off site
- Applying weed killing agents on paving and anywhere else that it may be required after removing weeds manually
- All paving and channels to be swept cleanly
- Replanting scrubs and plants when required
- Cutting trees where required.

- A cherry picker to be use where required when working at heights
- Clearing of vegetation, trees and grass.
- Remove all waste from site (At Contractor's expense)
- Rotational monthly site schedule:
 - a) SA Museum x 2 days
 - b) SA National Gallery and Annex Parking x 2 day
 - c) Rust & Vrugd x 2 Days
 - d) Betram House x 1 days
 - e) Old Town House Courtyard x 0.5 day
 - f) Slave Lodge Courtyard x 0.5 day
 - g) Other sites as required and advised by Iziko
