- 1.5. Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6. The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **tender** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **price** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **rand value** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **tender for income-generating contracts** means a written offer in the form determined by an organ

of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

- (e) **“The Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/documentation stated in the conditions of this tender;
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of –

1. BACKGROUND IZIKO

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

2. SPECIFICATION

The Iziko Museums of South Africa intends to source and procure require a high-end multimedia handheld guide device for museum visitors, capable of delivering rich digital interpretation including audio, text, images, video, interactive content, and location-based experiences. The device must combine smartphone-level performance with the robustness, durability, and device management capabilities required for intensive public museum use. Devices will be used in permanent and temporary exhibitions, including historic house museum environments.

3. . SCOPE OF SERVICE

The required Multimedia Guide Device must meet the following minimum requirements:

High-end multimedia touch guide device (such as Orpheo Touch or equivalent) supporting Audio commentary, Text content; High-definition images; Video playback; 3D models and reconstructions; Augmented Reality (AR) content; Virtual tours; Indoor and outdoor geo-located maps; Video synchronization with external displays or systems

- Smartphone-class performance with dedicated audio guide robustness
- Touchscreen interface suitable for intuitive visitor navigation
- Display Size $\pm 6.4''$ high brightness display; $\pm 1080 \times 2400$
- System: Android ± 12 or equivalent; CPU ± 2.4 GHz or equivalent; Internal storage ± 128 GB; RAM: ± 6 GB; Expandable storage via microSD card
- Size $\pm 19 \times 7.7 \times 1.7$ cm; ± 196 g
- Integrated camera approximately ± 64 MP with autofocus
- Integrated sensors including, Accelerometer, Gyroscope (essential for AR capability) & Ambient light sensor
- Wireless connectivity including GPS; Wi-Fi (including ± 5 GHz); Bluetooth (version ± 5.1 or equivalent)
- Minimum one stereo headphone output (3.5 mm jack or equivalent). Support for spatial, AR, or binaural audio formats
- Accessibility: Induction loop / hearing loop compatibility for hearing aids users; Audio description support, Lanyard attachment points; Voice-over and screen-reader support

Device Management and Software

- Remote device fleet management software (EMM or equivalent) for Device monitoring; Content distribution; Batch configuration; Usage tracking

- Content Management System (CMS) for creating and editing tours and multimedia content

Charging and Power

- Li-Ion ± 5000 mAh Battery, capable of ± 18 hours continuous use; Fast charging capability (approximately ± 3 hours to full charge); Battery optimization system to extend battery lifespan; Minimum performance retention after ± 500 charge cycles
- Charging Infrastructure: Multi-slot charger (minimum ± 16 slots per unit); Secure mechanical connection for charging (to prevent theft or misplacement);

Safety and Durability

- Shock-resistant casing, weather-resistant and fire-resistant housing suitable for museum use
- Built-in protections for:
 - Temperature
 - Short circuit
 - Overvoltage
