SECTION 3.1: FUNCTIONALITY EVALUATION CRITERION

Only five (5) Civil Contractors per CIDB Category (2CE, 3CE and 4CE or higher) will be appointed who obtain over 70 points and above will be appointed for a period of 36 months as and when required.

(a) Reference Scoring: A maximum of 100 points will be awarded at the sole discretion of the Municipality's Bid Evaluation Committee based on the information provided and will be split as follows

3. Plant and Equipment	20
4. Staff and Key Personnel	20

Criteria will be evaluated as follow:

1. Company Experience: (Tenderers to provide a company profile to support experience claimed)
