1. PURPOSE

The purpose of this Request for Quotation (RFQ) is to invite quotations. KwaZulu-Natal (KZN) Growth Fund Agency seeks to appoint an External Audit service provider for three years to perform audit services to KGF Capital (Pty) Ltd, Fund Manager established under the En-commandite Partnership agreement entered into with the Public Investment Corporation. To Audit the (2025 - 2027 financial year) on behalf of the KwaZulu-Natal (KZN) Growth Fund Agency.

2. BACKGROUND

Kwazulu-Natal Growth Fund Agency (KZNGFA) is an Agency, established and capitalised by the Provincial Government to provide debt and equity. The main objective of the KZNGFA is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

2.1 Procurement Philosophy

It is the policy of KZNGFA, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development and support of businesses from disadvantaged communities (small, medium, micro enterprises, as well as established businesses within those communities) in terms of its BEE Policy;
- b) The promotion of national and regional local service providers and agents before considering overseas service providers and;
- c) The development, promotion and support for the moral values that underpin the above, in terms of KZNGFA Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KZNGFA.

The KZNGFA wishes to engage with service providers who are equally committed to maintain high quality services and better pricing.

2.2. SUPPLIER DUE DILIGENCE

- 2.2.1 KZNGFA shall be entitled at all times to conduct bidder due diligence for short listed bidders prior to final award or at any time during the contract period. This may include site visits if applicable.
- 2.2.2 KZNGFA reserves the right to request the successful bidder and its staff to undergo a security vetting and/or credit vetting processes via external services providers such as Credit Bureaus and the South African Police Services. By submitting a bid proposal, the bidder gives explicit approval for KZNGFA to conduct such vetting requirements, if and when required.

3. SCOPE OF SERVICES REQUIRED

On 4 February 2020, KGF Capital (Pty) Ltd became authorized by the Financial Sector Conduct Authority ("FSCA") to be a financial services provider ("FSP") in terms of the Financial Advisory and Intermediary Services Act ('FAIS').

FAIS Act states that financial statements must be submitted by an authorized financial services provider to the registrar not later than four months after the end of the providers financial year end being 31 March 2026.

KGF Capital (Pty) Ltd seeks to appoint an External Audit Service Provider for three years where the objectives of the appointment are to:

- To carry out a financial audit and express an independent opinion on whether the financial statements prepared by the KGF Capital fairly present the state of affairs of the entity
- Assurance in respect of:
 - I. Money and assets held on behalf of clients
 - II. That such money and assets are kept separate from those of the business of the entity and report any non-compliance identified in the audit to the registrar (Section 19-FAIS Act)
- Report any irregularities or suspected irregularities identified in the course of the audit to the registrar (Section 19-FAIS Act)
- In the event of the auditor's services being terminated by the provider, submit a statement to the registrar setting out what the auditor believes to be the reasons for the termination of the auditor's appointment (Section 19-FAIS Act) and
- Enquire of the FSCA whether the provider is exempt from the provision of section 19 or exempt from the Act (Section 19-FAIS Act).

4. CONTRACT DURATION

Contract duration 36 months

5. AWARD OF THE RFQ

KZNGFA is not obliged to accept and award this RFQ to the lowest bidder or any other bidder.

Selection will be conducted over three stages as detailed below:

6.1 STAGE 1 – COMPLIANCE WITH MANDATORY REQUIREMENTS

All bids duly lodged as specified in this RFQ will be examined to determine compliance with the mandatory requirements and conditions. Failure to provide any mandatory information as requested above will result in the submission being deemed non-responsive

6.2 FUNCTIONALITY EVALUATION

Scores will be tabulated to 50 points. Respondents must score 35 points and over to be assessed on their financial offer and preference score.

6.2.1 Proposals will be subject to an evaluation based on an 80/20 - 80 points for price and 20 points for specific goals.

Where

Ps = Points scored for price of tender under consideration

Pt = Price of tender under consideration

Pmax = Price of highest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
