The South African National Roads Agency SOC Limited (SANRAL) invites tenders for the provision of consulting engineering services for the detailed design review, administration and construction monitoring for the upgrade of National Route 2 Section 25 between Isipingo Interchange (km 0.75) to Higginson Highway (km 6.10). This project is in the province of KwaZulu-Natal and in the district municipality/local municipality of eThekweni and the approximate programme is for design and construction documentation to be completed by January 2023, followed by supervision of 39 months, commencing October 2023.

Preferences are offered to tenderers who comply with the criteria stated in the Tender Data.

Only tenderers with a B-BBEE contributor status level of 1, 2, 3 or 4 and who are registered on the National Treasury Central Supplier Database at the tender closing date are eligible to tender.

It is a requirement of this project that the tenderer sub-contract a minimum of thirty percent (30%) (of the work to Targeted Enterprise(s) as defined in the Contract Data.

Joint Ventures (JV) will be allowed on condition that one JV partner is a Targeted Enterprise. The JV partner will, however, not contribute to sub-contract target for Targeted Enterprises.
