**Evaluation criteria:** The evaluation of the bids will be conducted in three (03) stages namely:

**Stage 1:** Bidders that do not meet the **Administration compliance** (Compliance with mandatory and other bid requirements will not be eligible for further evaluation and will be deemed as non-responsive

**Stage 2:** Evaluation in terms of the stipulated minimum threshold for local production and content.

- Only locally produced services or goods or locally manufactured goods with a stipulated minimum threshold of 100% for Textiles, Clothing, Leather and Footwear for local production and content will be considered.
- The exchange rate to be used for calculation of local production and content must be the exchange rate published South African Reserve Bank (SARB) 12H00 on the date of the advertisement of the bid; and
- Only the South African Bureau of Standards (SABS) approved technical specification number SATS 1286:2011 must be used to calculate local content.
- Only bids that achieve the minimum stipulated threshold for local production and content may be evaluated further.

The stipulated minimum threshold percentages for local production and content for the sector is 100%.

**Stage 3:** Evaluation in terms of the 80/20 preference point systems prescribed in Preferential Procurement Regulations

Price=80 points, B-BBEE=20 points. Bidders are required to submit an original or certified copy of B-BBEE certificate to claim preferential points.
