## **SPECIFICATIONS OF GOODS REQUIRED**

### **1. Background**

uMngeni -Uthukela Water is requiring services for the supply and delivery of various construction stones to various sites of Umngeni- Uthukela Water within the inland region/UMgungundlovu District area of Supply.

There are no existing meters on this point. Umngeni Water needs to be able to measure flow volumes to its customers. The inlet to the raw water tank at Ixopo cannot be operated effectively because Umngeni Uthukela Water cannot measure what the node is consuming.

### **2. Description of goods/ services required**

The scope involves the supply and delivery of

- Dolerite Gabion Rock fill
- Dump Rock
- Concrete aggregate/19 mm stone
- Crusher Sand
- 

### **3. Extent of the services**

- Delivery to the various site travel cost based on a rate per kilometer using 6 m<sup>3</sup>, 10 m<sup>3</sup> and 20 m<sup>3</sup> trucks

#### **G5 Gravel Material**

- **Grading Requirements:** The material shall have a maximum dimension not exceeding sixty three millimetres (63 mm) for uncrushed material after compaction and fifty three millimetres (53 mm) for crushed material, before compaction. The total percentage by mass passing the two comma nought millimetre (2,0) sieve shall preferably not be less than twenty (20) nor more than fifty (50). The latter value may be allowed to reach sixty five (65) percent for supply only (constraint seventy {70} percent after compaction) where so indicated in the Project Specification or agreed to by the Materials Engineer (typically applicable to calcrete, weathered granite, weathered dolerite)

#### **Gabion Rock Fill/stones**

- dolerite gabion rock fill material to be used with hexagonal woven double twist Type 80 mm mesh gabion basket, River /Reno mattresses, foundations and stone pitching.

- Dolerite rock fill material to be used for stone pitching, landscaping and road works. The dolerite rock must be un-weathered and solid without flaking or weathering evidence. The rock sizes should be 70 – 150 mm
