Appointment of a Service Provider for the Preparation & Updating of GRAP Compliant Assets Register for a period of 36 Months

Bids are hereby invited from service providers for **BTO 03 2023-2024**. Bidders must be registered on the Central Supplier Database.

NB: Bids will be evaluated in terms of 80/20 preference point system as prescribed in the Preferential Procurement Policy Framework Act and Preferential Procurement Regulations of 2022 where 80/20 points system will be applied wherein 80 points are for price and 20 for specific goals and for this purpose the enclosed forms must be scrutinized, completed, and submitted together with your bid. The tender validity period is 90 days after the tender closing date.

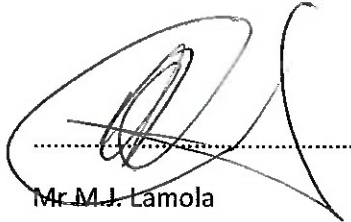

Bidders will be required to produce proof of the deposit before they will be issued with a bid document.
