1. PURPOSE

The purpose of this RFQ is to appoint a suitable service provider who will provide Audio-Visual Services for the 2023 Kudu Awards to be held on the 30th of November 2023, for 400 guests, in Gauteng.

2. BACKGROUND

South African National Parks (SANParks) is a public entity, established under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003), with the mandate to manage national parks and other defined protected areas. As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs.

The Parks under the management of SANParks are divided into 6 regions:

3. SCOPE OF WORK

The event will be held on 30 November 2023, at a venue in Gauteng. The bidder is required to complete the setup of all equipment the day before the event (29 November 2023); and do a soundcheck on the day of the event.

The specifications and requirements of the audio-visual services are as follows:

PRODUCTION

- Pre-Event Production – interviews pre-recording and crew cost
- Production and design of an opening 3-minute video montage (SANParks will provide content)
- Post-Production – a copy of the edited video of the entire production.

VIDEO CAMERAS/RECORDING/LIVE STREAMING

- Video and Audio recording of the entire event (prior; during and after until mid-night)
- Supply of minimum of three (03) cameras to record the proceeding of the event
- Live Streaming of the event on SANParks Facebook page and YouTube Platform

STAGE

- Supply the stage and stage setup (10m by 5m with universal access ramp)

LIGHTING

- Stage and Room Lighting (Ambient lighting, lighting for speakers, etc.)

SOUND-SYSTEM

- PA system sufficient for a 400-seater room, including:
 - 1 X podium microphone (on stand)
 - 4 X wireless hand-held microphones
 - 4 X Lapel microphones **or** headset microphones.
 - Stage Monitors, backline, etc.

CREW/OPERATORS

- Crew must include all necessary personnel to provide the services as required, i.e. cameramen, director, sound-operator, stage-builder, lighting technician/operators, riggers, etc.)

SCREENS/PROJECTORS

- Supply of two (02) led/plasma screens (TV) (Minimum size - 55 inch)
- Supply three (03) projectors with projection surface/screen or LED screens to play the live proceedings of the event (situated on left, right and centre of the room)
- Podium with digital screen to display SANParks logo

PHOTO-BOOTH

- 360-degree slow-motion photo-booth, with adjustable stand

4. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.


