TENDER SPECIFICATIONS

1. PURPOSE OF THE TENDER

The purpose of this tender is to source the services of a suitable service provider for the supply, rental, placement, servicing, and maintenance of Portable non flushing chemical toilet units within each of the pre-specified informal settlements with the disposal of the sewerage at the Wastewater Treatment Works or alternative site identified by Municipality's official or representative.

2. INTRODUCTION AND BACKGROUND

The George Municipality is mandated to provide efficient sanitation infrastructure to Informal Settlements. The scope of work comprises the supply and cleaning of portable non-flushing toilet units using mechanical cleaning methods as required by George Municipality on a regular basis and the provision of toilet paper with each service. Portable non-flushing chemical toilet units need to be supplied to various informal settlements in George to address basic sanitation needs of the community. A price per toilet needs to be provided for this tender as the number of toilets per settlement will only be determined after award. These toilets need to be serviced, cleaned, and maintained at regular intervals.

3. GENERAL IMPORTANT INFORMATION FOR ALL PORTABLE TOILETS:

Interested service providers need to provide pricing for the following:

- a. Hire, delivery and collection of chemical toilets in the George Municipal Area.
- b. Servicing and maintenance of chemical toilets at the frequency specified after **the final award (dependent on budget availability)** and the provision of 5 toilet rolls per toilet per service.
- c. Portable toilet units **must** be anchored to their identified site on a level surface. If the toilet cannot be anchored, the reason in writing must be provided.
- d. One (1) portable unit will serve approximately five (5) families or informal houses and must be allocated as such.

- e. The units must be lockable to be allocated to certain groups of users. Each unit must have **five (5) sets** of keys which must be handed over to the specific group who will be using the specific toilet once the toilets have been placed.

4. IMPORTANT ADDITIONAL INFORMATION

- 4.1 It is the service provider's responsibility to ensure that these toilets are cleaned and maintained on a regular basis for hygienic reasons and in terms of service delivery standards required.
- 4.2 All costs (labour, material, transport, maintenance, servicing, municipal dumping fee, etc.) must be included in the prices provided. Escalation of costs will be allowed during year 2 and 3 of the tender period. Tenderers must submit requests for escalation and provide proof of the escalation of prices for line items.
- 4.3 The cost of dumping of the effluent waste is for the account of the service provider, and this should be taken into account when tendering.
- 4.4 The tenderer must provide the necessary dumping certificates as required by George Municipality after the commencement of the service.
- 4.5 Only one service provider will be appointed. An alternative bidder may be appointed.
- 4.6 Vandalism complaints to be attended to by the service provider and suitable maintenance actions taken within 24hours of complaint being sent.
- 4.7 The service provider should note that George Municipality does not accept any responsibility for vandalized or stolen toilets. **Service provider must ensure their products and remove and replace vandalized toilets at their own cost.**
- 4.8 The service provider will be required to collect chemical toilets within 48 hours after receiving notification from the George Municipality that such toilets are no longer required. Failure to collect chemical toilets within 48 hours after notification will result in non-payment of the monthly hiring and maintenance fee as tendered.

The rates supplied will be fixed for year one and escalation will be allowed for years 2 and 3 of the contracts. All costs (labour, dumping, material and transport) must be included as per the pricing schedule.

TENDERERS WHO ARE NOT THE DIRECT SUPPLIER OF THE PRODUCT MUST ATTACH A WRITTEN AGREEMENT FROM THEIR SUPPLIER CONFIRMING THAT AN AGREEMENT EXISTS BETWEEN THEM TO DELIVER AND COLLECT THE PRODUCT AS INDICATED.” IF SUCH AGREEMENT IS NOT ATTACHED YOUR TENDER WILL NOT BE CONSIDERED FOR EVALUATION.

5. TOP STRUCTURE SPECIFICATIONS FOR A NON-FLUSH PORTABLE TOILET:

- 5.1 Portable toilet with a sturdy structure of at least 900mm wide by 900mm deep and 2.1m high with a secure floor and a door that is able to close and lock from both the inside and outside with a suitable latch with an emergency release facility.
- 5.2 There must also be an indication that the unit is in use.
- 5.3 Suitable ventilation, including a built-in vent pipe from the waste tank.
- 5.4 The interior floor, walls, ceiling, and doors of each unit shall have a finish that can be easily cleaned and sanitized.

6. TOP STRUCTURE SPECIFICATION FOR A NON-FLUSH PORTABLE TOILET FOR PERSONS WITH DISABILITIES

- 6.1 The preferred facility is a separate unisex toilet facility.
- 6.2 The size of a toilet unit shall be at least 1700mm x 1600mm, with a door that shall open outwards to accommodate a wheelchair.
- 6.3 There must also be an indication that the unit is in use.
- 6.4 Suitable ventilation, including a built-in vent pipe from the waste tank.

- 6.5 The interior floor, walls, ceiling, and doors of each unit shall have a finish that can be easily cleaned and sanitized.

7. THE SERVICE

- 7.1 The successful Service Provider will be on implementation of the contract, to roll out the required toilet units, and implement servicing schedules.
- 7.2 The maximum lead time, for commencing the contract, will be **one (1) month** after receipt of an official appointment notification.
- 7.3 The appointed Service Provider will be required to have all resources (labour and equipment) in place prior to site handover.
- 7.4 In addition, the appointed Service Provider will also be required to familiarize themselves with the areas to be serviced, together with the support of community representatives and council officials, to verify the location of all service points within each area.

8. SERVICING INSTRUCTION

- 8.1 Units must be serviced, cleaned, sanitized, and left in a hygienic condition for the targeted informal settlement users.
- 8.2 Should new areas be identified for servicing, these may be added to the contract, or existing ones may be removed, all at the discretion of the Municipal official or representative.
- 8.3 It would be required that should additional areas be added to the contract that it be serviced at the same tendered rate.
- 8.4 The attention of Service Providers is particularly drawn to the high standard of service applicable to this Contract.

9. SERVICING PROCEDURE

- 9.1 Extract full/dirty waste tank unit with vacuum (suction) tanker within the targeted Informal Settlements.

- 9.2 Recharge (filled) the portable non-flushing toilet waste container unit with approved chemical product.
- 9.3 Transport waste toilet matter to designated waste disposal site or alternative site identified by Council's representative.
- 9.4 Clean the toilet structure inside and outside should there be any raw spillage.
- 9.5 Team Leader and Municipal Official to conduct a survey every 2 months to verify the number of toilet units in the field.

10. TREATMENT AND DISINFECTING

- 10.1 After each service/cleaning cycle of toilet unit is complete, each cleaned empty waste container unit must be recharged/refilled with SABS approved chemical product.
- 10.2 The chemical is to inhibit faecal odours and assist breakdown of solids and have no deleterious effect on the efficient working of the receiving Wastewater Treatment Works, as well as the safety of users.
- 10.3 The approved chemical product to be provided should be capable of the following:
 - Cleaning agent,
 - disinfectant agent,
 - odour control,
 - fly breeding control and
 - must be a homogeneous product.
- 10.4 The above chemical product must be approved for domestic purposes.

11. WASTE DISPOSAL SITE

- 11.1 Disposal may only take place at the Gwaiing WWTW, or alternative site as identified by Council's representative.
- 11.2 The Gwaiing Landfill site is open weekdays and Saturdays from 07:00 to 18:00. The landfill site is closed on Sundays. Public Holidays it is open from 07:00 to 15:00.

11.3 Service Providers who are found illegally dumping waste or leaving waste on site will result in penalties (to be specified in SLA) being imposed.

12. MAINTENANCE

12.1 The Service Provider will be responsible for replacing any lost or damaged portable non-flushing chemical toilet units and shall indemnify the Council against any such expenses.

12.2 All portable non-flushing chemical toilet units shall be secured to the ground to the satisfaction of the Council's representative, in order to prevent them toppling due to wind or any other cause.

- 60mm diameter x1000mm pole to be used as support for the Portable Chemical Toilets.
- At least 2 support poles to be installed for each portable chemical toilet.
- Pole shall be installed into a 200mm wide x 600mm deep trench and backfilled with cement stabilized dry mix.
- The chemical toilet will be fastened with galvanized 3.15mm fence wire and tighten up unto the fix poles.
- **Labour intensive methods as far as possible.**

12.3 The Portable non-flushing chemical toilet unit will remain the property of the Service Provider's.

12.4 The Council, therefore, takes no responsibility for the replacement and repair of Portable non-flushing chemical toilet unit when lost or damaged. However, the Service Provider shall be responsible for handling the Portable non-flushing chemical toilet units in such a manner so as to minimize damages.

12.5 All plant and equipment shall be maintained in a clean and serviceable condition.

12.6 Any "Down time" of vehicles and equipment will be to the Service Providers account.

- 12.7 Time lost must be either made up by working longer hours as directed by the Council's representative.
- 12.8 Water wastage is not permitted, and leaking hoses/equipment must be repaired immediately.
- 12.9 The Service Provider is responsible for her/his own security, and it is deemed that it has been allowed for in his rates.
- 12.10 The Service Provider is to satisfy herself/himself that all toilet units are properly cleaned prior to leaving the site.

13. SITE LOCATION

The Service Provider will be required to work in designated areas within the boundaries of the George Municipal area.

- 13.1 The rates submitted in the Pricing Schedule shall constitute the base rate for working in the areas within the George municipal area.
- 13.3 The location of the proposed work will be the current informal settlements serviced by chemical toilets, but the number of toilets can either be increased or reduced in future as settlements grow and are upgraded or relocated at the sole discretion of the Municipality.
- 13.4 Should new areas be identified for servicing, these may be added to the contract, or existing ones may be removed, all at the discretion of the Municipality.
- 13.5 The Service Provider must take note of the various local constraints, specifically dense settlements with poor quality access roads and a potentially high-water table in winter.
- 13.6 The location and distribution ratios of Portable non-flushing chemical toilet units per informal settlements are 1:5.

14. DELIVERY AND COLLECTION

- 14.1 The Service Provider will be required to always have a minimum of 5 toilets in their warehouse for emergencies.

- 14.2 Delivery to site is required 24 hours after receipt of an official order.
- 14.3 It is a contractual requirement that the items be delivered as per indicated time frame after request from project manager was received by the contractor.
- 14.4 Deliveries will be made as and when required by the project manager, including Sundays and public holidays where requested.
- 14.5 The service provider shall nominate a contact person with whom the Department will arrange and schedule deliveries.
- 14.6 A delivery note signed by the Municipal representative that inspected the items in delivery shall be submitted by the service provider.
- 14.7 Defective or damaged goods will not be accepted.
- 14.8 Adherence to service provider delivery periods is of utmost importance.
- 14.9 Notices for collections will be issued as and when required by the Municipality's representative.

15. REPORTING AND LEVELS OF SERVICE TO BE RENDERED BY THE SERVICE PROVIDER

- 15.1 The service provider will report to the Manager: New Housing or a representative.
- 15.2 The onus to produce work, which conforms in quality and accuracy of detail to the requirements of the specifications, is on the Service Provider.
- 15.3 The Service Provider shall, at his own expense, institute a quality-control system and provide experienced foremen and supervisors together with all transport and equipment, to ensure adequate supervision and positive control of the works at all times.
- 15.4 The costs of all supervision and process control, thus carried out by the Service Provider, shall be deemed to be included in the rates tendered for the related items of work.

16. INSTRUCTIONS AND COMMUNICATION

- 16.1 The Service Provider must have an office in the George Municipal area, through which all communication with the employer will flow, and where the majority of work in terms of this tender will be carried out.
- 16.2 Where the contractor is not based within the George municipal area, the contractor shall ensure that a **local office is available within one (1) month from commencement of the contract**. Failure to adhere will result in the Municipality following their default process.

- 16.7 The Service Provider shall respond to all complaints regarding work provided under this tender in a courteous and prompt manner within 24 hours.
- 16.8 Should a complaint go unresolved for longer than 2 days, the Council's representative will have the right to demand an explanation or resolution to her/his satisfaction.
- 16.9 The Service Provider shall inform the Council's representative timeously of any problems on site and keep records of the communication.

17 NOTICE TO RESIDENTS REGARDING THE SERVICING OF TOILETS TO BE RENDERED

17.1 The Service Provider will be required to notify residents by attaching an approved servicing schedule on the outside and inside of the toilet door.

17.2 Servicing schedules to remain attached to toilet doors and be able to withstand all weather conditions.

17.3 The aim of the notification will be to facilitate access to the toilet units as well as to ensure that users leave toilet unlocked during servicing days.

18 HUMAN RESOURCES

18.1 Required Personnel

18.1.1 The Service Provider shall provide a Contracts Manager and Operations Manager which must have the necessary experience in this type of work.

18.1.3 The key personnel will be a link between the Contractor and the Council's Representative and must be available to attend monthly meetings or as and when required.

18.1.4 The key personnel must be familiar with the contents of the tender document.

18.1.5 The Service Provider is to provide his supervisory staff with cellular phones or radios for communication purposes.

18.1.6 The Service Provider is to be contactable during all hours, either by telephone, cellular or fax or email.

19. OCCUPATIONAL HEALTH AND SAFETY

19.1 The Chief Executive Officer of the company shall assume responsibility in terms of Section 16(1) of the Occupational Health and Safety Act (as amended). Should the Contractor assign any duty in terms of Section 16(2), a copy of such assignment shall immediately be provided to the representative of the Employer as defined in the Contract.

19.2 All work performed on the Employer's premises shall be performed under the supervision of the construction supervisor who understand the hazards

associated with any work that the Contractor performs on the site in terms of Construction Regulations 2003.

- 19.3 The Contractor shall appoint a Competent Person who shall be trained on any occupational health and safety aspect pertaining to them or to the work that is to be performed.
- 19.4 The Contractor shall ensure that he familiarizes himself with the requirements of the Occupational Health and Safety Act and that he, his employees, and any sub-contractors, comply with them.
- 19.5 Discipline in the interests of occupational health and safety shall be strictly enforced.
- 19.6 Personal protective equipment shall be issued by the Contractor as required and shall be worn at all times where necessary.
- 19.7 Written safe work procedures and appropriate precautionary measures shall be available and enforced, and all employees shall be made conversant with the contents of these practices.
- 19.8 No substandard equipment/machinery/articles or substances shall be used on the site.
- 19.9 All incidents referred to in terms of Section 24 of the Occupational Health and Safety Act shall be reported by the Contractor to the Department of Labour and the Employer.
- 19.10 The Employer hereby obtains an interest in the issue of any formal inquiry conducted in terms of Section 32 of the Occupational Health and Safety Act and into any incident involving a Contractor and/or his employees and/or his sub-contractor/s.
- 19.11 No use shall be made of any of the Employer's machinery/plant/equipment/substance/personal protective equipment or any other article without prior arrangement and written approval.
- 19.12 No alcohol or any other intoxicating substance shall be allowed on the site. Any person suspected of being under the influence of alcohol or any other intoxicating substance shall not be permitted access to or allowed to remain on the site.

- 19.13 Prior to commencement of any work, verified copies of all documents mentioned in the agreement must be presented to the Employer.

20. GENERAL SAFETY REQUIREMENTS

- 20.1 Cleaning methods must be of such nature that no person, property or improvements in the vicinity of the works is endangered.
- 20.2 The Employer accepts no responsibility for any work executed without written permission outside the site of works.
- 20.3 The apparatus and methods used shall cause no damage to infrastructure, property or fixtures and such damage as may be caused will be repaired by the Council at the Service Provider's expense.
- 20.4 Every effort must be made to service all toilets within informal settlements.
- 20.5 The Council's representative must be informed in cases where this is not possible.
- 20.6 The Council's representative may instruct the Service Provider to cease work if he deems the method of work to be unsatisfactory, a danger or inconvenience to the public, or deemed to be uneconomical under the circumstances.

- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be

imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the bid will be manufactured.

- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Supplier" means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
- 1.26 "Tort" means in breach of contract.
- 1.27 "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
- 1.28 "Written" or "in writing" means hand-written in ink or any form of electronic or mechanical writing.

2. Application:

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General:

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 Invitations to bid are usually published in locally distributed news media and on the municipality/municipal entity website.

4. Standards:

- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
5. Use of contract documents and information inspection:
- 5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the provider in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the provider's performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.
6. Patent rights:
- 6.1 The provider shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
- 6.2 When a supplier developed documentation / projects for the municipality or municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality or municipal entity.
7. Performance security:
- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque.
- 7.4 The performance security will be discharged by the purchaser and returned to the provider not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified.
8. Inspections, tests and analyses:

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that goods to be produced or services to be rendered should at any stage be subject to inspections, test and analyses, the bidder or contractor's premises shall be open, at all reasonable hours, for inspection by a representative of the purchaser or an organization acting on behalf of the purchaser.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Goods and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.
- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing:

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents:

- 10.1 Delivery of the goods and arrangements for shipping and clearance obligations shall be made by the supplier in accordance with the terms specified in the contract.

11. Insurance:
- 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified.
12. Transportation:
- 12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified.
13. Incidental services:
- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any:
- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
 - (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the provider for similar services.
14. Spare parts:
- 14.1 As specified, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
 - (b) in the event of termination of production of the spare parts:
 - (i) advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.
15. Warranty:
- 15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this

contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

- 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise.
- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4 Upon receipt of such notice, the supplier shall, within the period specified and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment:

- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated.

17. Prices:

- 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the provider in his bid, with the exception of any price adjustments authorized or in the purchaser's request for bid validity extension, as the case may be.

18. Variation orders:

- 18.1 In cases where the estimated value of the envisaged changes in purchase does not exceed 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the contractor may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

19. Assignment:

- 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts:

- 20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under these contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the Supplier's Performance:

- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the goods are required, or the supplier's services are not readily available.
- 21.4 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.
- 21.5 Upon any delay beyond the delivery period in the case of a goods contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties:

- 22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default:

- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;

- (b) if the supplier fails to perform any other obligation(s) under the contract; or
 - (c) if the supplier, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.
- 23.5 Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
 - (i) the name and address of the supplier and / or person restricted by the purchaser;
 - (ii) the date of commencement of the restriction;
 - (iii) the period of restriction; and
 - (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.
- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.
- 24. Anti-Dumping and Counter-Vailing duties and rights:
 - 24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-

dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the supplier to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the supplier in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

25. Force Majeure:

25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency:

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of disputes:

27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.

27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.

27.4 Notwithstanding any reference to mediation and/or court proceedings herein,
(a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
(b) the purchaser shall pay the supplier any monies due to the supplier for goods delivered and / or services rendered according to the prescripts of the contract.

28. Limitation of liability:

28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;

- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
- (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. Governing language:

- 29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable law:

- 30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

31. Notices:

- 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties:

- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.
- 32.4 No contract shall be concluded with any bidder whose municipal rates and taxes and municipal services charges are in arrears.

33. Transfer of contracts:

- 33.1 The contractor shall not abandon, transfer, cede assign or sublet a contract or part thereof without the written permission of the purchaser.

34. Amendment of contracts:

- 34.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the

contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.

35. Prohibition of restrictive practices:

- 35.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is / are or a contractor(s) was / were involved in collusive bidding.
- 35.2 If a bidder(s) or contractor(s) based on reasonable grounds or evidence obtained by the purchaser has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties are contemplated in section 59 of the Competition Act No 89 of 1998.
- 35.3 If a bidder(s) or contractor(s) has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
