- Modify the RFQ's goods / service(s) and request Respondents to re-bid on any changes;
- Reject any Quotation which does not conform to instructions and specifications which are detailed herein;
- Reject Quotation submitted after the stated submission deadline or at the incorrect venue;

Should a contract be awarded on the strength of information furnished by the Respondent, which after conclusion of the contract, is proved to have been incorrect, PRASA reserves the right to cancel the contract.

PRASA reserves the right to award business to the highest scoring bidder/s unless objective criteria justify the award to another Respondent.

Should the preferred fail to sign or commence with the contract within a reasonable period after being requested to do so, PRASA reserves the right to award the business to the next highest ranked Respondent provided that he/she is still prepared to provide the required goods at the quoted price.

9 LEGAL REVIEW

Proposed contractual terms and conditions submitted by a Respondent will be subjected to review and acceptance or rejection by PRASA's Legal Counsel, prior to consideration for an award of business.

10 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. PRASA is required to ensure that price quotations are invited and accepted from prospective bidders listed on the CSD. 11 PROTECTION OF PERSONAL DATA

In responding to this bid, PRASA acknowledges that it may obtain and have access to personal data of the Respondents. PRASA agrees that it shall only process the information disclosed by Respondents in their response to this bid for the purpose of evaluating and subsequent award of business and in accordance with any applicable law.

Furthermore, PRASA will not otherwise modify, amend or alter any personal data submitted by Respondents or disclose or permit the disclosure of any personal data to any Third Party without the prior written consent from the Respondents. Similarly, PRASA requires Respondents to process any personal information disclosed by PRASA in the bidding process in the same manner.

13 ADMINISTRATIVE RESPONSIVENESS

The test for administrative responsiveness will include completeness of response and whether all returnable and/or required documents, certificates; verify completeness of warranties and other bid requirements and formalities have been complied with. Incomplete Bids will be disqualified.

14 VALIDITY PERIOD

14.1 PRASA requires a validity period of **90 Working Days** from the closing date.

14.2 Respondents are to note that they may be requested to extend the validity period of their response, on the same terms and conditions, if the internal processes are not finalized within the validity period. However, once the delegated authority has approved the process the validity of the successful respondent(s)' bid will be deemed to remain valid until finalization of the award),

SECTION 4

PRICING AND DEKIVERY SCHEDULE

Respondents are required to complete the attached Pricing Schedule.

- 1 Price must be quoted in South African Rand, inclusive of VAT.
- 2 Price offer is firm and clearly indicate the basis thereof.
- 3 Pricing Bill of Quantity is completed in line with schedule if applicable.
- 4 Cost breakdown must be indicated.
- 5 To facilitate like-for like comparison bidders must submit pricing strictly in accordance with this price schedule and not utilise a different format. Deviation from this pricing schedule could result in a bid being declared non-responsive.
- 6 Please note that should you have offered a discounted price(s), PRASA will only consider such price discount(s) in the final evaluation stage on an unconditional basis.
- 7 Respondents are to note that if price offered by the highest scoring bidder is not market related, PRASA may not award the contract to the Respondent. PRASA may:
 - 8 Negotiate a market-related price with the Respondent scoring the highest points or cancel the RFQ;
 - 9 If that Respondent does not agree to a market-related price, negotiate a market-related price with the Respondent scoring the second highest points or cancel the RFQ.
 - 10 If a market-related price is not agreed with the Respondent scoring the third highest points, PRASA must cancel the RFQ.

DELIVERY PERIOD: Suppliers are requested to offer their earliest delivery period possible.

Delivery will be effected within working days from date of order. (To be completed by Service provider)

SECTION 5

PRASA GENERAL CONDITIONS OF PURCHASE

General

PRASA and the Supplier enter into an order/contract on these conditions to supply the items (goods/services/works) as described in the order/contract.

Conditions

These conditions form the basis of the contract between PRASA and the Supplier. Notwithstanding anything to the contrary in any document issued or sent by the Supplier, these conditions apply except as expressly agreed in writing by PRASA.

No servant or agent of PRASA has authority to vary these conditions orally. These general conditions of purchase are subject to such further special conditions as may be prescribed in writing by PRASA in the order/contract.

Price and payment

The price or rates for the items stated in the order/contract may include an amount for price adjustment, which is calculated in accordance with the formula stated in the order/contract.

The Supplier may be paid in one currency other than South African Rand. Only one exchange rate is used to convert from this currency to South African Rand. Payment to the Supplier in this currency other than South African Rand, does not exceed the amounts stated in the order/contract. PRASA pays for the item within 30 days of receipt of the Suppliers correct tax invoice.

Delivery and documents

The Supplier's obligation is to deliver the items on or before the date stated in the order/contract. Late deliveries or late completion of the items may be subject to a penalty if this is imposed in the order/contract. No payment is made if the Supplier does not provide the item as stated in order/contract.

Where items are to be delivered the Supplier:

Clearly marks the outside of each consignment or package with the Supplier's name and full details of the destination in accordance with the order and includes a packing note stating the contents thereof; On dispatch of each consignment, sends to PRASA at the address for delivery of the items, an advice note specifying the means of transport, weight, number of volume as appropriate and the point and date of dispatch; Sends to PRASA a detailed priced invoice as soon as is reasonably practical after dispatch of the items, and states on all communications in respect of the order the order number and code number (if any).

Containers / packing material

Unless otherwise stated in the order/contract, no payment is made for containers or packing materials or return to the Supplier.

Title and risk

Without prejudice to rights of rejection under these conditions, title to and risk in the items passes to PRASA when accepted by PRASA.

Rejection

If the Supplier fails to comply with his obligations under the order/contract, PRASA may reject any part of the items by giving written notice to the Supplier specifying the reason for rejection and whether and within what period replacement of items or re-work are required.

In the case of items delivered, PRASA may return the rejected items to the Supplier at the Supplier's risk and expense. Any money paid to the Supplier in respect of the items not replaced within the time required, together with the costs of returning rejected items to the Supplier and obtaining replacement items from a third party, are paid by the Supplier to PRASA.

In the case of service, the Supplier corrects non-conformances as indicated by PRASA.

Warranty

Without prejudice to any other rights of PRASA under these conditions, the Supplier warrants that the items are in accordance with PRASA's requirements and fit for the purpose for which they are intended, and will remain free from defects for a period of one year (unless another period is stated in the Order) from acceptance of the items by PRASA.

Indemnity

The Supplier indemnifies PRASA against all actions, suits, claims, demands, costs, charges and expenses arising in connection therewith arising from the negligence, infringement of intellectual or legal rights or breach of statutory duty of the Supplier, his subcontractors, agents or servants, or from the Supplier's defective design, materials or workmanship.

The Supplier indemnifies PRASA against claims, proceedings, compensation and costs payable arising out of infringement by the Supplier of the rights of others, except an infringement which arose out of the use by the Supplier of things provided by PRASA.

Assignment and sub-contracting

The successful Respondent awarded the contract may only enter a subcontracting arrangement with PRASA's prior approval. The contract will be concluded between the successful Respondent and PRASA, therefore, the successful Respondent and not the sub-contractor will be held liable for performance in terms of its contractual obligations.

Governing law

The order/contract is governed by the law of the Republic of South Africa and the parties hereby submit to the non-exclusive jurisdiction of the South African courts.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

SECTION 7

1. SCOPE OF WORK

1.1 The scope of the work/service to be provided by the contractor is as follows:

- Perform an analysis of our safes in terms of their physical state, determine their age and develop a maintenance plan for each safe.
- Carry out planned maintenance, corrective maintenance, repair, replacements and/or relocation of Safes which are used in Stations and Area offices by Customer Services in PRASA KZN region As and When required.
- The scope also includes a 24hr, Monday to Sunday emergency standby service as and when by Prasa Customer Service.

1.2. The contract duration will be for a period of 24 months from the time of contract commencement.

1.3. As part of the administration claims shall be submitted timeously and the following documentation must be provided in support of a claim.

- I. Completed job cards indicating location, dates, personnel, times worked and travelling information.
- II. Records of material receipts for material purchased and used in this contract (only for material not priced for in the Pricing Schedule)
- III. Invoices for services outsources/hired under this contract

4. CONTRACTOR REQUIREMENTS

- 4.1.** The Contractor shall comply to the responds times to repairs/maintenance in accordance with the following:
- Emergencies – within 3hrs
 - Urgent – 5hrs
 - Non – Urgent – within 24hrs
- 4.2.** The Contractor to supply all required equipment for the transportation of the relocation of Safes in stations and area offices and prices to be included.
- 4.3.** The Contractor is responsible for supply of the material required to repair the faults as per job cards/work order. All materials used shall be of a high standard (SABS approved).
- 4.4.** The Contractor shall be or have in his employment qualified technicians leading maintenance teams, proof of qualifications for maintenance team leaders shall be provided on request.
- 4.5.** The Contractor shall have the capacity to be able to work on more than one site at any given time.
- 4.6.** Where day to day repairs is to be undertaken, the Contractor shall first submit for approval a quotation of the labor and material cost based on the schedule of prices, before proceeding with the job.
- 4.7.** The supplier shall be within eThekweni Municipality boundary proof of business address or lease agreement is required to be submitted.

5. QUALITY CONTROL

- 5.1.** All material supplied and workmanship to meet the Prescribed Statutory Requirements, including the Occupational Health and Safety Act 1993.

N.B. The contractor material supplier must be a reputable material supplier and only market related material prices will be accepted by PRASA.

- 5.2.** All replacement parts must be SABS approved, 12-month guarantee.
- 5.3.** Works with poor workmanship will not be signed off and PRASA reserves the right to hold payments until satisfied with the quality of the work.
- 5.4.** Safety – the Contractor will always ensure that work is performed in accordance with all the prescribed legal prescripts.

6 PAYMENT

- 6.1** When the safes have been maintained, repaired and/or relocated, invoices quoting the Contract number and the relevant Purchase Order Number must be sent to the Regional Customer Services, PRASA KZN.
- 6.2** Invoices must be accompanied by a job card detailing the maintenance, repairs or relocation of safes and signed by the consignee.
- 6.3** Payment will be as per Schedule of Quantities.
- 6.4** Prices will be fixed for the first year. In the second year, there will be a one-time, market-based price escalation.

7 TO BE SUPPLIED BY PRASA KZN

7.1 Compulsory Briefing to be held at Durban Station.

8. PENALTIES

8.1. Should the Contractor fail to deliver on the agreed date, a penalty of 1% per day will be charged on the total value of the Purchase order (PO) but shall not exceed 10 percent of the total value of the PO.

8.2. PRASA KZN reserves the right to evaluate the product at any given time during the contract period for compliance. The Contractor will be held liable with costs for any deviations in the specifications which may have resulted in damages and downtime to Customer Services. Both parties (PRASA and the Contractor) will arrange a meeting to discuss the outcome of the investigation and costs incurred were necessary.

9. TERMINATION OF THE CONTRACT

PRASA KZN reserves the right to cancel the contract at any time during the stipulated period due to the contractor not performing according to the requirements of the agreement.

10. DELIVERY

10.1. PRASA KZN will require the safes to be repaired at the assigned Stations.

11. DURATION

11.1. The duration of the contract will be for a period of 24 months and will commence once notified by PRASA KZN.

11.2. The contract will have a limiting value of R200 000 (two hundred thousand only) inclusive of VAT.

11.3. The contract will terminate once the period is reached or when maximum value is attained whichever comes first.

12. RETURNABLE DOCUMENTATION.

The bidders to supply the following documentation with their tender.

- A minimum of 2 reference letters for the maintenance of repairs of safes **not the supply and delivery of safes.**
