Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

Dube TradePort Corporation (DTPC) hereby invites proposals for the aforementioned services. The works consist of the Turnkey Services contract (Design and Construction) for a Mixed Use Office Building on Block D to provide a total gross area of 16 218m², including offices, ablution, and sundry facilities as per DTPCs requirements.

It is estimated that tenderers must have a CIDB contractor grading designation of 9GB by the closing date of the bid.

PRE-QUALIFICATION AND OBJECTIVE CRITERIA

The pre-qualification criteria for this RFP is as follows:

- a) In line with the PPPFA regulations 2017, the pre-qualification for this bid is:
 - i. That 30% of the contract value must be subcontracted to black EME/QSE for both professional services and construction service providers. The construction subcontractors must be registered and have an active CIDB grading of **6GB/EB/ME or lower** by the closing date of the bid.
 - ii. The objective criteria in terms of the PPPFA 2001, is that all the above-mentioned subcontractors (both professional services and construction service providers) must be based in Kwa-Zulu Natal.

LOCAL CONTENT AND PRODUCTION

- b) In line with the National Treasury Instruction notes, this bid has a Local Production and Content for designated sectors as follows:
 - i. Steel must be 100%;
 - ii. Plastic pipes must be 100%;
 - iii. Electrical cables must be 65%;
 - iv. Cement must be 100%.

It is a bidding condition that all bidders must meet the pre-qualification and objective criteria as well as the local production and content requirements. Any bidder that does not meet any one of this requirements is not eligible to tender and their bid proposal will not be acceptable.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages as follows – compliance and functionality (including technical evaluation) will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 90/10 preference points system.
