

APPOINTMENT OF A SERVICE PROVIDER TO DESIGN AND DEVELOP THE NATIONAL FRAMEWORK FOR THE BUILT ENVIRONMENT (BE) TECHNICAL CAPACITY OF THE STATE

1. PURPOSE

The National Department of Public Works and Infrastructure (hereinto referred to as the Department) seeks to identify an experienced company to design and develop the National Framework for the Built Environment (BE) Technical Capacity of the State.

2. INTRODUCTION

- 2.1 The Department of Public Works and Infrastructure (DPWI) is a government department that deals with management of the State infrastructure. Similarly to International trends in Public Works services, the DPWI sets the tone for the responsibilities and mission of the Department. These responsibilities include the construction and management of State assets, such as public hospitals, schools, government buildings, bridges, dams, roads and the provision of water, reticulations, and sewerage to communities.
- 2.2 The mandate of the DPWI, as derived from Section 4 of the Constitution of the Republic of South Africa (Act no. 108 of 1996); the Public Finance Management Act (1 of 1999); and the Government Immovable Asset Management Act (19 of 2007) (GIAMA), amongst other relevant legislations, directs the Department to carry out its responsibilities of the provision of State accommodation and related services to National Departments, managing the State property portfolio, and provision of leadership and direction to the construction and built environment industries.
- 2.3 Further to the mandate of the DPWI, Section 195 and Section 197 of the Constitution dictates that we address skills development in a manner that accelerates the advancement of previously disadvantaged people, women and designated groups with particular emphasis on leaderships, as well as technical and management capabilities.
- 2.4 The National Framework for Technical Capacity of the State, should be designed and developed in a manner that will provide a structured long-term plan, aligning to the National Development Plan, vision 2030 and other related, relevant capacity development regulations and policies, and focusing on the vision, mission, mandate and service delivery objectives of the Department and the BE Sector. It should streamline the development of processes to facilitate, lead, coordinate and monitor capacity building activities within the Built Environment focusing on the capacity building of human resources, institutional development, and the policy environment across the State as the three (3) spheres of government namely Local, Provincial and National, including the State Entities, and State Owned Companies.

- 2.5 The long term goal of the framework is to produce competent BE Professionals, and a workforce that is driven by high values and standards, promoting accountability and value for government's return on investment.
- 2.6 The final Framework document must in addition to the critical elements highlighted above, provide an implementation Plan to guide on performance measures (indicators), the risk management plan, and the monitoring and evaluation plan.

3. BACKGROUND

- 3.1 The Department through the Professional Services Branch (PSB), coordinates programmes that contribute to the creation of a pool of critical skills aiming at changing the profile of the workforce by growing a representative workforce for the built and property environment while growing the size and raising the quality of the human capital base needed to improve the quality of life of all South Africans.
- 3.2 The Department coordinates and manages the supply of BE skills to support the state infrastructure delivery. Further to this, it maintains partnerships with relevant stakeholders to strengthen and facilitate the provision of BE skills; and support all government spheres with the institutionalization of capacity building programmes.
- 3.3 Since the dawn of democracy in South Africa, the State has lacked a centrally coordinated function that drives technical capacity building. This has resulted in a disjointed approach to capacity building with no clear outputs and inability to replenish technical competencies lost through the aging workforce and other factors contributing to the current gap in the needed State BE technical capacity.
- 3.4 The branch currently leads the Public Works Sector Capacity Building Forum and is coordinating the capacity building interventions through the implementation of the Skills Pipeline Strategy across all Public Works Provincial Departments. The impact report of 2020/21 of this programme birthed the establishment of the Public Works Sector Student Chapter that is at conceptual stage, targeted to be fully operational by 2021/22.
- 3.5 Finally, in the attempt to offer holistic capacity solutions to the State BE Sector, interventions to equip internal capacity with ability to transfer skills through various options, i.e. mentorship, facilitation of workshops, presentations at seminars, etc. have been put in place, with the aim of working towards the establishment of a National Public Works Academy in the future.
- 3.6 To do the above, it is imperative for the State to know of its current capacity status quo, to understand the ideal capacity, and capacity building initiatives to bridge the gap between current and ideal.

4. SCOPE OF THE ASSIGNMENT

The work entails to -

4.1 Conduct an analysis on the status core of the technical (BE, Infrastructure, Real Estate and Asset Management) capacity of the state institutions.

- 4.2 Conduct consultations to develop the Framework for state capacity on infrastructure delivery, maintenance and management.
- 4.3 Ascertain the ideal state capacity for infrastructure delivery, maintenance and management.
- 4.4 Develop a well-researched Framework design and development guide / plan outlining the content topics, lay-out, planned research integration and references, taking into consideration the relevant legislations and policies.
- 4.5 Design a well-researched National Framework for the Built Environment (BE) Technical Capacity of the State which is result focused, with clear objectives, processes, implementation approaches, monitoring and evaluation, resource and record management addressing the infrastructure delivery, maintenance and management goals.
- 4.6 The National Framework should further offer a direction for applicable capacity building interventions, capable of improving the capacity for the infrastructure delivery, maintenance and management across the State.
- 4.7 Consult the framework design with the Department and the nominated / sampled BE Sector representation to ensure a comprehensive coverage of all capacity building elements.
- 4.8 The framework must hold a set of ideas or practices that comprises a broad approach action plan to assist both capacity building programmes' implementers and beneficiaries within all spheres of government.
- 4.9 Incorporate consultation inputs and produce a detailed, well informed, framework for the Built Environment (BE) Technical Capacity of the State.
- 4.10 The document must be produced as a functional, BE capacity global framework with the users, beneficiaries and relevant government targeted outcomes in mind, guiding the development of strategic planning and policy documents.
- 4.11 The content layout of the National Framework must include amongst other beneficial sections - "targeted outcomes, logic model, interventions, performance indicators, stakeholders with roles and responsibilities, as well as sample tools to monitoring and evaluation of the National Framework.
- 4.12 Consult draft 1 of the National Framework with the PSB branch, DPWI executives, and stakeholders.
- 4.13 Upon inputs / endorsement by the PSB branch and DPWI executives, present the final draft of the National Framework and close-out report prior to closing date the project.

5. DELIVERABLES

The successful bidder will be required to:

- 5.1 Submit an action plan with indication of resources, role players, and timelines.
- 5.2 Submit a list of project team members and a brief of their resume;

- 5.3 Submit a record of experience of the company in doing similar work to this project.
- 5.4 Execute the project activities in line with the implementation plan to be agreed upon and approved by DPWI PSB.
- 5.5 Produce a National Framework design and present to a consultation meeting with the DPWI identified stakeholders.
- 5.6 Consult the draft National Framework as per intervals outlined in the approved implementation plan.
- 5.7 Produce a final National Framework document and required annexures for approval.
- 5.8 Submit the National Framework document with all accompanying tools / resources, in soft copy.
- 5.9 The successful bidder will be required to work in close collaboration with the Professional Services Branch of the Department of Public Works and Infrastructure.

6. CONDITIONS OF CONTRACT

The conditions of contract applicable to this appointment will be the General Conditions of Contract for Goods and Services.
