SPECIFICATION

1. INTRODUCTION

Tenders are herewith invited for the supply, delivery & erect of a precast (concrete) fence at the Durnacol new cemetery Site in Dannhauser.

2. BACKGROUND

There is existing fence which is not conducive for cemetery site. This is a new site and comprise of approximately 10 000 burial plots. Dannhauser Municipality is inviting potential contractors to tender for this work.

3. SCOPE

The scope of work will entail the following:

- Remove existing fence and dispose to a site identified by the Municipality
- Supply and installation of concrete precast fencing
- The total perimeter of the fence is 1300 meters
- The fence shall be 1.2 meters high

PLEASE NOTE: All technical specifications listed below are the minimum product requirements.

4. GENERAL/TECHNICAL REQUIREMENTS (RELEVANT TO ALL FENCING TYPES)

4.1. All concrete for precast elements must achieve a minimum compressive strength of 40Mpa and meet SABS specific standards.

4.2. Removal of Existing Fences

Contractor will be responsible to remove and dispose of existing fence. If old fence is still in a condition to be used elsewhere it needs to be transported to the municipal stores for safekeeping.

4.3. Site works

The contractor must remove and dispose of any spoil materials and rocks and leave the works neat and tidy on completion. Contractors need to provide a rate for rock excavation per cubic meter in the pricing schedule.

 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
