The purpose of this Request for Quotation (RFQ) is to invite qualified and accredited training providers to submit proposals for the delivery of Occupational Health and Safety (OHS) Committee Member training. The training is intended to ensure that committee members are adequately equipped with the knowledge and skills required to fulfil their roles in compliance with the Occupational Health and Safety Act and applicable regulations

OBJECTIVE

The objectives of this training are to:

- Equip OHS Committee members with a clear understanding of their roles and responsibilities.
- Ensure compliance with statutory requirements and best practices in occupational health and safety.
- Enhance the ability of committee members to identify, assess, and manage workplace hazards and risks.
- Strengthen incident investigation, reporting, and corrective action processes.
- Promote a proactive safety culture within the organisation.

SCOPE OF SERVICES

The scope of the services is as follows:

- Design and deliver OHS Committee Member training in line with legislative requirements.
- Provide a detailed training programme, including course content and learning outcomes.
- Facilitate training sessions (on-site- JTC Offices).
- Provide all necessary training materials and resources.
- Conduct assessments (where applicable) and issue certificates of competence.
- Ensure that facilitators are suitably qualified, experienced, and (where applicable) accredited.
- Submit a post-training report, including attendance registers and evaluation feedback

EXPECTED OUTCOMES AND DELIVERABLES

The Expected outcomes and deliverables must be read in conjunction to the scope of services.

Upon completion of the training:

- Participants will demonstrate an understanding of the Occupational Health and Safety Act and its application.
- Committee members will be able to effectively carry out their duties, including inspections, meetings, and compliance monitoring.
- Improved hazard identification, risk assessment, and incident management practices will be evident.

- b) The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form;
