# 2.1 Background and/or Purpose of this Bid

The intention of this tender is to solicit services of a professional engineering consultant to monitor the investigations, designs and the implementation of the GRJ, KIM & UPN Generator sets replacement projects up to closeout stage.

# 2.2 Pricing Schedule

Bidders must only price in accordance with the pricing schedule in the NEC3 PSC, this will enable ACSA to compare priced offers. Failure to submit a priced offer using the prescribed schedule will make the bidder liable for disqualification.

# **SECTION 3: EVALUATION CRITERIA**

#### 3.1 Evaluation Criteria

3.1.1ACSA will use a pre-determined evaluation criteria when considering received bids. The evaluation criteria will consider *mandatory administrative*, *functionality*, *Price and Preference*. During the evaluation of received bids ACSA will make an assessment whether all the bids comply with set minimum requirements and whether all returnable documents/information have been submitted. Bidders which fail to meet minimum requirements, thresholds or have not submitted required mandatory documents will be disqualified from the bid process.

- 3.1.1 The requirements of any given stage must be complied with prior to progression to the next stage. ACSA reserves the right to give bidders reasonable time to submit information that will be required in Stage 1 below.
- 3.2 A staged approach will be used to evaluate bids and the approach will be as follows:

### 3.4 Stage 2 Functionality

Functionality is the terminology used to define the technical ability of the Tenderer, based on experience, to deliver the required product in accordance with the specialised quality, reliability, and functionality.

Points allocated for Functionality shall be evaluated in accordance with the criteria as listed below. Total points allocated shall be 100. Tenderer must score a threshold of 70 points out of 100 for the bidder to be successful.

#### NOTE:

With reference to project experience requirements stated in the technical evaluation sheets below, the following must be noted which will be used to evaluate the project experience:

- The Built Environment refers to all structures that are planned and/or erected above or underground, as well as the land utilized for the purpose and supporting infrastructure.
- Maintenance projects/ contracts will not be accepted for evaluation and will score zero. "Maintenance project" refer to servicing of diesel generators and other electrical infrastructure.
- Projects comprising of integrating other sources of electricity with already installed diesel generators will not be evaluated/ will score zero points.
- Bidders are required to list their relevant completed project experience. Relevant completed projects
  are defined as Built Environment projects which comprised of design, installation and commissioning
  of standby diesel generators with a minimum capacity of 100kVA. Projects provided must have been
  completed within the last 15 years.
- Bidders are to ensure that projects completed provided indicates the size of the diesel generator(s) installed and commissioned, failure to specify the capacity of installed generator will result to the project provided/ submitted scoring zero points.
- Partially completed projects (e.g. ECSA Stage 1 4) will not be considered as completed projects and will score zero.
- "Completed project" refers to a project which has achieved Practical Completion certification.
- It is the Bidders responsibility to ensure that the above description regarding the project relevance is clearly articulated in Annexure C for the Company Experience and Annexure E for the Lead Electrical Engineer's Experience.

#### Making a Declaration

Any legal person or persons having a relationship with persons employed by ACSA, including a blood relationship, may submit a bid in terms of this tender document. In view of possible allegations of unfairness, should the resulting bid, or part thereof, be awarded to persons connected with or related to ACSA employees, it is required that the bidder or his/her authorised representative declare his/her position in relation to ACSA employees or any member of the evaluation or adjudication committee which will consider bids.

ACSA requires all bidders to declare that they have not acted in any manner inconsistent with the law, policy, or fairness. Furthermore, ACSA requires bidders to declare if they have Politically Exposed Persons (PEP) also known as Domestic Prominent Influential Persons (DPIP) in their organisation. See below definition of PEP/DPIP.

Politically Exposed Persons or DPIP are individuals who are or have been entrusted with prominent public functions in the country or a foreign country, for example Heads of State or of government, senior politicians, senior government, judicial or military officials, senior executives of state-owned corporations, important political party officials. Business relationships with family members or close associates of PEPs involve reputational risks similar to those with PEPs themselves. PEP status in the following areas shall be declared:

- Current or former senior official in the executive, legislative, administrative, military, or judicial branch of government or foreign government (elected or not)'
- A senior official of a major political party or major foreign political party;

- or otherwise restrict either Party from pursuing any business opportunities provided it complies at all times with the non-disclosure obligations set forth herein
- 9.2 The disclosing party retains the sole and exclusive ownership of intellectual property rights to its confidential information and no license or any other interest in such confidential information is granted in terms hereof or by reason of its disclosure.
- 9.3 The termination of the discussions referred to in 2.1 above shall not release the parties from the obligations set out in this agreement.

# 10. ENFORCEMENT, GOVERNING LAWS AND JURISDICTION

- 10.1 This agreement shall be governed by and interpreted according to the laws of the Republic of South Africa, without reference to the choice of laws' provisions of the Republic of South Africa. In the event of a conflict between or inconsistency in the laws applicable in the various provinces of the Republic of South Africa, the law as applied and interpreted in the Gauteng Province shall prevail.
- The parties irrevocably submit to the exclusive jurisdiction of the High Court of South Africa, Witwatersrand Local Division, in respect of any action or proceeding arising from this agreement.
- The parties agree that, in the event of a breach of this agreement, monetary damages would not be an adequate remedy. In the event of a breach or threatened breach of any provisions of this agreement by the receiving party, the disclosing party (and/or its relevant affiliate) shall be entitled to injunctive relief in any court of competent jurisdiction and the receiving party shall reimburse the disclosing party for any costs, claims, demands or liabilities arising directly or indirectly out of a breach. Nothing contained in this agreement shall be construed as prohibiting a party or its affiliate from pursuing any other remedies available to it for a breach or threatened breach.
- The failure by the disclosing party to enforce or to require the performance at any time of any of the provisions of this agreement shall not be construed to be a waiver of such provision, and shall not affect either the validity of this agreement or any part hereof or the right of the disclosing party to enforce the provisions of this agreement.

- 12.4 The parties acknowledge that this agreement and the undertakings given by it in terms hereof are fair and reasonable in regard to their nature, extent and period and go no further than is reasonably necessary to protect the interests of the parties.
- 12.5 The parties hereby confirm that they have entered into this agreement with full and clear understanding of the nature, significance and effect thereof and freely and voluntarily and without duress.
- 12.6 Neither party shall have the right to assign or otherwise transfer any of its rights or obligations under this agreement.
- 12.7 This agreement may be executed in several counterparts that together shall constitute one and the same instrument.
- 12.8 In this agreement, clause headings are for convenience and shall not be used in its interpretation.
- 12.9 Each clause of this agreement is severable, the one from the other and if any one or more clauses are found to be invalid or unenforceable, that clause shall not affect the balance of the clauses which shall remain in full force and effect.
