INTRODUCTION TO SANPARKS

The contract is for the appointment of an Occupational Medical Services for Kruger National Park

CONTRACT PERIOD

Five years

SPECIFICATIONS/SCOPE OF WORK

The scope of work entails the appointment of an external service provider to carry out occupational medical services on a regular basis to its employees.

- The KNP Medical Center shall be part of the disaster management
- The KNP medical center shall ensure that occupational medical personnel are available within the Park

Occupational Medical service provider shall consist of the below:

- X 1 (one) Occupational Medical Practitioner;
- X 2 (two) Occupational Nurses.

Provision of **Occupational Medical Services and Occupational Nurses** services on a daily basis which includes but not limited to the following:

- Risk based medical surveillance/fitness for duty medical testing:
- Pre-employment
- Periodically/annual
- Return to duty
- Exit
- Management of occupational diseases and injuries.
- Assisting in disaster management
- Managing medical bag or kit at the camps for the entire KNP
- Conducting health risk assessments
- Referrals to specialist
- Medical report interpretations for chronic diseases of our employees.
- Practice management and administration
- Liaising with other health care professionals and coordinating referrals (Skukuza Medical Center, EMS, air services, orthopedic).
- 24 hour Standby, 7 days a week, in case of emergencies and eventualities to SANParks employees (Rangers, Security Services, and others emergencies as they may arise).
- Providing hygiene training to employees.
- Providing trauma care and stabilising employees on scene during emergencies.

RESPONSIBILITIES OF SANPARKS

- To provide bidding company with information that will assist in submitting the tender.
- To provide bidders access to the different facilities, should they require to do site inspection
- On a monthly basis, the service provider will be monitored through performance and recommend a mitigating plan.
- Enter into a service level agreement with the bidder

- Will provide equipment (lung function, eye test and ear booth) to assist the bidder to discharge his/her responsibilities,

1.15.	"Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.

1.19.	"Order" means an official written order issued for the supply of goods or works or the rendering of a service.
1.20.	"Project site" , where applicable, means the place indicated in bidding documents.
1.21.	"Purchaser" means the organization purchasing the goods.
1.22.	"Republic" means the Republic of South Africa.
1.23.	"SCC" means the Special Conditions of Contract.
1.24.	"Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
1.25.	"Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

GCC2	2. Application
	2.1. These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents. 2.2. 	17.1. Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in

GCC18	18. Contract amendment
	18.1. No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
GCC19	19. Assignment
	19.1. The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
GCC20	20. Subcontract
	20.1. The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract

(b) Use, exploit or in any other manner whatsoever apply the confidential information for any other purpose whatsoever, other than for the execution of the contract and the delivery of the deliverables or (c) Copy, reproduce, or otherwise publish confidentiality information except as strictly required for the execution of the contract. The recipient shall ensure that any employees, agents, directors, contractors, service providers, and associates which may gain access to the confidential information are bound by agreement with the recipient both during the term of their associations with the recipient and after termination of their respective associations with the recipient, not to (a) Disclose the confidential information to any third party, or (b) Use the confidential information otherwise than as may be strictly necessary for the execution of the contract, The recipient shall take all such steps as may be reasonably necessary to prevent the confidential information from falling into the hands of any unauthorised third party.

	The undertakings set out in this clause shall not apply to confidential information, which the which the recipient is able to prove: (a) Was independently developed by the recipient prior to its involvement with SANParks or in the possession of the recipient prior to its involvement with SANParks; (b) Is now or hereafter comes into the public domain other than by breach of this contract by the recipient; (c) Was lawfully received by the recipient from a third party acting in good faith having a right of further disclosure and who do not derive the same directly or indirectly from SANParks, or (d) Is required by law to be disclosed by the recipient, but only to the extent of such order and the recipient shall inform SANParks of such requirement prior to any disclosure. The recipient shall within one (1) month of receipt of a written request from SANParks to do so, return to SANParks all material embodiments, whether in documentary or electronic form, of the confidential information including but not limited to: (a) All written disclosures received from SANParks; (b) All written transcripts of confidential information disclosed verbally by the SANParks; and (c) All material embodiments of the contract intellectual property. The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein. Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract.
