The scope of work entails the appointment of Panel of service providers for the supply, delivery and offloading of thatch grass and material in the Kruger National Park for the period of three (3) years.

Service provider (s) are required to conform in the specification below:

- **Thatching grass (per bundle) 15000 per load in a truck (Thatch grass loading and offloading)**
  - Grass species: *Hyparrhenia Hirta*, *Hyparrhenia filipendula* (*Phillependula*) and *Hyperthelia Dissoluta*
  - Cut length of not less than 0,8 m
  - Minimum diameter at the butt end of 1.2mm
  - Maximum diameter at the butt end of 2,5 mm
  - Mass of the bundle range between 0.8 to 0.9 kg
  - Diameter of each bundle should range on average between 24 to 26cm circumferences at the base of bundle.
  - Be acceptably straight (cut above the first node)
